

#### NOTARIES MUST BE REAPPOINTED

Secretary of State Martin Dies, Jr. announced that all qualified Notaries Public desiring re-appointment for the new term which begins June 1, 1969 and ends June 1, 1971, must pay the required fee and file a new oath and bond with the County Clerk between May 1, 1969 and May 15, 1969 inclusive.

Mr. Dies emphasized that Notaries Public should NOT send requests for re-appointment or for commissions directly to the Secretary of State inasmuch as the law specifically requires that the County Clerk approve Notary Bonds and forward copies of the Application to the Secretary of State.

Dies further stated that any person not now a notary public who desires appointment for the new term, should apply to his county clerk before May 16, 1969. The applicant must be at least 21 years of age, a citizen of the United States of America and Texas, and a resident of the county for which appointed. The required Application Forms may be obtained from the county clerk.
