Sterling voters, slightly over of them, took time out to rote in the amendment election re Tuesday. Voters here approved of three of the nine amendments and rejected six.

Local voters were against the legislators pay raise and annual ressions of the legislature by a vote of 89 to 23.

Voters approved the homead protection for single adnits 72 to 40. And for the homead exemption for single adnits that followed, they approved 77 :0 40.

Sterling voted 74 to 35 agnst the rules to create conservation districts.

Strangely enough, Sterling voters then on the next amendment voted for allowing coastcounties to vote sea. wall bonds 58 to 51.

Local voters went against the proposal to give district courts probate jurisdiction rather than county courts, 81 to 27.


Vote for the veterans land fund increase was turned down to 32.

Social Security to **Handle All Payments**

State and Federal agencies are working together on the supplemental security income program that starts making payments in January to people with little or no income who are 65 or over, or blind or disabled. The program is a Federal-State partnership with each partner doing what it can do best. according to J.M. Talbot, social security manager.

Mr. Talbot said the Federal program will coperate with State and local public assistance programs to establish the Nation's first uniform income floor for people in need who are 65 or over. or blind, or disabled. Social security and the Department of Public Welfare are working together so the new payment system will get off to a new start in January, he said.

People getting welfare assistance payments in December because they're 65 or over, or blind, or disabled generally will continue to get payments in January, Mr. Talbot said. They don't have to apply. Their combined State and Federal assistance payments in January will be at least as much as their welfare assistance payments were in December, Mr. Talbot said. They will also be eligible for Medicaid.

Medicaid, vocational rehabilitation for disabled people and other social services, such as child care, family counselin, etc.. will be administered by the State Department of Public Welfare. The Social Security Administration will determine eligibility for supplemental security income, make the Federal payments, keep records, and work to prevent fraud, according to the social security manager.

The amount of the supplemen-

tal security income checks people will get will depend on other income they might have. People with no other income at all will have a basic cash income of at least \$130 a month for one person and \$195 for a couple, Mr. Talbot said. People with other income may get reduced supplemental income checks.

Although the supplemental security income program will be administered by the Social Security Administration, payments will be financed by Federal general tax revenues-not by social security contributions from workers and employers, Mr. Talbot said.

Social security offices are taking applications from people who are 65 or over, or blind, or disabled and aren't getting public assisatnce but who think they might be eligible for suppayments. plemental income People getting State or local assistance don't have to do anything about supplemental security income, Mr. Talbot said. They'll get additional information about the program from social security and the Department of Public Welfare. Until the supplemental security income program starts in January, Mr. Talbot said, the Department of Public Welfare will continue to make payments in the usual way.



Social Security News

The San Angelo Social Security Office is now taking applications for supplemental security income payments, a Federal program scheduled to start in 1974 that will establish an income floor for people in financial need who are 65 or over, or blind, or disabled, according to J.M. Talbot, social security manager.

But, people already getting State old age assistance or State aid because they are blind or disabled don't have to apply, he said. They'll be geting more information later this year about how the program will help them.

"The first monthly payments under the Federal program will be made in January, 1974," Mr. Talbot said. "Until then, State and local public assistance offices will continue to make payments in the usual way."

People not getting public assistance now who think they may be eligible for the new Federal payments should call or write social security to find out if they should apply, according to J.M. Talbot.

"Federal supplemental security income payments will be made by the Social Security Administration," Mr. Talbot said. "But the program will be financed by Federal general revenues-not by social security contributions from workers and employers. It's not the same as social security."

The aim of the new program is to provide supplemental payments in cases of need so that people 65 or over, or blind, or disabled will have a basic cash income of at least \$130 a month for one person and \$195 a month for a couple.

"This doesn't mean that every eligible person or couple will be getting that much from the Federal Government every month," Mr. Talbot said. "The amount of the Federal payment any person gets will depend on how much other income he has."



ments will depend not only on the amount of income people have but on the value of their assets," Mr. Talbot said.

"If you're single-or married but not living with your husband or wife-you can own things worth up to \$1500 and still get Federal payments," he said. "A couple can own things worth up to \$2250 and get payments. Not everything you own has to be counted toward your total assets, however."


"A home of reasonable value will not be counted as an asset," Mr. Talbot said. Personal effects and household goods won't count in most cases. Insurance policies or a car may not affect eligibility either, but it will depend on their value.

Certain income will be disreded in deciding on an application for supplemental security income. The first \$20 a month of income generally won't affect the Federal payment at all, Mr. Talbot said. "In addition, people who are working part time should know that the first \$65 a month of earnings won't be included in counting their income and only half of the rest of their additional earnings will be counted, he said.

Apart from earnings, other income above the first \$20 a month generally will reduce the Federal payment. This includes social security checks, veterans payments, workmen's compensation, pensions, annuities. and gifts, Mr. Talbot said. And. if you live in someone else's household, your basic Federal payment will be reduced by one-third before other income that may affect your payment is deducted.


