## THE LANGUAGE OF FOREIGN MARKETS

Called "diner" in Spanish, "argent" in French, and "gelt" in German, money is luring increasing numbers of American executives to visit distant lands in search of business.

Progressive companies are realizing that the demand for the bilingual executive is growing. They have, therefore, begun adopting language training programs for their personnel.

Previously, training of employees was done in classroom groups. But most companies have found that the busy businessman couldn't be tied down to a 10:30 class twice a week—and preferred an individualized approach to learning.

Employees of Control Data Corporation had an even more troublesome "time" problem. Twenty-five employees of this computer company were being sent to Germany to set up a system for Volkswagen. They wanted to learn German but couldn't be pinned down to a schedule, since they were needed whenever computer time was available.


The Sullivan Language Schools, a nationwide network of centers with headquarters in Palo Alto, Calif., solved their problem by setting up an individualized "school" on their premises. The unique Sullivan method was developed under a Carnegie Foundation Grant by the noted linguist Dr. M. W.



The Sullivan Language Schools have also helped Sears, Roebuck and Co. fashion buyers to learn French and the Latin American Section of A.B. Dick Co. to learn Spanish. The ambitious Japanese of Mitsui Corp. who already speak English are moving on to French, German and Spanish.

Even if their employees are not assigned to overseas duty, some large firms are offering language lessons as a fringe benefit. Companies with plants in Spanish-American districts sponsor courses in Spanish so that their people can better relate to the community.

All in all, the executive who says, "I don't need a second language—there's always someone who speaks English" may become obsolete.

Notice Affording Opportunity for Public Hearing Corridor and Design (Combined Hearing)

The State Department of Highways and Public Transportation is planning the construction of R. M. Highway 3093 from R. M. 2401, 7.5 miles west of R. M. 33, in Glasscock County, southeast to R. M. 1357, 3.0 miles west of R. M. 33 in Reagan County.

The proposed construction will follow the present county road with the exception that 5 degree curves will replace the 90 degree turns. The roadway width will be 2-10 foot lanes with 1 foot unaved shoulders. All cross drainage will be by dip section.

The present 60 foot county road right-of-way will be increased to a width of 100 feet.

Maps and other drawings showing the proposed location and geometric design, environmental studies, and any other information about the proposed project are on file and available for inspection and copying at the Resident Engineer's Office at 2802 Armstrong Street, San Angelo, Texas.

Also, the drawing showing the proposed geometric design have been placed on file with Reagan and Glasscock Counties.

There will be no relocation of dwellings or business establishments; however, information about the State's Relocation Assistance Program, the benefits and services, as well as information about the tentative schedules for acquisition of right-of-way and construction can be obtained at the Resident Engineer's Office.

Any interested citizen may request that a public hearing be held covering the social, economic and environmental effects of the proposed location and design for this highway project by delivering a written request to the Resident Engineer's Office on or before August 16, 1976.

In the event such a request is received, a public hearing will be scheduled and adequate notice will be publicized about the date and location of the hearing.
