John A. S. Walker, of Ashtabula, has accepted the democratic nomination for the judgeship of the 16th district.

The democrats of the 13th senatorial district have nominated Mr. Anson Halsey for state senator to succeed Capt. Gray.

Hon. R. A. Frarrior, of Aransas county, comes up as a candidate for the legislature in that district. The Victoria Advertiser speaks very highly of him.

The socialist-labor party were saved the trouble of nominating a presidential ticket by Weaver writing a letter to the secretary of that party endorsing their ideas.

The census of Arkansas gives a population of 41,550, including 1,000 Chinese and 4,645 Indians, but excluding reservation and Pueblo Indians, not taken in the census.

The Ferrissians are "up to snuff" and the use of dynamite. The destruction of a noble ship and one hundred and fifty human lives at one fell blow is a "glorious thing" in war.

The Fort Worth Democrat advances for thousands of dollars to be loaned for the crops of Tarrant county. There is no excuse for idleness in Texas, at this time especially.

The San Marcos are already excited over the railroad "paw" question, there being several candidates for positions when the road reaches that place.

Prospectors for a good farm at Austin in October are reported very good. The racing especially promises to be exciting and interesting. The entries for speed contests already being monthly here. The crowd of the state we hope this fair will be a grand success in every particular.

The Relief committee of Ireland are closing up their affairs. The crops, which are large and abundant, are ready for the harvest, and there is no need for assistance. The money on hand is sufficient to relieve such isolated cases as may require further assistance.

The Spanish have overthrown another American vessel off the coast, and what makes things worse is that the ship's name is "The Washington." But then, we have had a long time as usual to indignities the past few years that a tenth more or less makes no difference.

To those who know the facts and read the correspondence from Texas and other southern states sent to the St. Louis Globe-Democrat, it would be very discouraging to be convinced that Bob Lagassell is right when he says there is no hell. If there is not, those correspondents will never receive the punishment for their crimes that they deserve.

The Express is now the official organ of the city. For two years this paper has been doing a large amount of "cheerily work" for the city, the officials asking this paper to publish notices for the benefit of the people gratuitously, and for which the "official organ" received the compensation it asked, but notwithstanding this never failed to say that the bid of Tex Express was far below commercial rates, these advisers voted against granting this paper the contract.

The comptroller of the currency has completed a table showing the losses charged off by national banks for the six months ending March 31, 1888. The total losses by all these banks in this period amounted to \$7,562,000. The losses for the corresponding period in 1879 were \$10,337,338. Or these losses during the last six months \$1,206,521 was an amount of depreciation in premium upon United States bonds held by banks, thirty banks were also lost to nature.

The St. Louis Republic says the disaster to the British arms in Afghanistan is part of the heritage bequeathed to the Gladstone ministry by its predecessor. The Gladstone government did not approve the Afghan enterprise and was making preparations to withdraw the army or a part of it and leave the Afghans to themselves, reserving only cash for the British occupation. But the overthrow of Gen. Durrani's army will interfere with this wise policy. The British people feel the disaster keenly, and the public feeling is in favor of an exemplary retribution of it that will subdue the Afghans and restore the prestige of British authority in the East.

The Express, as well as nearly every other paper in the country, has published something about the latest Paris convention based on the infatuation of the Empress of Austria for a circus rider named Elia. The Boston Star and the London Reporter, which is more prone to act in contact over a stack of raw hides or a mass of brogans than over a social sanction, referring to the fact that the empress has invited Elia to accompany her to Ireland next winter as her annual for hunting, says one of the social maxims which is without question is that European society is much better than our inferior air, but what would we say if we saw Mrs. Hayes, for instance, skydiving from the country with even the most famous female circus rider?

THE WATER QUESTION.

A rivalry contest is going on between what hill-powers would call the "gutter-snipe" press of the city—that is, small circulator distributed gratuitously by their publishers—in connection with the water supply question. These papers, the *Surprise* and *Last Ditch*, are issued by rival job offices, the first named defending the water company and the last the ditch party. The latter goes out of its way to attack the former, and against the city, but that question was long ago settled in favor of the water works of the city. When we read the *Surprise*, its assertions are sustained by an array of "facts and figures," we are impressed with a belief that the ditch system is an expensive affair, which threatens in time to make a water supply for the city to the extent that it will become a marsh, while to read the *Last Ditch*, whose assertions are also supported by "facts and figures," one cannot fail to see that the water works company, like a huge amoeba, is twining itself around the city with but one result: the drying up of all the ditches and the crushing of the people under a burdensome taxation that will soon ruin them entirely.

We believe there is a greater amount of feeling exhibited among the people in the discussion of the water supply question than there is any reason for. It is simply a question of law and equity that can be settled in the proper way. The ditch party appear to believe they have the first claim to the water in the river, and those who receive their supply from the water mains believe they are entitled also to take water from the river by artificial means. There is no question as to who is now being benefited, and it appears to us that the most satisfactory way to arrive at a solution of the difficulty would be to either crowd the case over to a final determination or drop it at once, and then go into the courts and test the question of water rights. It can never be settled by either side calling the other hard names. The cost or profit of either the waterworks or the ditches has nothing to do with the real question. There is the contract with the water company, and there are the vested rights of the ditches. If the contract is good it will be enforced, and the rights of the ditches, defined by the courts, will be maintained. No amount of wrangling will accomplish any good.

One erroneous impression has gone abroad that should be corrected, and that is that the hydrant rates will be gradually increased by the operations of the waterworks contract alone. The rental cannot be increased above the present amount without action of the council ordering additional hydrants. All are satisfied that the rate agreed upon in the contract is too high, and the council would hardly dare contract for more hydrants at the matter now stands. The water company desire to extend its mains so as to give a greater number of people the benefit of the water for domestic use and fire protection; but cannot afford to do so without receiving some revenue from hydrant rents on the extension. Therefore the work is blocked. If the pending question were settled, we believe the contract, it led to be good, could be modified in such a manner that the city could afford to contract for more hydrants, the water company could afford to extend its mains, and a much greater proportion of people receive the benefit of water for domestic use and fire protection.

THIS WAS A NUMBER JURY.
At Moberly, Missouri, July 29th, a man named Corlew was on trial for attempting to ravish the wife of a man named Crump. While passing into the court room, Crump followed the officers aside and fired at Corlew. The latter ran, followed by Crump, who finally, after chasing his victim through several stores, at last brought him down, filling him with pistol balls. Though the crowd followed along and saw the whole affair, encouraging Crump and ordering out of the way a boy who said an unwarmed man, Isaac Coffey, at that, should not be shot down in that way, the jury of inquest rendered the following verdict: "We, the jury, having viewed the body of Corlew, deceased, and that he came to his death by gun or pistol shot fired by unknown hands to the jury. Few possessing a knowledge of the circumstances would blame Crump for taking vengeance upon Corlew, but there might have been a better way to protect the dayer than through the jury of a half a dozen men acting as a coroner's jury."

The Macedonian cry, says the New Orleans Democrat, "goes up from the south to the national republican congress. It is asserted that with a few speakers and such money some congressmen may be gained and one or two states carried. There is no question, however, to extend the aid asked for. The committee does not accept the sanguine view taken by southern republicans, and gives all applicants to understand that while speakers may be sent to help them out in their canvases, precious little money will be placed at their disposal. The latest volunteer after substantial encouragement in the south Senator Bruce, who has been to Washington to urge upon the president the necessity of something more tangible than campaign documents, and to inform him that unless it is furnished the southern republicans would quit the field. This threat had no effect, as it is well understood by the republican leaders that it will make any difference in the general result whether they withdraw from or remain in the field.

It may as well be understood that if the southern republicans want to haul up subsidies with their hands they must pay for the meals themselves."

A CORRESPONDENT OF THE Austin *Telegraph*, writing from this city, makes the following statement: "No doubt the officers of the San Antonio street railway company are gentlemen of veracity, but if they wish to retain their reputation, they should tear out the time honored legend that 'change to the amount of two dollars will be furnished by the driver,' for your correspondent has been unable to find a driver who could furnish change to the amount of twenty-five cents. The cards should be taken out, or the company should go to the 'White House' and get some change if it cannot be procured elsewhere. As it is, it is works considerable hardship upon strangers visiting San Antonio who take a ride on the cars, to carry from 20 to 30 cents in San Antonio street railway tickets or drug store advertisements, as they are not current in the city, and the company will not redeem them any more."

Challenging the New Census.
St. Louis Republic.
A dispatch from Washington says "the surprising census returns from the southern states, showing large gains, are giving rise to strong suspicions of fraud. In nearly every southern city and village an increase of population has been reported in ten years, while it is generally known that with the exception of some towns in Virginia, Florida, Georgia, Arkansas and Texas there has been no increase in the south by immigration, either from the north or from foreign countries." It is added that there is reason for suspecting that "a pronounced scheme, concocted by southern political leaders, has been carried out by the southern census-takers to fraudulently magnify the population in order to maintain and increase their proportionate representation in congress."
The census returns from the south that have reached us are too meagre to warrant estimates about their correctness. But before the republican papers of the south begin to denigrate the census of the north they will do well to examine the surprising figures reported in the north. When the Chicago population grows from 229,000 to 293,000 in ten years, and that of Cook county from 349,926 to 606,800, while the population of the rest of the state of Illinois increases only from 2,081,475 to 2,500,000, and the population of the city of Chicago from 293,000 to 434,000, or a growth of 48 per cent; Athens, Ohio, from 10,000 to 16,000, a growth of 60 per cent, and Fremont, Ohio from 5,000 to 8,485, a growth of 70 per cent. The town of Cambridge, in Massachusetts, has increased from 39,000 to 51,000, or at the rate of 32 per cent; Fall River, Massachusetts, from 20,700 to 30,000 at the rate of 40 per cent; Lawrence from 28,900 to 39,000, or at the rate of 35 per cent; Providence from 63,800 to 104,000, or 63 per cent; and Lowell from 41,500 to 68,000, or at the rate of 41 per cent. These large rates of increase in population, which the republican papers of the north are so ready to denigrate, are the result of the same cause that is at work in the south, and when the challenging of the returns begins in the next congress, it will probably be made general.

An Explanation From Germany.
Washington, July 22—The German government has again been guilty of proceedings toward American citizens which are entirely contrary to the spirit of the treaty between the two nations. A naturalized American citizen, Mr. A. C. Boller, of St. Louis, returned some years ago with his two active American sons, and became an American citizen. His sons, native Americans, before they became of age, returned to the land of their birth, and where they exercise all the rights belonging to American citizens. The provisions of the treaty between the two nations are completely ignored. The court of St. Louis has decided in favor of the American citizen, and the decision is now being appealed to the German government. The court has decided that the American citizen is not to be treated as a foreigner, and that the treaty between the two nations is to be observed.
