The examination of Neal Wilkerson and Albert Smith, charged with the Brownwood-Eastland stage robbery, continued yesterday before J. C. Commissioner Pascoe. After testimony was given by the witness placed on the stand the day before, the government's counsel placed the robbery of Hackberry postoffice, in Lavaca county, Texas, on the 14th of last December.
