Miss Norfleet played for the great master a Bach Prelude and Moskowski's "In Autumn" Her playing brought the most lavish praise of Mr. Pade-rewski, who exclaimed, "Bravo! Bravo?" as the last notes died away. He declared her technique wonderful, that her playing is exceedingly musical and was especially impressed with her perfect tone coloring. He examined her hands carefully and said they are perfectly formed for piano playing. He declares she has wonderful talent, has received perfect training, and will become a great concert pianist, though he advised her not to practice too much. 

In Memory of James Chisum. James Chisum was born

Sept. 25, 1827 in Hardeman Co., Tennessee. His parents moved to Paris Texas in an early day where he grew to manhood and married Miss Ada Josephine Wright, Dec. 21st 1852, then he moved to Bolivar, Denton Co, Texas where two daughters and two sons were born to them. The eldest daughter, Mary Branch and his loving wife died over 32 years ago, and are buried at Bolivar Texas. After losing his loving companion, he moved to the old Chisum ranch at South Spring, Lincoln Co New Mexico with his two sons Walter P. and Willie P. Chisum, both of Roswell; and his daughter, Mrs. Sallie L. Roberts of Artesia, moving there in 1879 where he and his two brothers, the late John S. Chisum who died at Eureque Springs Kansas, on the 22nd of Dec. 1884, and was buried at Carlsbad, N. M. March 24, 1908. Paris Texas; and Pitzer M. To the Hon. Wm. H. EDDY COUNTY'S NEW JAIL.

Building About Completed and Will be Received by the Court in a Short While.

The contract price for the building, including iron work and plumbing in the corridor and nest of cells was \$11,480. The foundation is of concrete, 5 feet wide and two feet deep and besides all round two foundations of like size run under the two inside walls north and south. The building is of Iola gas burnt brick. The stone work extending four feet above the foundation is of native lime stone trimmings, which there are two rows extending entirely around the house is of Barstow red sand stone. The window lintels are also of Barstow red sand stone. The building is located seventeen feet from the rear, north end of the court house and the second story, in which the jail is located is connected with the sheriff's office by an overhead passage-way (bridge of sighs) and the sheriff's office opens into the court room. The floor of this passage-way is of concrete, with roof of galvanized steel and the sides are covered with heavy wire cloth and in taking prisoners to the court there is absolutely no opportunity for escaping. There are six rooms on the first floor including a bath room, lavatory and toilet, and entrances on the north, south and west sides. Five of the rooms will be fitted up' for the jailor's residence and the grand jury room is 14x20. Steps from the front hall lead to the second story. At the top of the stairs is a bath room, toilet and lava tory for prisoners and in front on the west side is the woman's cell.

This room or cell is 12x12 and the windows are provided, it. with heavy iron bars. From the upper hall-way there is a heavy solid iron door that opens into the jail proper. This is a light room 27x32 and there are eleven large windows with heavy iron bars on the outside and heavy wire cloth on the inside. The floor is of cement and the corridor and nest of cells is in the middle of the

There are four cells and each one is provided with two heavy folding iron cots, and in the corner of each cell there is a pipe that leads out through the roof and this pipe is covered heavily with sheet steel and in the cell at the bottom of the pipe there is a receptacle, with door which holds a sanitary night bucket, which is absolutely odorless. 


