Artesia, New Mexico. Dear Sir: -I have been a reader of the Advocate a long time and have noticed that it is always on the lookout for political grafts and skin games intended to break the strength of New Mexico Democracy and I thought you might be interested in what I have to tell.

I have been informed by a reliable person, whose name I am now willing to give, that the Republicans of Eddy county are about to pull off what they consider a smart trick, and if the Democrats lay around and swell up with a feeling of security, the trick might work.





Ancient Artesia.

(By Gayle Talbot.)

When the initial issue of the Advocate made its appearance five years ago, Artesia was in its swaddling clothes, so to speak. While the townsite had been laid off some months previous, the town's real growth dated from the bringing in of the first well near the corner of what is now Richardson and Rose Lawn avenues This well had been completed about two weeks when the writer came. July 8, 1903, was the date and the first issue of the Advocate came in August. At a meeting in the Rhode's hall (now Batton's second hand store) Artesia Commercial Club, of which A. V. Logan was first president, proffered the inducements that were directly responsible for the paper's coming. There were at that time only two buildings on the south side of Main street in Artesia Improvement Company addition. One was Clark Brother's store now occupied by W. E. Ragsdale and the other a combination drug store and residence occupled by Dr. J. F. Rhodes, an Arkansas doctor who never had a counterpart on earth. The Advocate built the second house on the north side of the Higgins was doing the prostreet (now adjoining Mrs. Dyers' bakery on the east) the other being a saloon presided over by a man named Tucker. The writer could have bought any of the Main streets lots for fifty dollars. The bare lots are now worth two thousand or more.

The first copy of the Advocate that came from the press was confiscated by Dr. Rhodes. The first man to pay for a cash subscription to the paper was newly completed store build missed an issue since.

then escaped from the fertile imagination of Mr. Higday and associates.

Hart Crouch arrived this week from the Ruidoso and purchased the site for Artesia's first livery stable, and no one could imagine where he expected to get his business.

Rev. W. T. Burk was Methodist circuit rider and he and Rev. J. C. Gage announced the first protracted meeting to be held in the town, and that was upstairs in the Rhodes building, where a thriving union Sunday School, under supervision of R. M. Ross was conducted. Mr. Burks owned a homestead south of town (now known as the Hoffman ranch) and sold it to J. R. Blair for \$590. It is today worth \$24,000.00. But Brother Burk thought he was rich and went on his way rejoicing over his good sale.

The second well to be put down was being bored on the I. Mack Smith place, south of town. This was a wild piece of land worth one or two dollars per acre. It is now in fruit and alfalfa and sold a week or two ago for \$32,000.

Capt. J. M. Chase was erecting a small store house in the midst of the prairie where the town of Dayton stands. E. C. moting down there, as an assistant to Doc Day. 



Ancient Artesia.

(By Gayle Talbot.) When the initial issue of the

Advocate made its appearance five years ago, Artesia was in its swaddling clothes, so to While the townsite speak. had been laid off some months previous, the town's real growth dated from the bringing in of the first well near the corner of what is now Richardson and Rose Lawn avenues, This well had been completed about two weeks when the writer came. July 8, 1903, was the date and the first issue of the Advocate came in August. At a meeting in the Rhode's hall (now Batton's second hand store) Artesia Commercial Club, of which A. V. Logan was first president, proffered the inducements that were directly responsible for the paper's coming. There were at that time only two buildings on the south side of Main street in Artesia Improvement Company addition. One was Clark Brother's store now occupied by W. E. Ragsdale and the other a combination drug store and residence occupled by Dr. J. F. Rhodes, an Arkansas doctor who never had a counterpart on earth. The Advocate built the second house on the north side of the street (now adjoining Mrs. Dyers' bakery on the east) the other being a saloon presided over by a man named Tucker. The writer could have bought any of the Main streets lots for fifty dollars. The bare lots are now worth two thousand or more.

Gåge announced the first protracted meeting to be held in the town, and that was upstairs in the Rhodes building, where a thriving union Sunday School, under supervision of R. M. Ross was conducted. Mr. Burks owned a homestead south of town (now known as the Hoffman ranch) and sold it to J. R. Blair for \$590. It is today worth \$24,000.00. But Brother Burk thought he was rich and went on his way rejoicing over his good sale.

The second well to be put down was being bored on the J. Mack Smith place, south of town. This was a wild piece of land worth one or two dollars per acre. It is now in fruit and alfalfa and sold a week or two ago for \$32,000.

Capt. J. M. Chase was erecting a small store house in the midst of the prairie where the town of Dayton stands. E. C. Higgins was doing the promoting down there, as an assistant to Doc Day. He put in a whole day trying to sell "business" property some down there to the editor of the Advocate before he found out he was a newspaper man and didn't have the coin.


