A. L. Torres, Y. L. Almeda F. A. Seldner, Yldefonso Salido and G. R. Romay, delegates from the state of Sonora to the national presidental convention held recently in the City of Mexico, have just passed through El Paso on their return. The convention was composed of 1.000 delegates and was absolutely unanimous for president Diaz for another term and practically unanimous for the continuance in office of vice president cities would have been obviated Ramon Corral.

At the same time there are ominous clouds gathering on the Mexican political horizon.

Diaz has now been president for 27 consecutive years; he is now 82 years old, or far beyond the usual span of life. If he were to die tomorrow or at any time during his present or com ing presidetial term, chaos would undoubtedly come again in Mexeco.

REYES LOVED BY ARMY.

The foremost, perhaps contending possible successor to Diaz is Gen. Reyes, the present governor of the state of Nuevo Leon, whose capitol is Monterey Reyes has been commander-inchief of the Mexican army and is still so popular with the sold iers, it is said, that it is thought he would have no difficulty in securing the support of the army to his presidential pretensions. Grave fears are thereforee entertained, it is said, of a turbulent and bloody revolution in Mexico in case of the death of president Diaz. 
