## TALK ROADS

Both Rail and Dirt at Club Meeting Monday Night.

## ENDORSE COMMISSIONERS

On Roads But Hold Trophy Temporarily. Boost Chicago Exhibit.

The Artesia Commercial Club at its meeting Monday night talked sanitariums and railroads; asserted that the County Commissioners were honestly mistaken about ownership of Hearst Trophy; endorsed the Chicago Land and Irrigation Exposition in strong resolution, not forgetting the Bureau of Immigration; requested the improvements committee to push Plains road and Road Commissioner Patrick to push the improvement committee; praised the commissioners for good faith in regard to roads; asked the secretary to employ his persuaders the night before meeting; took in eight new members; accepted the invitation of the festival committee to be present today at 3 o'clock, and referred invitation from E. A. Clayton to spend a day at Spring Lake Spa to the house committee.

## MINUTES OF THE MEETING.

The Club met in regular session at the rooms of the organization at 8:30 o'clock p. m., with the president, Judson G. Osburn in the chair. Owing to the absence of the secretary on account of indisposition, his place was occupied for the night by James D. Whelan. The roll call showed the following officers and directors present; J. G. Osburn, H. W. Hamilton, J. B. Atkeson, H. G. Gray, G. U. McCrary, E. C. Higgins and James D. Whelan, besides a good many committeemen and regular members.

The roll of committees showed that none were ready with a formal report. Whelan of the railroad committee said he had an important communication relative to the possible building of a road across the Valley but desired to take the matter up with the railroad committee before laying the whole affair before the house. Henninger of the committee on sanitariums said that he had had several conversations with Dr. F. M. Smith and that they believe it would be a good idea to have a committee meeting called by Dr. M. M. Inman, chairman of the committee. Relative to sanitary matters which fall within the province of the committee he thought all physicians ought to be added to it and greater stringency advised. The president stated that he would act upon the suggestion.

Under the head of communications, the first one received was from C. H. McLenathen vice-president of the Carlsbad Commercial Club who as the representative of that body

wrote to inform the Commercial Club that on application to the Board of County Commissioners by the Carlsbad Commercial Club said County Board had authorized him to write to the Artesia Commercial Club requesting the Hearst Trophy. Whelan moved that Secretary Clark be instructed to reply that the Artesia Commercial Club is now and has always been willing to pass around the cup in accordance with the terms of the agreement entered into between Artesia, Hope and Carlsbad last fall and acted upon by the Commercial Clubs of all of said communities, and that had the request come from the Carlsbad Commercial Club acting solely in its own behalf it would have been complied with; but inasmuch as the communication came virtually from the Board of County Commissioners, a body which has no right whatever in the premises and which while, no doubt, acting in good faith was mistaken as to its rights, therefore that the Artesia Commercial Club would retain the Trophy until such unwarranted claim was abandoned, as the turning over of the cup to Mr. McLenathen as the representative of the county board might be construed to imply a concession on our part that such board had some claim upon the said Hearst Trophy. The motion also provided that the president Judge J. G. Osburn and the two vice presidents, Judges G. U. McCrary and J. B. Atkeson, be instructed to act as a committee to assist the secretary in the correspondence. The mover after the motion had been duly seconded by E. C. Higgins, made a short talk reviewing the history of the acquirement of the cup to show that it was not the property of any one of the three above communities or of the county as a political entity. The motion was carried.

A request from the United Land & Irrigation Co. of Chicago asking that the secretary send literature was referred to the committee.

## TOURNAMENT--PRESS MEET

## Moral Issues.

A few weeks ago the reading public was somewhat surprised at an action taken by an Episcopalian board back east in which that body declared for a downward revision of the tariff. About the same time a bishop of that church denounced the minions of privilege in no uncertain tones and this, too, caused not a little comment. Ordinarily as far as possible we believe that churchmen as such should remain out of politics; except where some moral issue is involved and this will generally be acknowledged, as the correct rule. But we differ from a great many people as to what constitutes a moral issue.

There has been among both the clergy and laity a tendency to assume that speaking generally only issues relating to temperance, to some form of gambling or to the social evil could be considered as moral issues except perhaps cases of open and vulgar bribery or of stealing of public money. All these are moral issues, to be sure, but they do not by any means comprise all the public questions that can be classed in that category. The fact is that all issues have a moral as well as an economic aspect. Some times the moral phase is involved to such a slight extent that it might be considered non-existent for all practical purposes, and when such is the case the active interference of churchmen in their clerical capacity is to be frowned down. But as it is by no means unusual for the moral phase of a question to be relatively small in one generation and relatively great in the next, and when the moral side of the issue becomes predominant it is pretty hard to preach any sort of practical sermon without saying something that in one way or other has some bearing on the public question. In this event it is just as well to "call a spade a spade" and be done with it as it is to "whip the Devil around the stump." Hence, we commend the Episcopalian gentlemen in frankly saying what they thought about the tariff question and about the matter of privilege.

For, the tariff is now a moral issue and that phase of it exceeds all others and moreover it is the greatest question in national politics today. Fifty years ago the moral aspect of the tariff was comparatively insignificant. It is true that the advisability of "perverting manufacturers with any sort of governmental "encouragement" presented some moral aspects, but the only phase that loomed large then was in regard to whether it was wise as a business pro-

position to give protection for a few years to certain industries until they grew big enough to meet competition. This was all that was ever suggested by the early protectionists.

This condition has changed. While the economic part of the subject has grown to enormous magnitude the moral has grown still faster and now overshadows all others.

For the money which the tariff fattened trusts have received from the people under the pretense of turning it over to their workmen, they are putting into their own pockets and not only that but they are giving the foreign purchaser alone the advantages of the low prices to which the home consumer is entitled. Therefore, they are using the anti-foreign prejudice to get the American people to give them something for the purpose of fighting the foreigner (which by the way is not a very humane or Christian-like purpose) and then instead of injuring the said foreigner as they have agreed to do, they give him the benefit of their industrial development and charge the American dupe up with the cost of the process.

If "Hungry Joe" king of New York green goods men ever perpetrated a bigger fraud and one more worthy of denunciation, the criminal records fail to show it. The abolishment of protection thus misused is clearly as moral issue.

Then the dominant political party retained power last year under a promise to revise the tariff honestly and downward. True the platform did not say downward, but the presidential candidate so construed it, and if he had not done so he would not be president of the United States today and the majority of the Republican congressmen and some of the Republican senators would have been home making an honest living perhaps.

To refuse to fail to carry out political pledges in this case is larceny of office and power as Mr. Bryan very correctly and forcibly says. Now if it is right to denounce the small malefactor, and it is, there is all the more reason why the great criminal should be brought to book and compelled to disgorge his ill gotten gains and the clergy is clearly within its rights in saying so.

All of which leads us to commend the Episcopalian referred to and to wish them success in this fight, which is the fight of the country as well as their own.

## Censures Elbert Hubbard.

In the Public of July 23, Geo. V. Wells comments on the introduction of "Little Journeys to the Homes of Great Business Men" into the high schools in the East. These delightfully written essays by that elegantly mendacious little prevaricator, John Wanamaker's hired man Fra Elbertus, shocks somewhat the ideas of proprietary of the staid and orthodox Wells, who seems to still retain the superstition that there is a standard of right

and wrong in this world, and that people ought to live up to the "light as God hath given them to see it." Wells seems never to have learned that the proper way to be right is to deny that anything can be intrinsically wrong, to assume that immorality consists in not regarding anything as immoral and that theft is commendable if you are wise enough to think so and can keep out of the penitentiary. Hence, Wells doesn't take kindly to "teaching the young idea how to shoot" according to the doctrines and dogmas of the effeminate Fra. For be it known that the Fra is the most inoblerant dogmatist that ever wrote, whenever his own dogmas are called to question. Therefore Wells figuratively whets his hatchet and goes on the war-path. He is sacreligious enough to think that there is something wrong with the act Hubbard commends in Armour when the packer and his partner "discovered how to make a hog yield four hams" and sold all of them to the government for real hams. Getting money under false pretenses is generally considered a crime, but those who get money in that way from Uncle Sam are seldom punished and that there is any other higher reason why men should refrain from such business transactions is an old foggy notion, which only narrow-minded men like Wells are foolish enough to believe.

Wells' objection to the Armour "Little Journey" is summed up in the last paragraph, and the same objection will lie against all the writings of the Immortal who elects to immortality all who are willing to part with ten dollars for an occasional "Philistine" and a semi occasional fragment of brilliant misrepresentation in other forms.

"The real objection to such books is that they are carelessly written and give to youthful readers false impressions of the real truth that underlie human relations. The square deal in economic and political reform is delayed by the false ideas which this book is the means of spreading."

(Concluded from page 1)

ceived and the secretary instructed to comply with same.

Several communications from M. L. Stewart relative to Bryan meeting and Chatauqua course were laid over.

A communication was received from H. B. Henning in regard to the Land & Irrigation Congress to be held in November and December and the following resolution was carried:

"Resolved: That we heartily endorse the Chicago Land & Irrigation Exposition to be held in Chicago Illinois from November 20th to December 4th and that we hereby declare it to be our purpose to co-operate with the Territorial Bureau of Immigration in getting up a first class exhibit from this territory."

The following applications

were acted upon favorably by the membership committee and the parties voted into the Club; J. A. Bruce, William Hubbard, Ed Muncey, Horace Cooper, Dr. P. M. Baker, Reed Brainard, T. R. Smith and G. E. Patrick.

An invitation from the Executive Committee of the Annual Alfalfa Festival invited the club to meet with said committee and with the Farmers Institute and the Alfalfa Growers and other citizens Saturday July 31 at three o'clock was accepted.

A correspondence between Road Commissioner Patrick and County Commissioner Joseph H. Graham and between the latter and the Division of Public Roads of the United States Department of Agriculture was read. It appears that the said department would send a man if applied for in time to super-

intend the work: the county or locality to pay all expenses of work. Mr. Patrick said he had also written in person but had received no reply. There would be no public money available until next January but a couple of thousand dollars would fix the road. The commissioners would do all things possible to help as soon as they received the money. Mr. Patrick thought that the Commercial Club ought to take the matter up. He gave a detailed and intensely interesting account of the condition of the proposed road and cited numerous conversations he had had to show that when the bridge is finished we shall gain a vast trade for Artesia. The committee on public improvements was instructed to get busy and a special instruction was given to Mr. Patrick to see each member of the com-

mittee personally every day and urge promptness and dispatch until the matter should get under way. This motion by Atkeson, seconded by Whelan. An amendment by McCrary was accepted to the effect that the committee investigate the new convict labor law and if possible secure convict labor on said road. The proposed work of the Board of County Commissioners on roads was heartily endorsed in the same motion. Carried.

Whelan favored having the notices for meeting put in the postoffice the night before the meeting so members could get them with morning mail and on motion by Atkeson seconded by McCrary it was determined to request the secretary to do so.

The president referred to a communication from W. A. Winters of the San Diego, El

Paso & St Louis railroad ask what Artesia would do. Higgins suggested that we get up bonus for first road built.

Referred to railroad committee with instructions to act as quickly as practicable.

President also stated that he had been called up from Roswell by E. A. Clayton with proposition to have an entertainment in behalf of the club at Spring Lake soon. He had not given details. Moved by Whelan and seconded by Hamilton that the matter be referred to the House Committee of the Club, because as said committee has charge of entertainments given in town it presumably should have charge of club entertainments outside. Carried.

### Obituary.

These were "Rock of Ages," "Jesus Lover of My Soul," and "Nearer My God to Thee." As she faced the inevitable there was no fear or dread, but Christian fortitude and resignation for she was ready to go having made her peace with God many years before. The end came quietly and peacefully, and she fell "asleep in Jesus." "Asleep in Jesus! Blessed sleep! From which none ever wake to weep!"

### Another Wise Law.

The last legislature passed a law that is an astonisher. It is chapter 101, and was passed and approved on the last day of the session, so it must have been approved by the celebrated steering committee. The object of the law is to prevent women visiting saloons, but it is so sweeping in its character that it prohibits every woman from visiting any of the stores in Lordsburg, and if they enter the postoffice or the ice cream parlor they are liable to a fine of \$100 and six months in jail. Of course no conviction could ever be had in the local court. The woman who enters the court room would be guilty of a violation of the law. The first section of the law prohibits a woman entering the saloon, under any excuse. The second section provides that "it shall be unlawful for any woman to visit \* \* \* any room adjacent to or within one hundred feet of a saloon or any place where intoxicating liquor is sold or given away, or found loitering around or within one hundred feet of the same." The penalty for a violation of this law is a fine of \$100 or six months in jail, or both. An inspection of the main street of many of the towns in the territory will show how utterly impossible it would be for a woman to visit many places of business in the towns without violating this law.—Lordsburg Liberal.

As all the drug stores in the dry towns sell intoxicating liquors for medical purposes on prescriptions and as the law quoted by the Liberal does not define the character of the sale which will make the statute applicable, we anticipate that it will be well for the ladies to avoid Main street between Joyce-Pruits dry goods department and the Artesia Feed & Fuel Company headquarters. "Cooper'll git ye if ye don't watch out."

The law in question is similar to the act of the Nebraska legislature in the early eighties which provided that "it shall be unlawful to discharge any gun, pistol, rifle or other deadly weapon upon any road, turnpike or other public thoroughfare, except to destroy some wild, noxious or ferocious animal or an officer in discharge of his duty."

### The Hearst Trophy.

There is absolutely no reason for any friction concerning the disposition of the Hearst Trophy which was won by the exhibits for Hope, Artesia and Carlsbad at Albuquerque during the National Irrigation Congress and Interstate Fair last year. While Artesia and Hope won twentyseven of the twenty nine prizes taken by the county, yet had any of the three exhibits been withdrawn it might have meant the relegation of Eddy county to the second place among all the county exhibits in the United States. We say it might, though the withdrawal of Carlsbad would scarcely have had such result. Certainly the withdrawal of either Hope or Artesia would have been fatal. Now, as this cup was won by the three it legally and morally belongs to all of them, and them alone, not to Queen or Malaga or Loving. The only thing to do, in our opinion would be for all three clubs to appoint a committee composed of business men from each town who would have charge of the cup and let each club contribute to a common fund for the management and prompt circulation of the Trophy. The Carlsbad Club erred in repudiating its agreement and the commissioners erred unthinkingly in yielding to their representative, but all this is of little importance since with the exercise a little discretion and common sense the matter can be adjusted without trouble.

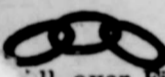

When he went back to Denver, he got off at the junction, and went home by way of back alleys, and so bribed the Jap cook that he remained in the barn two days before even his women knew he was on the place, in the meantime sending out emissaries with an olive branch as big as an alfalfa stack, who finally fixed it up so that it was safe to move about a little without being mobbed by the suffragettes. He is still maintaining the shut mouth before referred to, and when anybody asks him if he said it, he points to an authorized statement, printed in 18-point type, to the effect that his meaning was grossly misintepeted. That is always the fashion of big men when they tell what they really think, and a new reporter doesn't have any more sense than to tell the world what it is. It is not of record that the ex-governor is particularly penitent. He is merely dodging the lightning, and that is a whole lot wiser than he was when he started the rumpus.

All of which goes to show the ever lasting danger of shooting off your mouth, which is always loaded. It is morally certain to hit somebody, and the first thing you know you are yanked up on the charge of slander. There are some illustrious precedents in this line. Dr. Burchard was one of them. His little old phrase about "Rum, Romanism and Rebellion," put Jim Blaine among the "also rans," and caused the unspeakable blight of Clevelandism to be fastened on the country. There wasn't anything very bad about what he said. Any person with sense at all could identify it as piffle, very appropriate for the ministerial assembly, which usually has about that grasp of real current conditions. When it was spit right out in meeting, and the indiscriminating and uncharitable reporters gave it to the world, it raised one corner of sheol, and caused a political landslide that was among the greatest misfortunes the country ever had. Burchard differed from Buchtel in that he tried to explain it away, and as is usual in such cases, every time he opened his mouth he put both feet in it.

Of a still more illustrious rank was the break of the great and only Teddy, when he threw a brick at "Gene Debs and described him as an "an undesirable citizen with a revolutionary creed." That described Debs all right and certain of his faith, but when the one-idea fellows got through with Teddy he was about the most ridiculous subject that ever attempted to talk politics. He wasn't loaded to make his shoot off repeat and the undesirable citizens were. In other words he bit off more than he could chew when he spat off his mouth, which by the way was a favorite Rooseveltian pastime. Usually he got away with it better than in this case.

Way back in the early days

of the republic one Hamilton was slated for the presidency and would have cut the mustard but for the fact that in an unguarded moment he expressed his real opinion, which was to the effect that the ideal republic and the limited monarchy were to all intents and purposes the same thing. He actually and very sincerely thought it, but he should have kept it under his hat, especially since he very much wanted to be president, and in all likelihood would have made a good one. He fired himself before he was hired, as many a good man has done before, by way of his mouth.

Over in England when one Cromwell put the screws straight to the ruling king-gerino, the said sovereign forgot his balance wheel and said things that he really meant. There were no newspapers then, but the English were ever great gossips, and when Oliver got through with the late lamented, there wasn't a full sized grease spot left. If Charles had not shot his mouth off, but instead had used a little soft solder, Oliver would have lapsed into obscurity, and the history of England would have been a lot simpler than it is.

Coming back to our own country, one heartfelt remark of Jay Gould's to the effect that the people might be dammed, opened the way for the Ida Tarbells, and all the muckrakers for the attacks on predatory wealth, that is certain to work a big change in the course of a few years. Gould really felt that way, but if he had kept his head closed, the people would have been years in realizing that they were dammed by the influences of unscrupulous capital, such as those against whom President Taft is now waging such a staunch battle.

And there are thousands of other cases. Many of them will come to your memory the next time a chance remark lands you as a witness in court or loses you a customer out who has his peculiarities that are truthfully as you described them, but who is mean enough to resent it when you start on the stunt. The only really safe way is not to say it. Then you won't have any trouble taking it back or qualifying it. If you must submit to an interview, boost your home town. Declare there are no knockers in it, that the climate has Italy under the kibosh, and there is no use worrying about heaven as long as you can live there. Either that or copy after Gov. George Curry. You often hear that gentleman referred to as an unsophisticated and uneducated soldier sort of a fellow. It is to laugh. Just nose his record since he reluctantly consented to be pried loose from Samar. He has gone up and down the territory, discovering his old home town in every county in the division and giving the glad hand to all the callers and especially the newspaper fellows. Several hundred columns of interviews have been credited to him, but do you remember one case in which he has shot off his mouth and started something? Not on

face where it had never been before.

I notice that Dr. Washington Gladden, the fellow who kicked up all that row about "tainted money," is figuring and worrying about what he would do if he suddenly came into the possession of a million dollars, presumably not smelling bad. The reverend gentleman would buck Carnegie in the library line, and put in free baths for the people everywhere. Just why he wants to anticipate what the government is going to do is one of the hardest things about it. Preachers always were impractical ducks anyhow, and his plans in case somebody should drop the dough in his sock show that Mr. Gladden is the same stripe as the rest of them. All of those pretty and philanthropic ideas are all right as far as they go, but they do not go far enough. The first thing Wash would do after he got his hands on the roll would be to resign from the ministry and proceed to make some more millions. There never was a man yet that did not feel that way when he got a row of goose eggs, and it is unreasonable to believe that he would be any exception to the case. Preachers are merely mortal, the same as the rest of us, and contact with large amounts of the mazuma has just the same effect on them as on the rest of mankind.

One of the most remarkable incidents of the great Wells trial at Roswell last week was the voluntary production in court of all the books and records of the labor union, which was alleged to have been guilty of a conspiracy. Judge Pope had issued a call for the documents to be produced though he did not contend that the union could be forced to expose them as evidence. No earthly power could do that. He simply made them produce the records and then asked them if they were willing that it should be submitted. Considerably to the surprise of a good many, they were perfectly willing, and it must be confessed that the union stood all the better for it. Many people have on idea that a labor union is a secret society of dangerous anarchists, and we are surprised when they are convinced that they are nothing of the sort.

The same case has attracted a great deal of attention, but it is not complicated at all. The defendant objected to the principle of the "closed shop" which means that only union men can work on a certain job. He insisted that he had a right to hire whom he pleased, and in making the point stick, the union set a watch on the premises to warn and cajole away volunteers for work. Wells objected to this as an interference with his alleged rights, and an altercation resulted. When it was over one of the pickets was very dead. Not much complication about that, is there. Reduced to plain English, Wells contended that he had a right to run his own busi-

ness without the interference of anybody. The union held that it had a right to prevent his hiring non-union men if it could. Which would seem to point the lesson that the general adoption of the Golden Rule is quite a ways off yet.

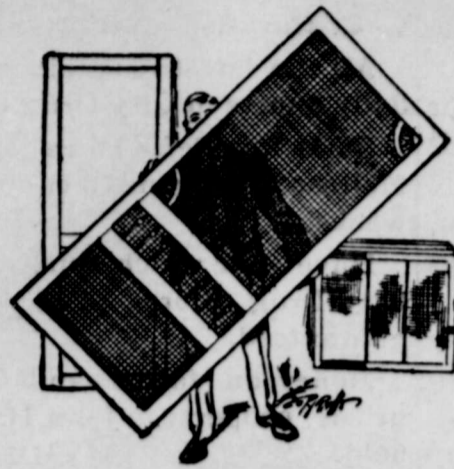
