The choice of Petersburg, Va., for a national army cantonment site was revoked.


News of the selection of Fort Worth as one of six national guard training camrs was received with great rejoicing at that city

A big step toward national prohibi tion was taken when the senate judiciary committee reported the Sheppard prohibition bill with the recommenda tian that it be adopted by the senate. A second step in the same direction was taken when the senate committee on agriculture voted to report out a bill restricting liquor manufacture for the purpose of conserving the food supply. Senate finance committee de cided recently to put into the war tax bill a prohibitive tax on distilled li qurr The Leever food control bill was ordered favorably reported by the house agriculture committee. In addition to temporary restraining order applying to University of Texas Regents Mathis, Kelley and Fly, a similar order applying to Regent W G. Love was granted at Aus tion by Judge Ireland Graves. These regents are restrained from dismiss ing John A. Lomax and other uni versity employes. Petition alleges conspiracy to that end. He also disposed of the John W. Hornsby que warranto proceedings against Dr. J. PI Tucker of Galveston by continuing in force, for this term of the Twenty-Sixth district court, the temporary restraining order preventing Dr. Tucker acting or attempting to act as a re

gent. At the fall term there will be a hearing, if necessary, to determine whether the temporary order shall be made permanent The order against the regents cannot be made permanent because the court is now in recess.

New Compress Company. Waco Compress company has been organized with a capital stock of \$100,000 for the purpose of building a new compress at that city. It is understood that a north Texas compress will be moved there to furnish the nu-

cleus for this plant.



### TRANSPORT SHORTAGE SERIOUS

Dispatch of Vessels Is One of the Gravest Problems With Which the United States is at the Present Time Confronted.

Shortage of ships for military transport service constitutes one of the biggest problems before the war chiefs of America today.

That dispatch of the bulk of the new army may have to be delayed by reason of this lack of transports is admitted by men in charge. There are sufficient ships to carry vast numbers of soldiers, but this is only a small part of the problem, inasmuch as these men constantly must be supplied with food, clothing, artillery and also other equipment.

In itself this is a tremendous task. The army will require its own weight in food every thirty-nine days, while all artillery must be replaced about every thirty days. Other supplies must be kept going in a constant stream. In addition to these needs there is the question of getting supplies to the allies.

With these two needs, commercial and military, government heads are perplexed about meeting the problem. Next year will see a new flotilla of cargo carriers, but the big needs will come in the next few months.

Lord Northcliffe, in America to coordinate the work of British missions, is counted upon to make some valuable suggestions in the line of obtaining enough shipping for all needs. As army plans now stand they contemplate dispatch of units abroad more or less constantly and in comparatively small numbers.

Soldiers already partly trained will get the finishing touches in France. The fact of sending these skilled men ahead necessarily will delay some what the dispatch of the new army, for absence of a training force will delay molding of the recruits.

FOURTH RAID OVER ENGLAND. FIFTEEN GERMAN AIRPLANES FORM THE SQUADRON.

Germany's fourth airplane raid on England in recent weeks claimed a death toll of 97 and 437 comprise list of injured in the city of London alone and fifteen airplanes formed bombing squadron.

Chancellor of the Exchequer Bonar Law announced in the house of commons that one of them had been sent to earth

The German raiders appeared over the Essex coast in broad daylight, the hour being noon.

In the East End of London one bomb dropped by the air pirates struck an elementary school, killing ten children and injuring fifty.

British anti-aircraft guns and defense planes vigorously fought off the invaders.

Special constables were called out hurriedly and the damaged areas at once roped off to keep back the curious crowds.

King George and Minister of War Derby went in an automobile to that part of London which had been hit, inspecting the wrecked buildings and tendering their sympathy to relatives and friends of the victims.

#### American Ship Rems Sub.

Destruction of a German submarine by the American ship Kroonland was reported by the merchantman on her arrival at an Atlantic port, an American harbor. Her officers would not discuss the encounter except to say that by agile maneuvering the vessel managed to ram the U-boat shortly after two of the under-water boats had attacked the merchantman, one from either side. The Kroonland lost a blade from her propeller.

#### Big Bond Purchase.

The United States Steel Corporation increased its subscription for the liberty loan bonds from twenty-five million dollars to fifty million dollars and declared an extra dividend of 1 per cent on the common stock to enable stockholders to contribute to the Red Cross fund of one hundred million dollars. If the total extra dividends are turned over to the Red Cross it will mean a contribution of \$5,500,000.

#### Liner Torpedoed, Many Lost.

The South Atlantic liner Sequana, with 550 passengers on board, including a detachment of the Sengalese rifles, has been torpedoed and sunk with a loss of 190 men.



Reinforcements were rushed to the aid of the patrol squad, but the Mexicans had retreated across the border when they arrived, the Americans not following across the line. Three bandits were killed.

Approximately one thousand soldiers, including a cavalry squadron, a company of infantry and a motorcycle machine gun company, immediately were ordered to the scene from El Paso by General Bell.

It is believed the Mexicans planned a raid of Ysleta.

#### Two Trainmen Killed.

J. A. Hall, freight engineer, was killed, and A. B. Brandhouse, passenger fireman, fatally injured, when a Santa Fe passenger train crashed into a stock train headon six miles south of Oklahoma City. A score of passengers were injured, some seriously. Five cars loaded with cattle and hogs were telescoped.

Appointment of Herbert Hoover is not to control the food of the country, but to release it from the grip of speculators and other persons who seek to make inordinate profits out of it, and to protect the people against Will remove the cause of sick- the extortions that would result, President Wilson said in a letter to Repentative Borland

'You are quite right about the administration measure," says the chief executive. "In my opinion, it is one of the most important and most imperatively necessary of the measures which have been prepared in connection with the war

"A certain dis-service has been done the measure by speaking of it as a food control bill. Object of the meas ure is not to control the food of the country, but to release it from the con trol of food speculators and other persons who seek to make inordinate profits out of it, and to protect the people against the extortions which would result.

President Wilson says "it seems to me that those who oppose the measure ought very seriously to consider whether they are not playing into the hands of such persons and whether they are making themselves responsible, should they succeed, for the extraordinary and atrocious price of food in the United States. Foodstuffs will, of course, inevitably be high, but it is possible by perfectly legitimate means to keep them from being unreasonably and oppressively high.

"I hope and believe that the congress will see the measure in this light and that it will come to an early passage, for time is of the essence. The legislation should be secured by the first of July to make the country safe against the dangers it is meant to guard against.'




