

#### SNOWFALL IN THE ELEVATED REGIONS OF NEW MEXICO --DECEMBER 1923.

A large excess of precipitation has occurred this fall and winter, the average snowfall amounting to 26.3 inches (Oct. 3, 5; Nov. 5, 8; Dec. 17.0 inches) compared with a normal fall about 9 inches. This gives unusual promise of abundant water in all streams. Soil moisture is good and the stored depth large in practically all parts of the state. The storms of December were frequent and general, heavy snow covering the plains and all lower levels, approaching or exceeding the depth in the mountain areas. Temperatures have averaged below normal and conditions in general have been favorable for the accumulation of snow in the higher districts and of soil moisture in lower ones. Present outlook for stream flow is excellent. Pecos and Southeast.

#### This district has also been favored with a large excess of snowfall,

especially the last month; the average for the season amounts to practically 25 inches. An excess of rain occurred in October and November. Soil moisture is abundant and the stored depth of snow large; 24 to 30 inches at headwaters and 8 to 24 inches in southeast mountain areas. Cowles: 30
