CULL YOUR SEED CORN CARE-FULLY, IT PAYS.

Ordinarily in planting each seed ear is responsible for at least two bushels of the crop expected. Think it over. The loss you sustain in planting one dead ear of corn more than outweighs the trouble of testing many ears. The agronomy depart-

ment of the New Mexico Agricultural College gives the following pointers on culling your seed corn. Culling of seed corn consists in

carefully examining each ear for inshould be observed for signs of im-

maturity. Good seed corn should have a plump, creamy white gern.. The kernels should be fairly large and well-matured with plump tips, and the backs of the kernels should be plossy and free from blisters. Indications of mould should be carefully noted, and a few kernels from each

should be discarded.




