WARN HUNTERS NOT TO EAT DOVES KILLED NEAR COTTON FIELDS

Warnings have been sent out over Texas and especially in the cotton growing districts, urging hunters to be very careful about eating doves, killed close to or in the neighborhood of cotton fields that have been poisoned for the leaf worm. It is said that these birds eat the worms without harmful effects to themselves, but the poison absorbed by their bodies make it dangerous for persons to eat the meat.

SIDE LIGHTS ON THE LIFE OF MRS. NOAH

Noah's wife, like the wives of The imperishable fame which shines other great men, never got as much upon his name would, indeed, be credit as she deserved. 

DEMOCRATS DEMAND HALF BILLION DOLLAR TAX REDUCTION 1927

WASHINGTON .- A half billion dollar tax reduction will be demanded by the democrats at the next session of congress, Senator Simmons, North Carolina, ranking democrat on the senate finance committee, declared Saturday night in a statement issued through the democratic national committee. He charged the republicans with deliberately attempting to hold off another reduction until next year to further the ambitions of republican presidential aspirants, and to provide political capital.

A surplus of \$562,000,000 will be available for reduction at the coming session of congress, said Senator Simmons, it is the clear duty of congress, he added, to distribute this "unneeded treasury surplus, and to put a stop to this unnecessary

taxation as soon as possible." Senator Simmons declared that liquidation of the war debt was closely connected with the question of tax reduction and that when congress meets in December the minority will demand not only sweeping tax reductions, but that since the foreign debtors have been given 92 years in which to pay their debts, the tax payers of the United States be given at least half that time in which to liquidate the indebtedness incurred by the foreign loans.







ELEVEN THOUSAND MILLIONAIRES, ONE BILLIONAIRE IN U. S.

NEW YORK, N. Y .- There are 11,000 millionaires and probably one billionaire in the United States in the opinion of Joseph S. McCoy, treasury actuary.

"The billionaire probably lives in New York," Mr. McCoy guesses in the current American Bankers Association journal.

Nine years ago when war profits held sway, there were 11,800 millionaires, but 2,800 of these toppled in 1920, and 2,000 of them have been replaced, studies of income tax returns reveal. Some of the war millionaires were even wiped off the income tax lists by the end of the 1920 depression, but today one out of every 10,450 Americans is a millionaire.

New York with 2,000 millionaires, leads the list. Pennsylvania is next with 1,052, then Illinois follows with 800, Massachusetts with 610, California 470, and New Jersey 390. North Dakota is the only state without a millionaire, and Idaho, Nevada, South Lewis Howell branded a bunch of Dakota, and New Mexico have one
