years. The attitude of the settler in those early days was one of indifference, while some seemed to regard a tree as an enemy to be destroyed. In 1691 some British officials be-

gan to wonder whether the supply of trees would last forever. An order was issued in Massachusetts reserving for the use of the Navy trees two feet or more in diameter. This may be called the first conservation law in America, but it was not allowed to stand long, and the waste continued. After the thirteen colonies became a nation, and population and industry increased, the destruction of forests went on still more rapidly. In 1876 it was estimated that nearly half the land originally in forest had been cleared, and the demand for lumber continued to increase.

Men had become alarmed, and in 1876 the Commissioner of Agriculture was ordered to have a study of the situation made, and soon thereafter a Division of Forestry was created. At first the appropriations were very small and the office was little more than a Bureau of Information, but it was at least a beginning.

Thus did this continent join the world movement to conserve the rapidly disappearing forests. In Europe three quarters of the original forests have disappeared. In Asia the proportion has been even greater. Japan has had some kind of forest-protection laws since early days, but China has allowed her forests to be cut down, until now she has only six



"Light your stove first. Put a wash boiler filled with water on one burner, a teakettle on another, and a large pan of water on the third.





Mrs. Belle DeGraf, San Francisco home economics counsellor, sug-gests a new and pleasing way of cooking string beans. String beans are very rich in vitamines. Mrs. DeGraf's recipe follows: String and cut beans in two lengthwise. Cook in a boiling salted about 25 minutes. Cook in a boiling saited about 25 minutes. Use only enough water to barely cover beans. Drain and season with ½ teaspoon sait and a dash of pepper and 1 table-spoon of butter. Set beans aside until sauce is made.

Put 2 egg yolks in a small sauce-pan, add 2 teaspoons of flour and 1 tablespoon of lemon juice; mix them and add 1 cup of stock. The stock can either be canned consomme, a bouillon cube dissolved in warm wa-ter or strained soup stock. Cook over a very low fire until sauce has thickened, then add to hot beans. Too fast or too long cooking will make this sauce curdle.

Beans Au Gratin

Another good dish is one recom-mended by Miss Lucy G. Allen, principal of the Boston School of Cookery, string beans au gratin. "Drain a can of stringless beans, and place them on a clean cloth to absorb all moisture," Miss Allen save.

absorb all moisture," Miss Allen says. "When well dried, put half of them into a shallow baking dish, season highly with salt and cayenne, sprinkle over the beans three table-spoonfuls of grated cheese, and pour over three tablespoonfuls of heavy cream. Repeat, making two layers and put into the oven to heat and brown about ten minutes.



Miss Allen also gives a recipe for glazed carrots. Carrots also have a high vitamine content.

Wash, scrape and cook five me-dium carrots. Cut in thin slices. Melt two tablespoons of butter in an omelet pan, and add two table-spoons of sugar. Add slices of car-rots, and stir well until browned.
