Tip-top Crumb Pudding 1 square unsweetened chocolate; 21% cups milk; 1 egg and 1 egg yolk, slightly beaten; ¼ cup brown sugar, firmly packed; ¼ teaspoon salt; 1 teaspoon vanilla; 1½ cups soft bread crumbs

14 cup red raspberry jam; 1 egg white; 2 tablespoons sugar. Add chocolate to milk and heat in

double boiler. When chocolate is melted, beat with rotary egg beater until blended. Combine egg, sugar, and salt; add chocolate mixture gradually, stirring until blended. Add vanilla and crumbs. Turn into greased baking dish and let stand 10 to 15 minutes. Place dish in pan of hot water and bake in moderate oven (350° F.) 45 minutes. Spread with jam. Beat egg white until foamy throughout; add sugar gradually, beating until sugar is blended. Then continue beating until mixture will stand in peaks. Pile lightly over jam on chocolate mixture. Re-turn to oven and bake 15 minutes longer, or until delicately browned. Serves 6.
