#### A BIG TASK AWAITS US

If the C. I. Many are realizing for the first time, the task of decentralizing coincidence. the useless government forces. Civilization has made some progress, but human nature is pretty much the same as it was 5,000 years ago and once a job is created with revenue for the job, numerous excuses can be found either for the continuation of the job or the making of a new position.

Students of government have been profoundly impressed with the statement that the number of government employes have increased forty five times faster than our population within the past thirty years. It is to be admitted that additional regulations may be needed as we progress and our population is enlarged, but society can be over regulated with the ramifications that go with regulation.

If individual initiative and freedom of thought have been responsible for making this nation the greatest one on the face of the earth (and no other can boast of the American standards of living) then we should give the individual initiative an opportunity to reassert itself. Individual initiative can not assert itself when stifled with too much red tape and too much government regulation.

All of which means that the government should cease its effort to compete with private business and turn business back in its rightful channel. Unfortunately for the private business concern for the tax payer, the head of the business concern can not ask for additional taxes to make up a deficit, created through mismanagement or from an experiment, but the government can and does. And this is one of the reasons why it will be futile to expect a reduction in taxes until the government decides to clean house and abolish some of the useless bureaus and will cease its efforts to compete in a field that rightfully belongs to private enterprise.

#### DEEPER DRILLING

Unless you know something about oil field history, the changes in the average drilling depth by years may not seem impressive. The average depth of new wells drilled last year was 3,052 feet, the highest since 1933 when the average was 3,100 feet.

This may not seem a spectacular increase from the 2,800-foot level attained in 1926. > DEATH FROM OLD AGE RARE EVEN AMONG WILD ANIMALS

Few wild animals die of old age, in spite of their freedom from the ills of civilization. Food shortage, accidental injuries, diseases, and natural enemies are the principal causes of death in the wild, says the United States biological survey. Pneumonia or inflamation of the lungs, is one of the common causes of death in the wild, as well as in civilization. Starvation is one of the most important contributing causes.

A number of wildlife diseases also attack human beings with serious and sometimes fatal consequences, and investigators must always be on guard in examining sick or dead animals. Rubber gloves and antiseptics are essential, and also care against bites by ticks and fleas from the animal. Rabies, anthrax, bubonic plague, glanders, tularemia, and undulant fever are among the wildlife diseases that man must guard himself against.
