



Oil men of Artesia, as well as business men of Artesia and Carlsbad, have been working for several months to have the improvement made

The road will serve a large portion of the more recently opened part of the oil fields.

The survey is being made under the direction of the State Highway Department.

The territory where the new road will be built was inspected May 4 by P. J. Vidal, chairman, and Ivan Hilton, member of the state highway commission, and B. G. Dwyre, state highway engineer, with a view to completing the link between Highways \$3 and 62 to serve the oil field region south of Highway 83.

The State Highway Department likewise has taken over six miles of Highway 83 west of Hope, known as the "cut-off," for which fence has been ordered and plans made to gravel surface it this summer.

State School Tax Amendments Into Effect on June 11

Perry, Field Representative, Explains Rulings of the New Law

Amendments to the state school tax act which will give an accurate check on wholesale and retail rating claims were announced yesterday in Artesia by E. M. Perry, field representative for the school tax division of the State Bureau of Revenue

These amendments are effective on and after June 11, according to Perry, who with J. A. Campbell, representative in the Hot Springs and Deming area, returned Sunday Beighty-five radio stations in a pro-gram "piped" through Artesia. Gov. John E. Miles, Col. Thomas from a division meeting in Santa

Under the new rulings, any firm classified as retail will be taxable at 2 per cent of gross sales, unless they retain certificates showing some sales were at wholesale prices, for resale.

The ordinance provides for three types of licenses, retailers' dispensers' and club, each to cost \$1,000 a year.


The retailers' license will permit sale of package goods only at retail, and will prohibit consumption of any alcoholic beverages on the premises

Under the provisions for dispensers' licenses, a licensee will be permitted to sell liquor by the drink or in original ackages. The club license is to be issued only a bona fide club of not less than fifty members who have paid membership fees of at least \$5 a year. The premises must be used exclusively for club purposes. The ordinance provides that the penalty for violation of any provision shall be a fine not to exceed \$200 or by imprisonment of not to exceed ninety days in the city jail, or both.

It is one of the ironies of nature that soil and rainfall conditions which are most favorable for the growth of the cotton plant are also most favorable for the multiplication of insect pests. The more luxuriant the growth the better the boll weevil, the flea hopper, and the leaf worm like it. It is not uncommon for a casual observer to list several days last week. remark on the promising appearance of a field of cotton, in which a close examination will show that the flea-hopper is destroying the fruiting buds, the boll weevil is laying eggs in the squares which escape the flea-hopper, and the leaf worm moth has deposited her eggs on the lower side of the tender foliage-the more luxuriant the better she likes it.



At this stage cotton should rapdly set squares and the squares become blooms. If rank-growing cotton doesn't look "like a flower iting her uncle and aunt, Mr. and garden" every morning there is something the matter. Every cotton grower knows that cotton naturally "throws off" a part of the embryo fruit, but natural shedding and insect damage are two quite different matters. The early and mid-season blooms and bolls are most important in the yield, and must be saved from insect damage in order to insure a normal yield.

With the greatly reduced acreage in cotton under the AAA it becomes the more important to secure good yields from the acreage we have, and controlling insect depredations is one proven means of so doing. Besides, insect control which permits the "weed" to hold all the early fruit it can carry brings the main crop to maturity earlier in the season and a higher percentage of it is harvested at the first picking, when the grades





The services of the staff of the Roswell office will be available to the public at all times for interpretation of this section of the act, Webb said.

The major functions of the Roswell office will be to maintain local contacts necessary to the administration of the program under which monthly retirement benefits will be paid to qualified workers beginto those who have or will become entitled to them since Jan. 1, 1937. The amount of the benefits will be determined by the wage record of he individual. Rables (or hydrophobia) is an acute, and rapidly fatal, in-fectious disease, most common in dogs, but often found in cats, wolves, foxes and coyotes. The infectious agent, from the saliva, is carried into the flesh of the bitten animal or person. This poison travels by nerves and spinal cord into the brain. Development of the disease varies greatly, anywhere from two weeks to two years. When a person is bitten by ANY animal, DO NOT kill the animal to have the head examined — this is a fairly good method, but not certain. It is far safer to pen the animal up and take good care of it for at least ten days. If the animal lives, there is no danger from rabies; if the animal dies, give the person who was bitten treatment against rables. There is no danger of rabies developing in ten days, while observing the suspected animal, unless the person is bitten about the neck or head. In this case, start treatment at once, while observing the animal. If it lives ten days, stop treatment; if it dies, continue treatment. MANN DRUG
