Transaction, Closed Wednesday, Involves Consideration of Three Million Dollars

Buffalo Oil Company and Jacob Feldman of Dallas Purchase Production and Large Lease Acreages in New Mexico-Will Maintain Local Office in Artesia.

A transaction in which the stock of the Maljamar Oil & Gas Corporation was sold to the Buffalo Oil Company and Jacob Feldman of Dallas, Tex., was completed Wednesday, it was announced by M. E. Baish, vice president and manager of the Maljamar interests.

Although local company officials did not disclose the consideration, it was reputed in a recent issue of the Oil & Gas Journal that the pending transaction involved \$3,025,000.

The deal involves all of the Maljamar producing properties in the Maljamar field in Lea County, including fifty-six producing wells and three drilling wells and about 12,000 acres of leases, as well as other scattered leases in Lea County and Texas.

The interests in Southeast New Mexico formerly held by Maljamar, will be operated by the Buffalo Oil Company, of which Herman Taubman is president and Frank Jacobson is vice president. Although the main office is in Dallas, a local office will be maintained here.

Buffalo Oil Company is an oil operating concern of wide interests in Texas and Oklahoma. The president, Taubman, is remembered here as the former owner of International Supply Company, which

operated a store here, prior to becoming the Bethlehem Supply Company.

Number of Early Lambs Will Be **Down This Year**

The number of early lambs in be about 6 per cent smaller this plantings of 291,000 acres this year than last and the smallest year, compared with a 1943 plantnumber in at least eight years, the Department of Agriculture report-

This reduction is a result of the smaller number of breeding ewes in these states, since the number of early lambs saved per 100 ewes was larger this year than last. Marketings of early lambs before July 1 will be considerably smaller than last year, but this decrease may be largely offset by a larger movement of grass fat yearling lambs and wethers from Texas.

Weather and feed conditions in the early lambing areas of the Pacific Coast and adjoining states New Mexico for January, Director Mississippi 33. to March 1 were more favorable for the early lamb crop this year than last in all states except California, and the development of the early lambs was better in most states than a year ago. Hay supplies at the beginning of the winter were expected to be short and prices were high, but the generally mild and open winter made full utilization of field and range feeds possible and reduced the need for nay and grain. In California the delayed winter rains and resultant shortage or absence of new green feed made necessary rather heavy feeding of costly supplementary feeds.
