# **EDDY GRAND JURY IS PETITIONED**

That much is certain. But who is causing its circulation and what is its terminology could not be learned Wednesday by members of The Advocate staff, in spite of frantic efforts in many quarters and questioning of persons who have seen or signed the petition. It had not been presented to any Advocate staff member for consideration.

Rumblings for many weeks have been heard that an Eddy County Grand Jury would be called, but the circulation of the petition here is the first definite evidence this might be done in the near future.

Persons who have seen or signed the petition here in recent days, said there is not a request for the investigation of any particular case or body. However, it was understood, it was asked that a district judge call a grand jury to look into the several governing bodies in the county and to consider any other business which might properly come before it.

There has been no grand jury in session in Eddy County in many years. The same maintains in a number of other counties in the state.

However, at present there is a spreading demand throughout New Mexico for grand juries, touched off by the calling of the Dona Ana County Grand Jury to investigate the death of Oleta (Cricket) Coogler, 18-year-old waitress, who was murdered several months ago. As yet there have been no indictments in that case, but the grand jury returned numerous true bills in other matters, involving local and state officials, as well as others.

More recently a Lea County Grand Jury has been called, specifically to investigate the alleged accepting of a bribe by Mayor Heard of Hobbs. And a grand jury has been called in Chaves County, so it was to be expected an Eddy County Grand Jury would be requested sooner or later.

### Law Of Little Value

EVERY TIME WE OBSERVE some of the old motor vehicles operating on the city streets and the highways, we can't keep from wondering just how long it has been since these vehicles were checked for their brakes and whether the vehicles are covered with public liability insurance. The law requires that they be covered.

But accident after accident occurs over the state and we find that the motor vehicle has been operating without the protection for others it is supposed to have. Drivers and owners seem to be little concerned about this state law.

And many never take the trouble to have their brakes and lights checked every 120 days despite the fact that the law requires this be done. There are places in the state where no warnings are issued regarding the checking of brake and light stickers and when the public never bothers about this law and when highway patrolmen make no check on the brakes and lights of motor vehicles.

Artesia and Eddy County have not been in this class but the operators of motor vehicles are operating on the same highways with others who haven't followed the law.

And since they do drive on the same highways then they are not being given the protection the law requires or the protection they have earned and deserve because they have followd the law.

The law requiring all motor vehicles to be covered with public liability insurance is a good law despite the fact that no method, way, or means for enforcing the law was established.

But it could be and it should be enforced. The state requires the owner of a motor vehicle to establish the fact that he or she owns the truck or car for which they apply for a license. #### Social Security **Is Often First Life Insurance**

"The fact is that eligibility provisions in the Social Security Act favor young people. Until a per-son is 24½ years old, earnings of as little at \$50 in as few as six different calendar quarters are sufficient credits in a Social Security account to give the equivalent of \$60 life insurance, minimum. The six calendar quarters do not need to be consecutive. And no matter

how young a person may be when the sixth quarter is earned, the insurance remains in force until attainment of 241/2 years of age, even if the boy or girl never does any more work in covered employment after the six necessary quarters are completed.

"The \$60 minimum insurance protection under Social Security is a small sum in terms of life insurance, but it is only a beginning and will increase to substantial amounts -in some cases as high as \$20,000 -as employment becomes regular

Any lessee or purchase contract holder desiring to apply for permission to change the use of water from certain State lands to other lands, including other State lands but not excluding privately owned lands; or to SECTION 8. Land Office on a form prescribed by the Commissioner of Public Lands, together with a \$5.00 fee, plus a sum of sufficient amount to cover the cost of publication of a Notice for three consecutive weeks in a newspaper of general circulation in the county where the land is situated. Before the approval of such application, however, a hearing shall be held before the Commissioner of Publice Lands on the date and at the time and place designated in the published notice. This Regulation is in addition to and supplemental of all rules and regulations imposed under the law by the State Engineer. (See Section 10 hereof)

Any person in interest aggrieved by the decision of the commissioner fixing such value may appeal as provided by law for appeals from other decisions of the commissioner. SECTION 9. Following is the Statute relative to the payment for improvements and water rights to the lessee by a purchaser of

State lands: (8-819, 1941 Compilation) "Whenever any lands are sold upon which there are improvements or appurtenant water rights be-longing to a lessee, the purchaser shall pay the appraised value of such improvements and water rights in addition to the price paid for the land. Before a deed or patent or contract is issued for such land, the purchaser shall file with the commissioner shall file with the commissioner a receipt showing that he has paid the owner the appraised value of such improvements and water rights, or deposit the same with the commissioner to be paid to such owner. The value of such

Washington (AFPS) - The United States is preparing for its biggest postwar test of defense against air attacks this September. with 26,000 civilian spotters scanning the sky for "enemy" bomb-

Under the code name, "Operation Lookout," the training exercise will be carried out in the New England States, New York, New Jersey, Pennslyvania and Delaware.


