#### **Planting Pine in Furre** THE STATE OF TEXAS. **County of Briscoe: Tested by Forest Service**

Successful methods for refore. ing by sowing pine seed in the fields, just like planting corn and other farm crops, may result from forest experiments now underway in southern Illinois.

The Carbondale office of the Central States forest experiment station, U.S. forest service, is testing several methods of establishing pine plantations of hilly old-fields. If successful methods of direct seeding are developed, they will be useful in southern Illinois as well as in similar areas of immediately adjacent states. Both hand and machine seeding methods are being tried in these studies. The hand method consists of digging up small spots in the field to be planted, using a mattock. Several pine seeds are sown in each spot. Results, to date, indicate that this method is more costly than planting nursery grown trees and that planting suc-

cess is uncertain. The machine seeding method being used looks very promising. In this method, furrows six to eight feet apart are plowed on the contour in the field to be planted. An ordinary horse or tractor drawn farm plow is satisfactory. The furrows are plowed shallow and are flat bottomed. The furrow slice is thrown downhill so that loose soil will not wash back into the furrow. Plowing is done in the fall and seeds are sown in the furrow in March with a common garden seeder.

In old fields having heavy broomsedge with grass and brush. machine seeding gave 800 to 1000 pine seedlings per acre when examined two seasons after sowing. #### **Fishing with Finishes**

Fishing equipment-from rubber waders to reels and from lines to ures- is given special finishing treatment to protect it and make it more attractive. These finishes have to be especially designed to meet a wide variety of conditions. The finish on the fishing rod, for instance, has to be very elastic so that it will not be affected by stresses and strains. It has, also, to resist temperature changes, fly oil, line grease and insect repellents. addition, it should not turn In white in salt or fresh water.

#### Two Important Vitamins

Vitamin B-1 and nicotinic acid are important vitamins, essential to health. The lack of vitamin Bl. also called Thiamin hydrochloride, causes the disease beri-beri, as well as some nervous disorders; while a deficiency of nicotinic acid results in pellagra. Though it can be prepared from nicotin by a chemical process, nicotinic acid and nicotin are entirely distinct chemical compounds, with very different properties. To avoid confusion with nicotin, which is very poisonous, nicotinic acid is now frequently called niacin.

#### **Meat Production Factors**

The relative economy of various meat animals depends on the quality, kind, labor, and value of the feeds, and other essentials required to produce a pound of dressed rcass. There are several main feed types with different costs. The proportion of cheaper feeds used greatly influences relative costs. Feed and labor are the main items in meat animal production.

Now the Firemen's leaders seek to paralyze railroad transportation to compel the railroads to employ a wholly unnecessary additional fireman to ride on diesel locomotives. This scheme is plain



LEADERS OF the Firemen's union have called a nationwide strike starting with four great railroads on April 26. These railroads are the New York Central, Pennsylvania, Santa Fe, and Southern.

The union claim that a second fireman is needed on grounds of safety is sheer hypocrisy. Safety has been dragged into this dispute only in an unsuccessful effort to give a cloak of respectability to vicious feather-bedding demands.

After a careful study of the first demands of this union, a Presidential Fact Finding Board on May 21, 1943, reported to President Roosevelt that there was no need for an extra fireman on diesel locomotives.

Again, on September 19, 1949, after a second hearing on the union leaders' demands, a second Board reported to President Truman that: "there presently exists no need for an additional fireman . . . upon either the ground of safety or that of efficiency and economy of operation."

#### Safety Record of Diesels is **Outstandingly** Good

Although the railroads accepted the Board , the union leaders have brazenly rejected them. They represent that an

extra fireman is needed for "safety" reasons. Here's what the Board had to say on that point:

> "The safety and on-time performance of diesel electric locomotives operated under current rules have been notably good . . .

> "Upon careful analysis of the data submitted on safety, we have concluded that no valid reasons have been shown as a support for the Brotherhood proposal under which a fireman would be required to be at all times continuously in the cab of road diesels. The proposal must be rejected."

The real reason behind these demands is that the union leaders are trying to make jobs where there is no work. In other words, a plain case of "feather-bedding." The railroads have no intention of yield-

ing to these wasteful make-work demands.

#### "The Safety Record of Diesels is Outstandingly Good ...."

The site had been occupied 900 years ago by the little-known Cohonina Indians, contemporaries of the cliff dwellers. Apparently the Cohoninas tried to copy the stone walls built by their more advanced neighbors. But before they reached. a height of four feet the walls fell flat in the faces of the imitators.

The cliff dwellers could have explained the failure as easily as did the archeologists centuries later. A wall of flat stones won't stand on a foundation of rounded boulders. The Cohoninas never tried to build with flat stone again, at least not at this site. They let the walls lay where they fell, but built other low walls, not more than three feet high, of rough stones.

The archeologists uncovered a dozen of these structures of one to four rooms. Two single - room houses had attached patios. Such house and patio construction is a new find in American archeology, Professor McGregor said.

But the find brings a host of questions. What was the advantage of going to the effort of fencing a patio with a wall only three feet high? Why would the Cohoninas have a house only three feet high, er build an energy - consuming three-Toot wall if they were going to top it with other construction

That the structures were houses is evidenced by the remains of roof beams found in them. It is from the growth rings of the wood in these beams that the archeologists date them as contemporary with the cliff dweller times.

"An editorial writer for a Maryland newspaper brought up just one of the problems. He said:

"'Let no amateur gardener suppose that this new Bermuda grass is going to be an unalloyed blessing. Another name for Bermuda is wire grass (devil grass in California) by which name it is a perennial weed which can be exterminated from flower beds and gardens only with the greatest difficulty. Once a garden is infested with wire grass, it stays that way. The more thoroughly its runners are subdivided, the worse it getsevery little snip promptly re-roots itself. What in this case may be a lawnkeeper's meat is most definitely liable to become a gardener's poison.'

The other grass is a selection of Bluegrass designated B-27, also Merion bluegrass, after the famous Philadelphia club where it was first observed. The earliest guess for seeed is two years and the quantity promised then is insignificant.

## **Conflagration Death Rate** Increases, Figures Show

Although the death rales from disease and most accidental causes have decreased in the United States during the past 38 years, the conflagration death rate has increased, according to life insurance statistics.

Automobile accidents is the only other type of accident to show an increase

Conflagration death rates were 50 per cent higher during the period from 1946-1948 than they were during the 1911-1915 period. Automobile accident death rates were 268 per cent higher, reflecting the increased use of autos.

On the other hand, the burns and scalds death rate has dropped 80 per cent in the same periods. This may have been due to elimination of the old coal and wood stoves in favor of gas and electric ranges, increasing use of electricity and increasing scope and effectiveness of safety education.

The great increase in the conflagration death rates occurred in the years 1941 to 1948.

"There is a delicate balance in nature between many forms of animal and plant life," Dunbar said, "and some of the man - made changes in the local environment have far-reaching and sometimes unforeseen consequences. . .

Blindness Among Children Although the number of children losing their sight because of venereal disease has been reduced by 50 per cent since 1936, V.D. is still an important cause of blindness among children, Dr. Franklin M. Dr. Foote reports that 10 per cent of the children entering schools for the blind in the U.S. today were made sightless by venereal infections. In 1936, 21 per cent of the children were V. D.-blindness cases.

Types of Heart Attack Heart attacks are of two general types. In the first type, coronary insufficiency, the coronary vessels are inadequate to meet the demands of heart muscle, says Dr. James A. "The term angina pectoris (pain in the chest) is retained for convenience and as a matter of cus-

tom," Dr. Brussel points out. "Angina pectoris indicates a short period in which the heart muscle is deprived of blood. Although angina may cause no permanent damage it should be re-garded as a potential harbinger of coronary disease.
