



Rome, June 27-The celebra tion of the Jubilee of Italian Unity with the exhibitions in Rome and in Turin, has emphasized the strangeness of the situation between Italy and Austria. Emperor Francis Joseph and the Government of the Dual Monarchy, alone of all the rulers and great powers, have sent no representa Ition to the Italian celebrations recalcitrant manner that Austria has participated in the International Exhibition of Fine Arts here while she was the only nation which did not take part in the Exhibition of Industries and Labor of Turin.

This is significant when one con siders that Vienna and Rone have been allied as members of of the tripple alliance for nearly thirty years. Nor can it be said that Austria's attitude is inspired of the Vatican, as Austria in 1870 was the first country to congratulate Italy over the fall of the Tem poral power and the relations between the Austrian Government and the Holy See have been, recently strained. The attitude of Austria is due to the ancient antagonism between the two countries, which is reaching a more accute stage now that the health of Emperor Francis Joseph is fail







The Country's Growing Interest in its New Navy by Lieutenant Tardy.

Special to Signal.

New York, June 28-From that day at Santiago when the Ameri can fleet destroyed the battleships of Spain, the nation has tak en a growing interest in its navy

"At the close of the Spanish was writes Lieutenant Commander. Walter B. Tardy, U. S. N., in the current issue of the Engineering magazine, "The press and the peo ple were satisfied with their navy. It has been successful and thus efficiency has been taken for granted. But when the stock was eventually taken the small per centage of hits made, became known and naval officers realized that somet-hing must be done to justify the public confidence."

The result of that realization is what Lieut. Tardy embodies in his paper on scientific management an defficiency in the United State navy.

"It is not uncommon to human experience" he observes, "for dif ferent experimenters working at similar problems independently to one ship, but after each ship and without any knowledge of hade developed her method of one another's efforts to arrive independently and simultaneously all the ships, by frequent conferat the same discoveries.

Something like this has happened in the case of the Navy and eiv-Il establishments for only since the technical and popular press took up the general discussion of scientific management have begun to realize that their management was of the kind now so strenuously advocated for industrial pursuits of all sorts."

This efficiency may be divided into three parts-efficency of the gun crew; efficiency of the fighting unit, or the ship, and the efficiency of the fighting division or the fleet. For it is with fighting ef ficiency that a fighting machine such as a navy is intended to be is first concerned. But the effort for efficiency has not been bound by

hits at ranges of ten thousand and physical yards, while steaming at fifteen knots, the target being only 60 feet long by 30 feet high. She fired forty eight twelve inch shells and her percentage of hits wasabout forty five. The rate of firing was about two shots per minute per gun. "Every officer in charge of any part of a ship's battery'' he writes, "was required to improvise the equipment and develop the best method of training withi nhis capacity. After each had formulated and tried out tentatively a drill, they came together,

We are forced to conclude therefore that he had reversed his judgment as to the land's being worth \$10.00 per acre in that the \$7.00 per acre offer was made to make the land "bring as much as possible." We desire to call your cur. attention further to the fact that the person who made the \$7.00 offer was endeavoring to get the commissioners court to do exactly what it did do, in so far as the principle and manner of the sa are concerned. That is to say that he wanted the court to sell him the land at a private sale at \$7.00 per acre, which is exactly what was done, except the sale was for about 45 cents less than he offered and to other parties than himself. He did not offer to change the contract when he endeavored to get the commissioners' court to back out of their contract already made and sell to him, but merely offered a small sum per acre more. Unless he criticise ! the court for an act which he him self endeavored to get it to de, he cannot consistently criticise either principle or manner of the sale. In other words, his consistent criticism is limited to the few cents difference in the valuation of the land as he and the court viewed it. The "Citizen and Taxpayer" error. payer also states in his article referred to that "said purchasers of said land are to have the right to transfer to Scurry County any paper that they may take in the sale of said land, said paper to contain a lien on said land and Scurry county is to release the present purchasers from all further liabilities on said land and take other vendees solely for their indebtedness." Realizing that it would be difficult for the county to sell its land to advantage, if the purchasers had to remain bound for a period of forty years on an obligation as large as this one, the courts of Texas have made legal that provision of the contract a bove quoted.
