





The shale formation at that depth encouraging and the promoters believe that the oil stratum has been almost reached. There are reasons to believe that when the sea level is reached the oil will be there. This will be at a depth of about 300 or 400 feet further.

An effort is being made to raise funds to drill five hundred feet further and more if necessary.

WISHERD AND BAKER

WERE CONVICTED

Defendants Were Charged With **Violating United States Bank**ing Laws

Abilene Reporter:

After a consideration of the case since 2:30 yesterday afternoon the jury in the case of the United States vs. John A. Wisherd and T. F. Baker charged with violating the United States Banking laws returned a verdict this morning at 9:11 declaring defendants Wisherd and Baker guilty on counts one and four and Baker not guilty on c ount three

Meek in most solemn tones then passed sentence upon the defendants giving each five years in the Leavenworth penitentiary. With flushed faces the defendants stood throughout this ordeal, each visibly affected but bravely resisting the shedding of tears or showing deep emotion.

Judge Meek did not lecture or rebuke the prisoners at the bar, but let them down as lightly as possible under the circumstances.

History of the Case:

John A. Wisherd in the year of 1907 owned the Two Circle Bar ranches consisting of 100,000 acres of land in Kent county and eight thousand head of cattle and in the Spring of that year borrowed \$57, 000 from the First National Bank of Snyder, with which it was alleged and proven he bought additional lands within his pastures and Mr. Baker was Cashier of said bank and made the loans.

Mr. Wisherd's name appeared on some of these notes alone and on others with employes of his and there were many and various notes showing loans at different times. The panic of 1907 came and defendant Wisherd paid \$15,000 of the indebtedness and renewed for the balance, giving a mortgage on the lands he had bought with the money borrowed to secure the payment of the balance due. This mortgage covered twenty sections of land.

Both Baker and Wisherd were indicted in 1908 and in 1909 the Snyder bank foreclosed on the twenty sections of land and secured its money therefrom. The trial came on in the Federal Court here and resulted in ahung jury or mistrial.

Mr. Baker was Assistant Cashier and Cashier of the First National Bank of Snyder for four years and the bank loaned from \$150,000 to \$250,000 and it was proven that in all that time the bank had not lost a dollar of money loaned by him. Wisherd is it is estimated at pres ent worth over a million dollars and is alleged and proven that at the


