Much Needed Rains Cause Power Failure

During the past week, the citizens of Baird have suffered some inconvenience due to West Texas weather. Thursday night, Baird received high winds which blew tree limbs into the power lines along 6th and Race streets. Most of the lines were repaired Thursday night, the remaining lines were repaired by 6 a.m. Friday morning. Plans are being made to trim tree limbs from all power lines.

At sometime between 12 a.m. Saturday night and 7 a.m. Sunday morning, the town had a power failure which lasted approximately 1 hour, before the power could be restored. Another power failure Sunday afternoon, which lasted less than 15 minutes, also affected one of the television station in Abilene as well as

Heavy rains hit Baird over the week end. It rained nearly all of Friday night with intermittent heavy showers during the remainder of the weekend. As much as two inches fell during the storm with as much as 3.2 inches being registered in some areas of town.

Commissioners To Decide Leasing Of Hospital June 30

At 9:12 a.m. Friday, June 20, the county commissioners received 2 proposals for the lease of the Callahan General Hospital. The hearing was opened by Judge Mack Kniffen in the commissioners court room. There were 18 persons present for the hearing of the proposals.

The first proposal was presented by the United Hospital Corporation out of Memphis, Tenn. They are a hospital management company and own a few hospitals. They are a small, privately owned company. They own one hospital in Goldwaithe and are presently working on negotiations for another in Lam Pasas and possible management services in San Saba, Gorman and other surrounding areas.

Jim Henson and Jim Provensal were the mediators for the Tennessee company. Their proposal was to lease the hospital for 5 years at a charge of \$1,000.00 per month. They wish to purchase the present inventory from whoever owns them for cash. They intend to continue all leases on the current equipment such as the X-ray equipment which is now rented at a price of \$700.00 a month. They will bring in their own administrator and will do most of their purchasing from their own company. They're intention is to project a new system by new methods. They will continue to employ townspeople and will care for indigent patients, though they wish to do this through social services and medicaid. They feel that they can save money through centralization of purchasing, computerization and over all better management through administraMr. Henson suggested that they would wish to deal directly with a hospital committee and suggested that the committee place \$300.00 a month in a escrow fund for equipment. The equipment bought with the escrow money would belong to the county. Anything under \$300.00 they would purchase themselves. They also mentioned changing the decor of the hosital which would be their responsibility.

Dr. Gayao begin his proposal by saying that he realized that the hospital still had problems. He reminded the commissioners that he wasn't in management and that he was only a physician, but he was learning the ropes. He stated that the hospital presently has department heads which allows for imput from each area of the hospital. James Paul Shanks, Dr. Gayao's spokesman stated that they wished to continue the current operation with a lease agreement for 5 years at \$200.00 a month. Dr. Gayao also stated that indigent patients will be accepted and although he, himself was not satisfied with the hospital's presnet situation, the commissioners's must have noted the considerable changes and improvements that have been made in the past 5 years in which the hospital has been leased to Dr. Gayao.

After questions were asked of both parties, Judge Kniffen recessed the-

parties, Judge Kniffen recessed the meeting until Monday, June 30 at 9:30 a.m. in order to discuss both proposals with the county attorney who was unable to attend the meeting.

Baird ASCS Director Named

A new acting director of the Callahan County Agricultural Stabilization and Conservation Service (ASCS) assumed his duties Monday.

Cecil Barton, a county office specialist with the state ASCS office in College Station, wass in the Baird office Monday. Before moving to the state office, Barton was executive director of the Austin County ASCS office for many years.

Barton replaces Roy Dycus who has been acting director for more than a year following the suspension of director J.C. Earp. Dycus is taking mediacl leave.

Barton will serve as acting director for an indefinite period. Earp and three county committeemen who also were suspended last year by the state ASCS committee have appealed their suspensions to the Washington office of ASCS. The Washington office has not yet made a ruling.

Barton also will serve in the capacity of the county committee until the appeals are final.

Final Decision On Landfill Proposal To Be Made July 14

The City Council met in a regular meeting Monday, June 23, 1980 at 7 p.m.

The minutes were read and approved.

The first proposal of the meeting was about the Baird landfill. Mayor A.N.

Johnson of Clyde accepted a proposal from the Baird City Council to share the landfill with Clyde for \$1,285.00 a month for a 1 year contract to begin hopefully July 1. Mayor Brame wanted to read final contract before the final decision was made. The final decision will be made July 14 giving the city attorney time to go over the contract.

The second order of business was to reexecute an agreement with Continental Telephone. The ordinance passed. The ordinance granted a franchise to the telephone company to do business in Baird.

A 25 years extension was asked for. The telephone company must pay 2% of their gross revenue to Baird. It is actually a street and alley rental fee. The question was brought up about the length of the franchise. A motion was made to accept the proposal but to shorten the time to five years.

The problems of a citizens who is physically and resourcefully unable to pay utilities was discussed. The welfare department has been paying but they say they no longer can. The city does have a policy in which the bill must be paid by the last day of the month or power is refused. Three citizens and i business outstanding bills were discussed.

The meeting was then adjourned.
