

FORTY-SEVEN YEARS AGO . .

Scurry County has a newspaper birthday this week. It was exactly forty-seven years ago that the first publication of any kind was issued from a printing plant in this county.

These forty-seven years have been crowded with all the triumphs and defeats that crowd onto the trail of a pioneer country. There have been a multitude of newspaper publishers, and several newspapers-weekly, semi-weekly and even daily. Fortunately for the community, most of the publishers have been forward-looking men Most of them left milestones of progress that helped to lead the county toward her present enviable place in the West Texas sun.

The physical assets of The Scurry County Times, the newspaper which has grown out of numerous trades, consolidations and a failure or two, are surpassed by few weekly plants in the state. Today's publishers pay tribute to those who have gone before when they say that the county's newspapers, in this respect, have always remained a step or two ahead of general Scurry progress.

In prestige, too, Snyder papers have, as a rule, held their heads above their neighbors. In celebrating the forty-seventn anniversary of publishing in the county, today's publishers leave it to Times readers, composing at least 75 per cent of the county's population, to determine whether the new Times is following in the footsteps of its foreparents.

Certain it is that The Times of 1935 enjoys far greater support than it deserves from Snyder and Scurry County. With generous readers and the inspiration of newspapers that have been published here these forty and seven years, the publishers of 1935 pledge themselves to do their dead-level best during the next 47 years!

Times readers are being transported this week from the customary Weekly Dozen to a dozen or more remarks from a recent copy of the Congressional Record. The remarks were made during the course of a speech by Senator Tom Connally in which the constitutionality of the proposed federal anti-lynching law was questioned.

Here we have not only an example of the keen insight of the junior senator from Texas, but a striking bit of repartee that is an oasis in a usually dry Congressional Record. Read it and enjoy life:

Mr. Connally-"The senator from Missouri, by his statements now, increases the high estimate which I placed upon his art and skill a little while ago. A few moments ago the senator from Missouri was lamenting the fact that in the consideration of the Bankhead Bill and other measures senators had not gone back and consulted and pondered over and deliberated upon the Constitution of the United States.'

Mr. Clark-"No. Mr. President, if the senator will yield; what I was expressing was amazement at the fact that the first time in months we have heard of our old friend, the Constitution, from the senator from Texas and from other senators in this body is when an anti-lynching bill is brought into the chamber."

Mr. Connally-"Oh, well, the senator from Missouri in one breath complains that he has not'been hearing the Constitution discussed and now he complains that it is being discussed at all. That is the implication from the senator's remarks. He asks, "Why have we not before heard of the Constitution?"

Mr. Clark-"Well, why have we not?"

Mr. Connally-"I am going to tell the senator. It is because the senator and others like him have been so concerned with passing measures of a temporary and emergent character that they have probably not been concerned with a discussion of the Constitution. Shall we swat the big boys just because they are big boys?

Some recent proposals at Washington seem to say 'Yes" to such a question, for the trend is unquestionably toward the throttling of many institutions that are the foundation upon which America has built her industrial empire,

Just now the leading "swat" talk is apparently directed toward the holding companies of some of our leading industries, particularly the utilities. The Times does not pretend to know the precise function of a large holding company. But we do know that a concern such as the Texas Electric Service Company, if it wishes to make an expansion, can go with proper collateral to a holding company and get a loan of giant proportions.

In like manner, as we understand it, any reader of The Times whose reputation, character and collateral are of the first water can go to his bank and secure a loan for an expansion of his business-farming, ranching or merchandising.

Why, we ask, should large holding companies be neezed as Washington is proposing to squeeze them, unless it can be definitely proven that they are economic vultures? In the same tenor, we ask why your bank-your holding company-should be squeezed out of existence, unless it is guilty of some major infraction of law or judgment?

The Times repeats a statement it has made often: That public utilities should receive the same consideration from the government and from the public as the groceryman or the dry goods man receives.
