## SOIL BUILDING WORK ON FARM SETS PAYMENT

County Agent Advises That Sooner Farmers Complete Conservation Work Checks Start Out

Of vital interest to Scurry County farmers this week was an announcement by the county agent's office that the sooner a farmer completes his soil building work under the Triple A program, the sooner he will receive his agricultural conservation payment.

Plans are now complete at the county agent's office, as they are in other West Texas counties, to accept applications for conservation payments in September from those cooperators who have earned their maximum soil building and range improvement allowances, according to X. B. Cox Jr., county agent.

Completion of enough soil building work to earn the maximum allowance before the close of the program will thus enable the cooperator to receive his conservation payment earlier than those who fall short on their improvement work.

"Present indications are that payments will begin about a month earlier this year than last," Cox said. "Many farmers and ranchers have already exceeded requirements for earning their full allowance, and so will be able to get their payments as soon as the necessary forms and instructions are available to county agents over the state."

Attaches of the state Triple A office at College Station report the "earlier payment for earlier work" was first used last year in order to eliminate a pile-up of applications in the offices, and to encourage greater use of funds allowed for improving the soil and controlling erosion.

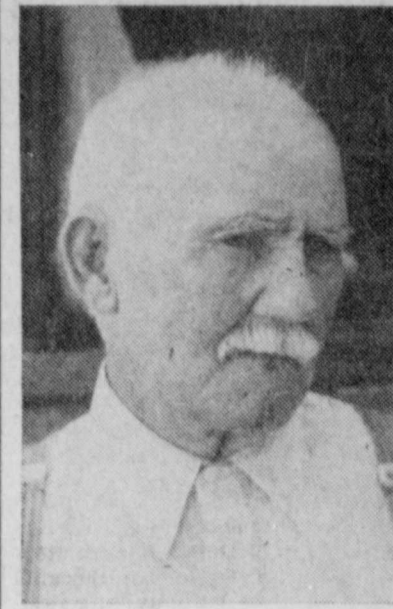

**MATTRESSES IN COUNTY TOTAL 183 UNDER AID**

**Demonstration Work Continues with Opening of Work Center at Hermleigh This Morning**

Reporting on the excellent progress made in cotton mattress construction at county work centers, Estella Rabel, county home demonstration agent, stated Tuesday that 183 mattresses had been made through Tuesday at Scurry County's five work centers.

Number of mattresses made at each of the county's work places follow:

Strayhorn, 40; Union, 51; Fluvanna, 23; Dunn, 24; and Snyder, 13.

All mattresses that are due county residents have not been made at the various work centers, including Snyder, Miss Rabel reports, due to a shortage of available cotton.

Work at the Hermleigh mattress center got underway this (Thursday) morning, with 53 cotton mattresses scheduled to be made at this place.

"We should like to point out that the making of bed equipment at our county work centers is not in competition with mattress factories," the home demonstration agent added.

"This work is being done simply to give the rural people of Scurry County who haven't made as much as \$400 the past year a chance to secure better bedding."

Work done on the mattresses at the respective community focal points is under the supervision of Miss Rabel as local extension service director, and home demonstration club leaders in the various communities.

Care of the mattresses being made is taught by an exhibit of a spring cover, a mattress pad and a mattress cover on display at the work centers.

The mattresses made, Miss Rabel reports, are to be sunned and beaten two weeks before they are used, then sunned and beaten once a week after being placed in useage.

Those who have signed mattress application blanks, and are eligible for the new mattresses, will be notified just as soon as more cotton arrives, the home demonstration office reports.

**TALK OF PLAN FOR GREATER SHOW IN 1941**

**Success of Affair Last Week-End Proves Need of Extensive Expansion Program**

Milking of the last wild cow Sunday morning at 2:30 o'clock brought to a close Scurry County's Fourth Annual Rodeo, and by far the most successful rodeo yet staged at tree-shaded Wolf Park.

Saturday night's final performance was witnessed by 4,000 widely cheering rodeo fans, who gathered here from all parts of West Texas and points as far east as Dallas and Fort Worth, and as far west as Prescott, Arizona, and Redlands, California.

Smashing success of the county's Fourth Annual Boots-and-Saddle Roundup, at which over \$1,100 in cash prizes were awarded, caused J. J. Koonsman, president of the Scurry County Rodeo Association, to say this week that the rodeo grounds, chutes, arena and seating facilities will have to be greatly enlarged before the 1941 rodeo is staged here.

Opal Etheredge, 18-year-old Hermleigh girl, was presented with a \$15 Navajo Indian blanket Saturday evening for winning first place in the senior sponsors' contest, and Faye Mathis of Fluvanna a \$10 Navajo Indian blanket for placing second. In the junior sponsors' contest, Dorothy Riley of Martin was awarded a \$5 cash prize for placing first and LaNell Berryhill of Turner \$3 for winning second place.

Sidlight feature of the Fourth Annual Rodeo performances was the exhibition of the prize Palomino mare, Rio Rita, by Levi Garrett of Sterling City.

Rio Rita, owned by W. A. Johnson of Fort Worth, president of Johnson Motor Lines, staged a show all her own with the camel stretch, saying her prayers, bringing mail from the mail box, acting a cowhand after a bronc threw him and twirling the rope. J. R. Reeves, local Johnson Motor Lines manager, was responsible for obtaining the educated horse for the rodeo performance.

Winners in the commercial float contest, staged Friday and Saturday afternoon in conjunction with the grand parade, were:

Servel Electrolux float, arranged by C. A. Seal, first prize of \$5; Perry Brothers, second prize of \$5; and the NYA work shop float, third prize of \$5.

In the children's float division, I. H. Spikes, with his re-creation of a covered wagon, copped first money of \$5. Wanda Mills and Leslie Thompson placed second, with \$3 given for their decorated bicycle built for two.

Final rodeo results follow:  
Huston Burns, best two-day average on calf roping, \$25; Johnny Stovall of Fluvanna, \$25 first money for best two-day average, steer riding; C. Honeycutt, second place money of \$15;

Otto Jones of the Spade Ranch, south of Colorado City, first place in cutting horse contest, Saturday afternoon; Clyde Miller, second; and Jesse Koonsman, third.

Friday afternoon's cutting horse contest resulted in Tom Garner, Clyde Miller and Jesse Koonsman tying for first place, an incident rather unusual in county rodeo history.

A striking spirit of cooperation was shown Friday and Saturday afternoons in the grand parades, staged just prior to the afternoon rodeo performances. The parade each day, over a mile long, attracted an unusually large number of floats, rodeo contestants and community sponsors.

Snyder's Tiger Band, ably directed by Bandmaster Herman Trigs, not only took a prominent part in the Friday and Saturday parades, but also played for afternoon rodeo performances. Bobby Jo Hays is drum major.

Sound equipment for the four rodeo performances was furnished by Gulf Oil Corporation of Houston through the courtesy of E. F. Sears, local Gulf dealer.

The man responsible for the excellent broadcasting of rodeo contestants, events, and announcements of interest to the spectators was R. C. Dillard, manager of the Scurry County Chamber of Commerce.

J. J. Koonsman, president of the Scurry County Rodeo Association, was introduced just before each performance, as was J. C. Dorward, vice president, and Allen Stephens, arena director.

Other officials who were given an introduction, amid hearty applause, before rodeo performances included Judges Jim York, Gaston Brock and Dud Arnett. Official timekeepers were John Cox and Jim York.

Flag bearers were Joe Parks and Norris Rodgers, while Weldon Johnson and Jesse Koonsman acted as pick-up men at all performances.

A wild Brahma steer gave 3,600 spectators Saturday afternoon an added thrill when he attacked a state highway patrolman and then took after the rider he had tossed overboard.

The highway patrolman, B. L. Woodell of Lubbock, escaped without serious injury after the Brahma's horns struck him just under the arms. The rider, C. D. Ferguson of Tyler lost four teeth when the steer ran him down.

Rodeo attendants, from the people who gathered at Wolf Park from this immediate vicinity, to those who came here from eastern New Mexico and Prescott, Arizona, were unanimous in saying this year's rodeo was the "biggest county rodeo staged in any part of West Texas."

**Deadline for Wheat Insurance August 31**

Claude D. Cotten, administrative assistant at the county agent's office, announced this week that all-risk federal crop insurance applications on the 1941 wheat crop will be accepted through Saturday, August 31.

"We want to encourage county grain producers," Cotten said, "who want to be assured of an income from next year's grain crop to take advantage of wheat crop insurance before the deadline passes."

"We have been informed that the state Triple A office has instructions to close down all wheat crop loan applications the last of August, and once the deadline is set we are aware of the fact such a time limit will be final. Applications already received indicate many wheat producers are going to be assured of an income from their 1941 grain crop, even though it may be ravaged by insects, disease, hail or drought."

## CONSTITUTIONAL AMENDMENTS

### H. J. R. No. 45—A JOINT RESOLUTION

proposing an Amendment to Article 8, Section 9, of the Constitution of the State of Texas adding a new Section thereto to be known as Section 9-A; providing that the Commissioners Court of Red River County, after a vote of the qualified electors owning taxable property therein, shall have the authority to levy a tax not to exceed twenty-five (25) Cents on the one hundred dollar valuation for a period not exceeding fifteen (15) years for the purpose of refunding the outstanding warrant indebtedness of the General Fund of the County by the issuance of bonds under the provisions of the general law regulating the refunding of outstanding debts of the County; providing for the necessary proclamation; and appropriating funds to defray the expenses of the proclamation, publication, and election.

Be it resolved by the Legislature of the State of Texas:

Section 1.—That Article 8, Section 9, of the Constitution of the State of Texas, be amended by adding thereto another Section to be known as Section 9-A, which shall read as follows:

Section 9-A.—Upon the vote of a majority of the resident qualified electors owning taxable property therein so authorizing, the Commissioners Court of Red River County, Texas, may levy an annual tax not to exceed Twenty-five (25) Cents on the one hundred dollars valuation for a period not to exceed fifteen (15) years for the purpose of refunding all the outstanding warrant indebtedness of the General Fund of such County and issue bonds under the provisions of the general law regulating the issuance of bonds to refund said indebtedness.

"At such election, the Commissioners Court shall submit for adoption the proposition whether such outstanding warrant indebtedness of the General Fund of such County shall be refunded into bonds, the amount of special tax to be levied, and the number of years said tax is to be levied. The funds raised by such taxes shall not be used for purposes other than those specified in the plan submitted to the voters.

"The provisions of this Section 9-A shall apply only to Red River County; and the provisions hereof shall be self-enacting without the necessity of an enabling act of the Legislature of the State of Texas, but shall become effective immediately after the official canvass of the result has been made and it is determined that this Amendment has been adopted by a majority of the voters of the State."

Section 2.—The foregoing Amendment to the Constitution of the State of Texas shall be submitted to the qualified voters of the State on the first Tuesday following the first Monday in November, 1940, at which election all voters favoring such proposed Amendment shall write or have printed on their ballots the words:

"For the Amendment to the Constitution providing that the Commissioners Court of Red River County may, upon a vote of the qualified electors therein, levy a tax and issue bonds to refund the outstanding warrant indebtedness of the General Fund of such County."

Section 4.—The sum of Five Thousand Dollars (\$5,000), or so much thereof as may be necessary, is hereby appropriated out of any funds in the Treasury of the State of Texas not otherwise appropriated, to pay the expenses of such publication and election, which shall be refunded the State of Texas by Red River County out of its General Fund or any other available fund. Provided that no election shall be held until Red River County shall first deposit with the State Treasurer the

### sum of Five Thousand Dollars (\$5,000) with which to pay such expense of said election. 9-1c

### S. J. R. No. 4—A Joint Resolution

proposing an amendment to Article IV of the Constitution of the State of Texas giving the Legislature authority to provide for appeal direct to the Supreme Court in cases involving injunctions granted or denied on the grounds of constitutionality or unconstitutionality of any statute or on validity or invalidity of administrative orders; providing for the submission of this amendment to the voters of this State; and providing for the necessary proclamation and expenses of publication.

Be it resolved by the Legislature of the State of Texas:
