## Seeking God After The Due Order

One of the most forceful lessons in all of God's word is that men must not only seek God, but they must seek Him after the due order. David learned this lesson the hard way as he, ignoring the instruction of God, met with disastrous defeat. He ascribed that defeat in I Chron. 15:13 as coming by reason of having not "sought Him (God) after the due order." The principle of seeking God after the due order (doing what God has commanded in the way He commanded) is one that the Lord has insisted upon from the beginning of time.

Because he did not observe the due order, the sacrifice of Cain was rejected (Gen. 4:3-7); Because he did not observe the due order, Saul was rejected as king (I Sam. 15:26); Because they failed to seek God after the due order, Nadab and Abihu were consumed with fire (Lev. 10:1-2).

Jesus warns us to seek God after the due order with the words 'Not everyone that saith unto me, Lord, Lord, shall enter into the kingdom of Heaven, but he that doeth the will of my Father who is in Heaven" (Matt. 7:21-23). Again, Jesus inquired in Lk. 6:46 "Why call ye me Lord, Lord, and do not the things which I say. "Many of our friends are falling into the same snare today, as those previously mentioned, because they disregard God's due order for becoming a child of God. They pray for pardon (yet without obedience), get religion, tell their experiences, vote on candidates, and are baptized without knowing what they are baptized for.

Dear friends, this is not seeking God after the due order. The due order for the alien sinner in seeking the forgiveness of sins is to hear the Gospel Acts 15:7); believe the Gospel (Jn. 8:24); repent of sins (Acts 17:30); confess Christ (Acts 8:37); and be baptized for the remission of sins (Acts 2:38). Every case of conversion in the book of Acts followed this course. This is the due order and for one to seek God in some other way is to meet with disastrous defeat and to fail at the judgment.
