Beef cattle producers in Sisher County now have an opportunity to participate in a new service that will enable them to obtain important value determining characteristics of the carcasses their cattle produce. The program is called the

Beef Carcass Data Service and is a joint effort of the U.S.Department of Agriculture and the Texas Agriculture Extension Service.

The service involves the use of specially designed eartags which the producer applies to those cattle on which he wants to obtain carcass information. When eartagged cattle are slaughtered, a meat inspector will remove the tag and attach it to the carcass. Then the USDA meat grader assigned to the slaughter plant will evaluate and record the quality and yield grade factors. This information will be sent to the Agricultural Marketing Ser-

vice's Carcass Data Center in Washington, D. C. Once the data is processed and returned to the producer or eartag owner, he will be billed at \$1.50 per head.

Eartags for the new service, at \$. 50 each plus \$. 75 for the tool to attach the tag, may be ordered from Dr. Frank Orts, Extension meats specialist at Texas A&M University. His address is Room 322, Animal Industries Bldg., College Station,

The guide contains a new section on investment credit which explains what property qualifies, the amount of credit available, limitations, and how to complete credit on used property and recapture informa-

The guide also has a chapter on credit for gasoline and fuels used on a farm for farming purposes. Another chapter deals with self-employemnt taxes for Social Security. It explains what income is and is not taxable for Social Security.

The tax guide is indexed so producers can easily find information on specific subjects as selling a farm, sale of breeding animals, depreciation, involuntary conversion and other topics.


Whether you have your return filed by a tax practitioner or do it yourself, the new publication will be useful.

The farmer of 1980 will have to be a businessman just as much as an agriculturalist.

He also will need an operation physically large enough to supply his family an adequate standard of living and still be able to generate enough capital to keep expanding. This means he likely will have to generate minimum farm sales of over \$40,000 annually, which will require that he have control over farm assets (land, equipment) totalling over \$250, 000. to \$300, 000.

And since profit margins have declined for most farm production, there will be greater stress on business and financial manaement skills.

Generating both equity and debt capital, or risk and borrowed capital, will be one of the main concerns of the future this program can provide imfarmer. The large investments plus the need to keep competitive by utilizing new and unusually expensive technological advances are causing capital to be very important.

He also will have to exercise budget and cost controls of his business. Skills in building sound credit, and then merchandising it, are also needed.

The greatest payoff in the future are likely to come from the effort devoted to improving farmers' skills in business and financial management.


