WTU to Make Study of Solar Energy

The possibility of using solar energy to generate electricity at one or more of West Texas Utilities Company's power plants will be examined in a study . being conducted by the company's Plant Operation Department in cooperation with the Energy Systems Group of Rockwell International.

The study will take nine months and will be completed in June or July, 1980.

Targeted for the study is Unit Number Four at WTU's Paint Creek Power Station, which is located on Lake Stamford, between Haskell and Stamford. The unit was completed in 1971 and is the largest and newest of Paint Creek's four generating units. All are presently powered by natural gas, with oil used as a backup fuel.

If results of the study are favorable, a proposal will be submitted to the Department of Energy for a grant to aid in constructing the equipment needed to repower the unit with solar energy. WTU officials, however, emphasized that the program in its current stage is strictly a

research project.

"At best, the project is several steps away from becoming a reality", said Randal Meador, WTU vice president and director of engineering.

Meador said six similar studies are being made with United States Department of Energy funding and support, and that only two projects will be granted funds to aid in construction. The cost of constructing the two projects will be shared by DOE and the winning utilities.

By funding these demonstration plants, the DOE hopes to lower the cost of the solar equipment by mass production to make solar electric generation economically feasible in the near future. The selection of the projects to be granted construction funds will be based on the percentage of the cost to be shared by the utility and the engineering quality of the repowering system.

ALL ALIENS MUST REGISTER IN JAN.

According to Richard M. Casillas, district director of the San Antonio Immigration and Naturalization Service office, the information furnished by aliens in reporting their addresses has been declared confidential by statute.

These reports must be submitted during January each year by all aliens in the United States, with few exceptions. Forms on which to submit the reports are available at any post office or office of the Immigration and Naturalization Service. Persons who are unable to pick up a form because of illness, or other reasons, may have a relative or friend obtain a card for them. The card should have a 15¢ postage stamp affixed and mailed. Parents or guardians of aliens under 14 years of age submit reports for such child-







COLLEGE STATION -While most people worry about the once-a-year income tax filing deadline, a Texas A&M University accounting professor reminds that Internal Revenue Service auditing is a year-round


In addition to reiterating that honesty is the best policy, Dr. Larry Crumbley has two suggestions for anyone about to be audited: Never send or give original records to the IRS, and if a special agent is conducting the audit, get a lawyer.

Crumbley advised making copies of records and giving them to the agent or the IRS. "If you give the original documentation, there is the risk of the agent losing it," he says.
