Steers Pull Off Last Minute Victory Over Sands in 1980 Season Opener

The Robert Lee Steers pulled their season opener out of the fire Friday night with less than two minutes left in the contest. An eight yard run by Quarterback Buck Duncan broke the 6-6 tie the Steers had with the Sands Mustangs and gave them a 12-6 win.

Starting off their 1980 season at Sands, the Steers were unable to light up the scoreboard during the first half. But neither were their host opponents, as the first half ended in a scoreless tie.

After working their way up to the 1 yard line in the third quarter the Steers gave the ball to Joel Percifull who carried it across for the first Steer counter.

The Mustangs' Shayne Wigginton made the only Sands' counter of the night when he went ac-

ross from the 3. The heaviest rainfall in years fell over Coke County the first of this week, breaking a drought that has been a serious problem to farmers and ranchmen as well as city folks, most of this summer.

A lot of damage was done to terraces, tanks and other structures, but most everybody seemed to believe the benefit of the rains will far outweigh the damage.

Robert Lee was short on water Tuesday due to a line break below Mountain Creek Dam, but it has been repaired and water service was back to normal by late Tuesday afternoon.

It was reported to the Observer that water backed up into some residences and business buildings, but no great amount of damage was reported.

Heaviest rainfall was reported by Bob Cox who lives northeast of Robert Lee. He received a good rain at his place Sunday night when most places in the county got only a shower. He is reported to have said he must have re-

ceived 18-20 inches altogether, and that he "had never seen Mountain Creek that big before."

Official measurement by J.E. Quisenberry for Robert Lee was 5.33 inches. Other places in town measured up to 7 inches.

Lake Spence picked up 6 feet of new water by Wednesday morning and engineers at the lake were expecting it to rise about 4 more feet. Mountain Creek Lake was running over all day Tuesday and the golf course in the nearby area was inundated.

Some measurements reported to the Observer were:

J.W. Service, north of town, 6 inches; David Key, southwest, 7 to 8 inches; Finis Harmon, Edith, 5 to 6 inches; Binks McCutchen, east, 6.5 inches; Bobby Roberts, south, 3 to 4 inches.

The Silver area got 8 to 9 inches, and the Colorado Tiver crested there Wednesday morning at 17 feet. The Observer was unable to contact anyone at Sanco, due to phones being out of order.

City officials were unhappy with the damage to the water system, but were pleased because Mountain Creek Lake had "all the water it will hold in it."

Bronte had measurements up to 5 inches and Oak Creek Lake was up 10.56 feet.

Music will be by Night Fever. Admission prices are \$3.00 for singles and \$5.00 for couples.

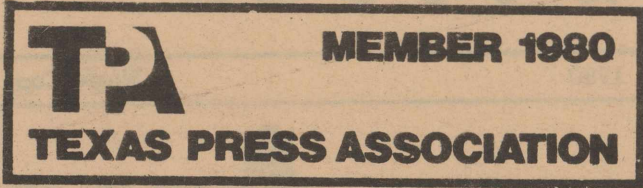

A spokesman for the EMS reminded the citizens of this area of the EMT (Emergency Medical Technician) course planned to begin in January 1981. Satisfactory completion of an ECA course or similar training (such as LVN or RN) will be required for all students enrolling in the EMT course. Persons enrolling must be at least 18 years of age.

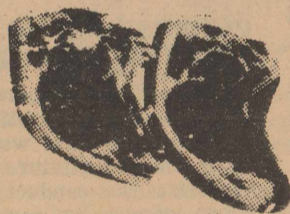

CF Chairman Asks for Help

Every day five new lives begin with Cystic Fibrosis. Every day three lives are lost because of this tragic disease.

These are grim facts, but CF is a grim disease, causing complications mainly in the lungs and digestive system. CF causes the body to produce a glue-like mucus which fills the lungs, creating an environment ideal for lung-damaging infections. One of more than 100 CF Foundation Chapters in the United States, the Lone Star Chapter is holding its annual Breath of Life Campaign in Robert Lee, during National Cystic Fibrosis Week, Sept. 21-27. Mrs. Aldridge urges everyone to support this campaign because, "Each contribution helps to find a cure... to buy time before it is too late."

PUBLIC NOTICE

BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS GENERAL ELECTION NOVEMBER 4, 1980

PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 35 proposes a constitutional amendment that would authorize the Legislature to permit banks to establish and operate unmanned teller machines within the county or city where the banks are located and to share the use of teller machines on a basis consistent with anti-trust laws, if it finds such operation will serve the convenience of the public. The Legislature has already passed enabling legislation (H.B. 1510) for this proposed amendment.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment permitting the legislature to authorize banks to use unmanned teller machines within the county or the city of their domicile on a shared basis to serve the public convenience."

PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 97 proposes a constitutional amendment that would grant the State and the accused the right to an interlocutory appeal from the following trial court rulings in criminal cases: pretrial rulings on the constitutionality of a statute; on a motion to quash, dismiss, or set aside an indictment; and on a motion to suppress evidence.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing appeal of certain pretrial rulings of a trial court in a criminal case by either the state or the accused."

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 98 proposes a constitutional amendment that would require a single appraisal of all property subject to ad valorem taxation and would provide for a single board of equalization within each county. The con-

stitutional requirement that the county commissioners court sit as a board of equalization would be eliminated, and elected officials of the county or governing body of the taxing unit would be prohibited from serving as members of the board of equalization.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment requiring a single appraisal and a single board of equalization within each county for ad valorem tax purposes."

PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 18 proposes a constitutional amendment that would allow the Legislature to authorize the conduct of bingo games by certain specified groups for charitable purposes, subject to the limitations that operation of the games must be approved in local option elections and that all proceeds must be spent in Texas.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize bingo games on a local option election basis if the games are conducted by a church, synagogue, religious society, volunteer fire department, nonprofit veterans organization, fraternal organization, or nonprofit organization supporting medical research or treatment programs and if the proceeds are to be spent in Texas for charitable purposes of the organizations."

PROPOSITION NO. 5 ON THE BALLOT

House Joint Resolution 86 proposes a constitutional amendment that would allow the Legislature to authorize the Governor to exercise fiscal control over the expenditure of certain appropriated funds, subject to any conditions and limitations provided by law and subject to the ap-

proval of a budget execution committee that would be composed of the Governor, Lieutenant Governor, Speaker of the House of Representatives, Chairman and Vice-chairman of the Senate Finance Committee, and Chairman and Vice-chairman of the Committee on Appropriations of the House of Representatives.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to grant the governor power to exercise fiscal control over the expenditure of appropriated funds as provided by law."

PROPOSITION NO. 6 ON THE BALLOT

Senate Joint Resolution 8 proposes a constitutional amendment that would allow the Governor who appointed a previously confirmed official to remove that official from office subject to the advice and consent of the Senate; and if the Legislature is not in session, to call a special session of the Senate which may last no longer than 2 days for consideration of the removal.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the governor to remove appointed officers with the advice and consent of the senate."

PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 121 proposes a constitutional amendment that would authorize counties with a population of 5000 or less to construct and maintain private roads if they impose a reasonable charge for the work. The Legislature by general law may limit this authority. Revenue received from private road work may be used only for the construction, including right-of-way acquisition, or maintenance of public roads.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing counties with a population of 5000 or less to perform private road work."

PROPOSITION NO. 8 ON THE BALLOT

Senate Joint Resolution 36 proposes a constitution-

al amendment that would change the jurisdiction and authority of the State's appellate courts. The amendment would change the name of the Courts of Civil Appeals to Courts of Appeal and provide that these courts have intermediate appellate jurisdiction over both criminal and civil cases. The amendment would change titles for the Associate Justices of the Supreme Court to Justices and would require members of the Supreme Court to be attorneys licensed in this state while holding office.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to change the name of the Courts of Civil Appeals and the names and qualifications of the justices of the Supreme Court and to prescribe the jurisdiction and authority of the appellate courts."

PROPOSITION NO. 9 ON THE BALLOT

House Joint Resolution 54 proposes a constitutional amendment which defines separate property owned by either spouse as all property, both real and personal, of a spouse owned or claimed before marriage, and that acquired afterward by gift, devise or descent. Persons about to marry and spouses, without the intent to defraud pre-existing creditors, may by written instrument from time to time partition between themselves all or part of their property. Spouses may exchange a community interest in property owned or to be acquired for a community interest in other community property. The amendment would allow spouses to agree in writing that income or property arising from any separate property is to be separate property rather than as community property as it would be in the absence of an agreement. The amendment proposes that a gift from one spouse to another is presumed to include all income or property deriving from such gift.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment allowing spouses to agree that income or property arising from separate property is to be separate property."

A REMINDER FROM THE VA

The Coke County Water Supply Corporation has been progressing very well in the last several months with the first phase of rural water line construction for Coke County. The first phase of the project is well on the way to supplying water for rural customers who live west and southwest of Robert Lee.

Now, the board of directors is looking at the second phase of the proposed four phase county-wide system which would supply treated water to most of the rural residents of the county.

Phase II, directors say, will be determined by the number of applications made from a general area. The general opinion of the board during the past has been that the area around Oak Creek Lake and extending southward into Bronte would be the logical area to be served by the corporation. Population around the lake and the rural area north of Bronte is one of the heaviest populated areas of the county.

However, the location of the second phase of the project will be determined by the demand for fresh treated water as indicated by the number of applications. Anyone who is interested in obtaining treated water should make an application and pay the

The project is financed by the Farmers Home Administration through loans and grants.

A lack of moisture, over an extended period of time, has caused farmers in Coke County severe drought conditions. Farms experiencing such severe drought conditions may be eligible for cost-share assistance under the Emergency Conservation Program (ECP). This disaster program is administered by the county Agricultural Stabilization and Conservation Service (ASCS) which provides cost-share assistance if the damage:

- 1. Is unusual in character and is not the

type which would recur frequently.

2. Is so severe that water available for livestock has been reduced greatly.

A farmer qualifying for ECP drought assistance may receive cost-share levels not to exceed 80 percent of the cost for performing the following types of measures:

1. Installing pipelines or other facilities for livestock water.

2. Constructing and deepening wells for livestock water.

Farmers who feel the drought is sufficiently severe and their capabilities are such that

assistance is necessary to correct the problem, should contact the county ASCS office, and request assistance by not later than Sept. 17, 1980, the deadline for filing requests.

Practices should not be started until an "on-site" inspection of the damaged area has been made by the COC or its representative. The COC will review this inspection when considering the request for cost-share assistance.

PROPOSICION NO. 1 EN LA BOLETA

Resolución Conjunta #35 del Senado propone una enmienda constitucional que autorice a la Legislatura permitir a los bancos establecer y operar máquinas registradoras automáticas (teller machines) dentro del condado o ciudad en donde están los bancos compartiendo el uso de las máquinas registradoras de acuerdo con las leyes antimonopolistas, si acaso esta operación resulta conveniente para el público. La Legislatura ya aprobó la autorización de esta legislación (H.B. 1510) para la proposición de esta enmienda.

La enmienda propuesta aparecerá en la boleta como sigue: "La enmienda constitucional permite a la Legislatura autorizar que los bancos usen máquinas registradoras automáticas (teller machines) dentro del condado o ciudad de su domicilio en un plan de cooperación para conveniencia pública."

PROPOSICION NO. 2 EN LA BOLETA

Resolución Conjunta #97 de la Cámara propone una enmienda constitucional que conceda al Estado y al acusado el derecho de una apelación interlocutoria en los siguientes fallos de la corte en causas criminales: los fallos antes del juicio sobre la constitucionalidad de una ley; sobre la petición para anular, destituir, o desear una acusación; y sobre una petición para suprimir la evidencia.

La enmienda propuesta aparecerá en la boleta como sigue: "La enmienda constitucional autoriza la apelación de ciertos fallos antes del juicio de una corte en una causa criminal por el Estado o por el acusado."

PROPOSICION NO. 3 EN LA BOLETA

Resolución Conjunta #98 de la Cámara propone una enmienda constitucional que requiera una evaluación de todos los bienes sujetos a los impuestos de ad valorem y proveerá únicamente una junta para

revisar avalúos dentro de cada condado. El requisito constitucional de que la corte de comisionados del condado sea la junta de avalúos será eliminado, y a los oficiales electos del condado o de la comisión directiva de la unidad fiscal se les prohibirá servir como miembros de la junta de revisión de avalúos.

La enmienda propuesta aparecerá en la boleta como sigue: "La enmienda constitucional requiere solamente una evaluación y una junta para revisión de avalúos en cada condado para determinar los impuestos de ad valorem."

PROPOSICION NO. 4 EN LA BOLETA

Resolución Conjunta #18 del Senado propone una enmienda constitucional permitiendo a la Legislatura el autorizar juegos de bingo por grupos con propósitos caritativos solamente sujetos a las limitaciones de que la operación de los juegos tiene que ser aprobada en elecciones de opción local, y que todas las ganancias tengan que ser usadas en Texas.

La enmienda propuesta aparecerá en la boleta como sigue: "La enmienda constitucional autoriza los juegos de bingo bajo elecciones de opción local si los juegos son dirigidos por, ya sea, una iglesia, una sinagoga, una asociación religiosa, un servicio voluntario de bomberos, una sociedad no lucrativa de veteranos, una organización fraternal, o una sociedad no lucrativa que apoya la investigación médica o programas de tratamiento médico y si las ganancias son usadas en Texas para los propósitos caritativos de las organizaciones."

PROPOSICION NO. 5 EN LA BOLETA

Resolución Conjunta #86 de la Cámara propone una enmienda constitucional que permite a la Legislatura autorizar al Gobernador para que ejerza control fiscal de los gastos de ciertos fondos financieros previamente asignados, sujeto a las condiciones y

limitaciones proveídas por la ley y sujeto a la aprobación de un comité ejecutivo del presupuesto que constará del Gobernador, Gobernador Teniente, Presidente de la Cámara de Representantes, Presidente y Vice-presidente del Comité de Finanzas del Senado, y Presidente y Vice-presidente del Comité de Asignaciones Fiscales de la Cámara de Representantes.

PROPOSICION NO. 6 EN LA BOLETA

Resolución Conjunta #8 del Senado propone una enmienda constitucional que permita al Gobernador remover a un oficial de su cargo aunque este haya sido previamente nombrado por el Gobernador y confirmado por el Senado. El remover al oficial será únicamente bajo el consentimiento del Senado, y si la Legislatura no está en sesión, se convocará una sesión extraordinaria del Senado, la cual no durará más de dos días, para considerar la eliminación del oficial en caso.

Resolución Conjunta #121 de la Cámara propone una enmienda constitucional que autorice a los condados con una población de 5000 o menos, que construyan y mantengan caminos privados cobrando razonablemente por el trabajo. Por ley, la Legislatura puede limitar esta autoridad. Los ingresos recibidos por trabajo en caminos privados se pueden usar solamente para construcción, para adquisición de derecho de paso, o para el mantenimiento de caminos públicos.

La enmienda propuesta aparecerá en la boleta como sigue: "La enmienda constitucional autoriza que los condados con una población de 5000 o menos trabajen en caminos privados."

PROPOSICION NO. 8 EN LA BOLETA

Resolución Conjunta #36

del Senado propone una enmienda constitucional que cambie la jurisdicción y autoridad de las cortes de apelación del Estado. La enmienda cambiará el nombre de Cortes de Apelaciones Civiles a, Cortes de Apelación, dando a estas cortes jurisdicción de apelación sobre casos criminales y civiles. La enmienda cambiará el título de los Jueces Asociados de la Corte Suprema a, Jueces, y requerirá que los miembros de la Corte Suprema sean abogados con licencia del estado de Texas mientras permanezcan en el puesto.

La enmienda propuesta aparecerá en la boleta como sigue: "La enmienda constitucional que cambia el nombre de Cortes de Apelaciones Civiles y el nombre y requisito de los Jueces de la Corte Suprema y dicta la jurisdicción y autoridad de las cortes de apelación."

PROPOSICION NO. 9 EN LA BOLETA

Resolución Conjunta #54 de la Cámara propone una enmienda constitucional que define la propiedad que posee cualquiera de los cónyuges como separada, incluyendo las dos clases—de bienes raíces y los bienes inmuebles—los tales fueron propiedad de alguno de los cónyuges antes del matrimonio o fueron adquiridos después como un regalo, ya sea un legado de bienes raíces, o de descendencia. Las parejas que están por casarse o los que ya están casados, y sin la intención de defraudar a sus acreedores preexistentes, pueden repartirse de vez en cuando, entre si y por escrito, toda o parte de su propiedad. Pueden también intercambiar un interés común en bienes poseídos o que van a poseer por un interés común en la comunidad de bienes. La enmienda permitirá a los cónyuges convenir por escrito que los ingresos o bienes derivados de cualquier propiedad particular seguirá siendo propiedad particular en lugar de ser comunidad de bienes como sería si no existiera este convenio por escrito. La enmienda propone que el regalo de un cónyuge a otro se supone que incluye todos los ingresos y bienes derivados de tal regalo.

Presenting wedding music was organist, Pinkie Humble, and accompanying soloist, Pat Schrader, both of Sterling City.

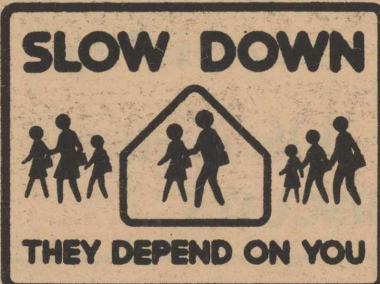

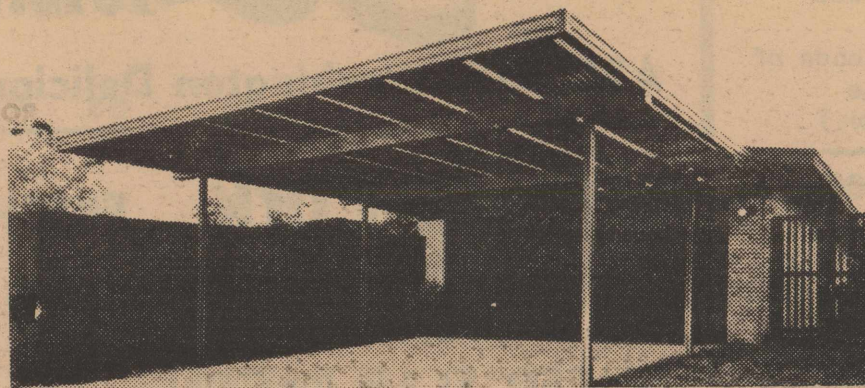

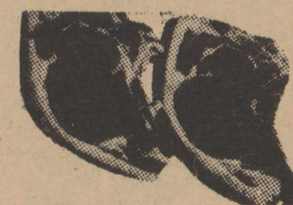
