## Lake Improvement Committee Formed at Monday Gathering

A group of interested citizens met Monday night in the courtroom at the Coke County Courthouse and formed an organization called the "Lake Improvement Committee." Officers were elected and the aim of the committee was stated "to make the lake a better place for people to fish and to enjoy other recreation." Thirty-one persons became members of the organization.

Officers elected include: E.C. Bennett, chairman; Wyvonne Autrey, secretary; and Mary Patterson, treasurer.

Bennett said the group plans to cooperate with local law enforcement officers by reporting thefts, vandalism, littering and any other lawlessness.

Another aim of the group is to protect access roads to the lake.

## Deadline Near For Casting Absentee Vote

Absentee voting in the three elections which are coming up Saturday, April 4, has been very light, according to a report Wednesday morning from the absentee clerks. Only one vote had been cast in the city and hospital district elections and two votes in the school trustee election. Deadline for casting absentee ballots is Tuesday, March 31.

### CITY ELECTION

Three candidates are running for the three vacancies on the city council. They are Jody Rodriguez, F.W. Prentice, incumbents, and J.A. Dunklin, a new candidate.

### SCHOOL ELECTION

Two vacancies exist on the school board of trustees and three candidates are running. The incumbents, Phil Ray and W.L. (Dub) Metcalf, and a new candidate, Mary Herring, are listed on the ballot.

### HOSPITAL ELECTION

Two directors are to be elected to the West Coke County Hospital District board. The three candidates are Mrs. Barbara Chesney, Jody Rodriguez and Teddy Pitcock.

## "Vial of Life" Available Soon

"Vial of Life" forms and stickers will be available on Friday, April 3. Anyone who has not picked up the life saving item may do so free on this date.

The program is designed to help save lives in case of an emergency. Each person in the Robert Lee area who has any type of medical problem or those who are on medication should fill out the form and put it in the refrigerator. Many lives have been saved by this program.

Vials will be available from 10 a.m. to 3 p.m. on April 3 at the Coke County Courthouse, Robert Lee State Bank, City Hall and Coke County Pharmacy. Members of the sponsoring organization, the '64 Study Club, will be on hand to explain the form and procedure.

The recent closing of a part of Friendship Road was discussed, Bennett said, "and the decision was made to sue the county if this was the only way to get this road opened."

## Tax Pamphlet Now Available

Edna Havins, Tax Assessor-Collector for the City of Robert Lee announced today the availability of a 12-page pamphlet which may help local residents save on their property taxes. She said the pamphlet explains how the property tax system in Texas operates and highlights possible tax savings available to citizens.

The publication was developed by the State Property Tax Board in accordance with the Property Tax Code, which was passed by the 66th Legislature in 1979, and the information is applicable to taxes collected by all levels of government, including counties, cities, and school districts.

Disabled veterans are eligible for exemptions with the City of Robert Lee.

April 1 is the rendition deadline and all citizens should render their property at the new county appraisal office before this date.

Included in the events for both boys and girls are long jump, high jump, shot put and discus. In addition there will be the triple jump for girls and pole vault for boys.

Running events for both boys and girls include 440 yard relay, 3200 meter run, 880 yard run, 100 meter dash, 440 yard dash, 220 yard dash, 1600 meter run and mile relay. In addition there will be 110 meter low hurdles and 880 yard relay for girls, and 120 yard high hurdles and 330 yard intermediate hurdles for boys.

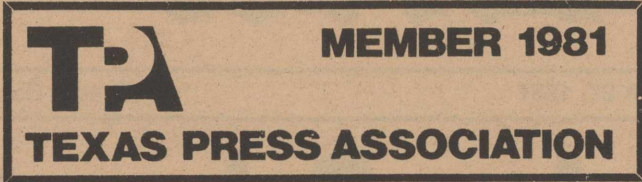

**Economizing Is Everyone's Responsibility — Even The Congress**

In a time of tight budgets, and cost cutting, there is no room for double standards. *Everyone* must share the burden, and make the sacrifices necessary to assure we reach our objective of balancing the Federal budget.

This includes the Congress itself, for too long considering itself immune from the hardship of spending cutbacks that it often has asked the American people to accept.

It is time to remove the double standard. The House of Representatives will have the opportunity to do so in coming weeks as it considers the staff size and the budgets for its standing committees.

The sums of money involved are not small. And reviewing committee funding over recent years illustrates the point.

From 1975 to 1980, Federal outlays increased by 78%. The House of Representatives committee expenditures increased by a whopping 120%.

Despite this fact, Committees of the Congress have requested an average proposed increase — over and above 1980 expenditures — of 36% for the coming year. This simply defies reason.

Overall, from 1960 to 1980, Legislative Branch Appropriations have ballooned a staggering 874%, from \$131 million to \$1.3 billion

The size of committee staffs absorbed a good portion of the funds involved. Committee staffs rose from 702 in 1970 to 1844 in 1979. The appropriations involved for committee staffing soared from some \$9 million in the 90th Congress back in 1966, to \$85 million in the 96th Congress, which began in 1978.

The Congress has the same opportunity now to break with the policies of the past that the Reagan Administration already has said is critical if we are to get at the root of our economic problems in this country — and that is a reduction in the growth of tax dollars spent by the Federal government.

In plain fact, Congress can no longer ask the American people to tighten their belts if the Congress is unwilling to do the same.

The Senate has already taken a step in the right direction. It has adopted an across-the-board reduction in spending for its standing committees by 10% compared to what they were authorized to spend in 1980.

The House now must follow the wise lead of the Senate. All of us must act in a manner consistent with this country's most important economic objective. Many of us who are concerned about the snowballing effect of committee budgets and staffs have sponsored a House Resolution, that if enacted, would express the intent of the Congress to hold the line on spending tax dollars — *your* tax dollars.

This bill would limit the aggregate of all authorization levels for the standing and select committees of the House of Representatives to 90% of the aggregate amount spent by these committees last year.

A 10% cut in spending is more than symbolic. It puts the Congress on record — for the first time in recent years — in favor of backing up tough *talk* about reducing the size of government with a legislative proposal *requiring* it.

Clearly, much more needs to be done if Congress expects to comply with the wishes of the American people for leaner, more effective government.

But long journeys begin with the first step. Congress can steer itself down the right road by learning to do more with less. After all, this is what economizing is all about.

**Representative Larry Don Shaw Reports from Austin**

Despite the fact that the Department of Public Safety every session asks the Legislature for more troopers, the pay and operating budgets are low and the potential for advancement so poor that the D.P.S. can't recruit enough qualified people to fill the trooper slots it has now.

Texas now ranks 37th out of the 50 states in what we pay our state troopers. A Texas highway patrolman with twenty years of experience earns less than a brand new City of Dallas police officer.

The hours are not terrific, either. The D.P.S. operates only two nine-hour shifts a day, so in the hours after midnight, off-duty troopers are on call to respond to accidents. For this, instead of overtime pay, they are supposed to receive compensatory time off, but with the D.P.S. operating at less than full strength, a trooper can't always find time to take it.

To put the trooper shortage in perspective, Texas has twice as many miles of highway as California, but California has three times as many highway patrolmen.

Promotions don't mean significant pay raises either. The result is that more and more Trooper II's simply decide not even to take the sergeant's exam, and when the last lieutenant's

exam came up, the majority of sergeants declined to take it. Instead, many troopers transfer to the D.P.S. Narcotics or Intelligence Divisions where the pay is higher and the opportunities for advancement are better. Or they leave the D.P.S. altogether.

Back in 1960, a total of 76 highway patrol recruits attended the D.P.S. academy. Only 43 graduated, and of those 43, only 5 remain with the D.P.S. today.

For Texans who view the highway patrol as little more than a symbol of the 55 m.p.h. speed limit, these problems may not be very disturbing. But the real problems in highway safety are drinking and crime, not speeding in 1979, and in the same year highway patrolment made more than 4,000 felony arrests.

In many rural areas of Texas, the highway patrol is the only sophisticated law enforcement for miles around. The presence of the highway patrol is the biggest single deterrent to truck hijackings, small town bank robberies, and other crimes that depend on mobility, and the safety of the ordinary motorist who stops to change a tire or nap at a roadside park would be diminished considerably without the highway patrol's presence.

In short, the highway patrol division of the D.P.S. is a crucial

and fundamental arm of law enforcement in Texas, and we as citizens deserve to have the highway patrol at full strength and manned with adequately-paid, experienced officers.

I have introduced a bill to give an across-the-board pay increase to all D.P.S. personnel, and I support including significantly increased equipment and operating budgets for the D.P.S. in the general appropriations bill. We need additional trooper slots, too, but perhaps the increased pay will at least help the D.P.S. fill the trooper positions already budgeted.

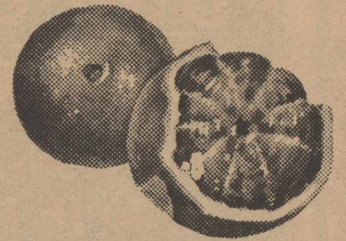

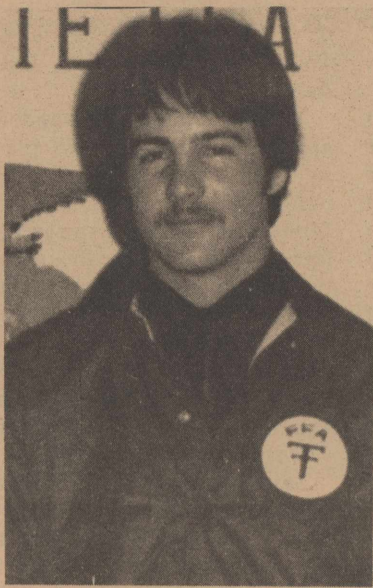

## Sen. Snelson Sponsors Bill On Education

Four bills affecting higher education in Texas were introduced March 11 in the Texas Senate by Senator Pete Snelson, chairman of the Education Committee.

Three of the proposals introduced by Snelson reflect recommendations of the "101 Committee" which studied the financing of higher education during the past two years.

The "101 Committee" recommendations included a proposal to increase college tuition and to utilize the increase for the creation of a college building fund.

"Although I was not a member of that committee, I believe that its work should be considered by this session of the Legislature," said Snelson. "I anticipate that there will be major changes in the bills as a result of committee hearings."

The fourth proposal is an attempt to resolve the matter of funding for major capital improvements and construction at institutions of higher education. It has been a major issue since the constitutional convention of 1974. Introduced as a proposed amendment to the Texas constitution, SJR 46 would expand the Permanent University Fund to include schools in the University of Texas and Texas A&M systems for construction funds and would broaden the current provision in the Texas Constitution regarding college construction funds to include all other institutions of higher education. The amendment also would reduce the presently authorized 10-cent state ad valorem tax to 3 cents.

Regarding the proposed tuition increase, Snelson said that he believes with the financial crunch facing the state, it is imperative that we explore all possible sources of revenue. Since higher education is seeking major increases in funding, it is proper that we examine the relationship of student costs and taxpayer costs.

The Senator noted that tuition did not increase significantly from 1957 to 1971, when the flat

rate of \$50 per semester was changed to \$4.00 per semester credit hour for residents and from \$200 per semester to \$40 per semester credit hour for non-residents.

Although student fees have increased since 1957, Texas is one of the four least expensive states in total charges to resident students attending public institutions.

May 1 is the final date to certify small grain acreage for 1981. Small grain for grazing must be reported. An accurate acreage report is important. If you are not sure of your planted acreage, request measurement service. A nominal fee will be charged to assure you of the correct acreage.

### SBA LOAN APPLICATION

Filing deadline for emergency loan applications thru the Small Business Administration (SBA) has been extended to April 13.

### ASCs DISASTER COVERAGE

Disaster provisions are still applicable for 1981 on wheat, barley, grain sorghum, corn, and cotton. Compliance with the farm's normal crop acreage (NCA), cross-compliance of NCA crops on the farm, and off-setting compliance between farms will not be a requirement for participation in the 1981 wheat, feed grain, and upland cotton programs.

### EMERGENCY FEED PROGRAM (EFP)

The EFP feeding period for both Coke and Sterling Counties will end March 31. Producers are reminded that feed acquired and cost-shared through the program must be fed by the end of the feeding period. An amount of feed not cost-shared which has been fed may be substituted for the feed cost-shared (on a grain equivalent basis).

You should furnish us with feed receipts as soon as possible so that payment can be computed. The final date to submit feed receipts for payment will be May 1.

## LETTERS TO THE EDITOR

To the Editor:

This is the centennial decade for Coke County.

From 1879 through 1890 the county was settled, schools, churches, county local government with its courthouse were organized. The Weathers family moved in northeast of Robert Lee and started sheep ranching on land now owned by Raymond McCutchen and on the open range in 1878.

In 1879 the Jim Byrd Family and the Austins settled in the Hayrick-Sanco Country. Mrs. Bryan Yarbrough's history of Coke County, which I understand is at the binders now, will tell more of the story.

History is not written or recorded or kept around in pack of yellowed papers for no reason. It is the story of the real values of our people. For some years now Coke County has shown - its people have shown their interest in keeping remembrance of those who founded it and have put their lives here. Books and pageant tell the story.

The year 1989 will be the 100th anniversary of the county. The years 1881 through 1889 saw the settlement of the Colorado-Concho-Clear Fork valleys.

We look back a hundred years and see wagons moving into this valley, bringing a few cattle with them, maybe an extra horse, a walking plow tied on the back of the wagons.

But these great tall years see something more - they see a frontier wider and more fantastic as the space shuttle loads up to move into space for real, with factories, even.

When surveyors start to run a line, they try to tie in to a fixed corner. The Bible says, "Remove not the old landmarks." Unless we are to lose ourselves in space, we had best not lose our place of beginning. That is what history is for. Coke County people have done a good job of it, working both individually and collectively.

It is a continuing thing. There is always more to be done.

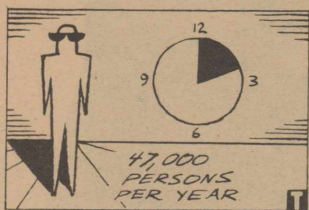
