The matter of closing Friendship Lane has become a festering sore on the side of a lot of people, especially on the west side of Coke County.

So far as can be determined at this point, the Coke County Commissioners' Court acted within its rights when members voted to close the road going down to Lake Spence from Highway 208.

the commissioners voted to close the road. On the other hand, it was reported that the petition against the road's closing bore the signatures of only eight persons.

Since that time a meeting has been called and an organization has been formed for the purpose of making Lake Spence a more pleasant, sanitary and beautiful place from which to catch its lovely stripers and other fish. That's a very fine objective. However, this organization also has declared its avowed purpose is to get Friendship Lane opened up again to the public. Court action has been threatened if the road is not reopened. There are those who want to sue the county.

Main objection to the road's closing is that it leads to the favorite fishing place of many local fishermen, particularly the elderly and others who have no boat or are unable to operate a boat on the lake.

E.C. Bennett is the leader of the anti-closing faction and makes no bones about his intentions to get the road reopened. He has lived in Robert Lee the past four years and is proud of his former successes in bucking the establishment. He told the Observer, "I've had a lot of experience fighting municipalities and I don't ever do anything I don't think is right." He cited that he was responsible for the airport at Hobbs, N.M., not being moved because he believed only a few investors in nearby property would benefit. "The same thing goes for this matter," he said, "where only Mr. Paul Burns and Mr. Douglas Robertson will benefit. "All in all, I feel that Robertson and Burns persuaded a lot of people to fight us but I like to see justice done. I'm a Christian man and I like to do this because I know we are right." Bennett said Tuesday night on the telephone.

He has a letter to the editor, also, in this issue of the Observer. Another letter opposing the closing is in this week's paper, submitted by D.E. (Ike) Bailey Sr. of Clarke Oil Well Servicing, Inc.

I was almost in agreement with these kind folks, who have chosen Robert Lee as their place for retirement, until late Tuesday, when I began to see that there could perhaps be another side to the matter other than just providing a nice fishing hole for some people.

I talked first, to County Judge D.W. Sims. He said, since he had been in Temple having surgery most of the time since the decision was made to close the road, that he could not comment too much on the matter. He said, however, "The commissioners followed the advice of the county attorney when he told them that they had every right to close the road."

The judge continued, "I felt when the commissioners voted to close the road that the matter was decided and I certainly wouldn't buck their decision."

Commissioner Jerry Parker of Bronte, who served as county

# Light Turnout for Local Elections

A light turnout of voters Saturday elected officials for the City of Robert Lee, the Robert Lee School and West Coke County Hospital District.

Heaviest voting was in the school trustee election where 192 ballots were cast. Incumbents on the ballot were reelected, with Phil Ray getting 159 and W.L. (Dub) Metcalf receiving 128 votes. The third candidate on the ballot, Mary Herring, received 88 votes and Gaylon Pitcock got three write-ins.

West Coke County Hospital District has two new directors, replacing George Newby and Earl Lindsey who did not seek reelection. Barbara Chesney received 137 votes and Teddy Pitcock was close behind with 133. The other candidate was Jody Rodriguez who received 66 votes.

Only 106 persons voted in the city election where three candidates were running for three vacancies. The incumbents, F.W. Prentice and Jody Rodriguez, received 102 and 89 votes, respectively. A new candidate, J.A.

Dunklin, received 90 votes to become a Robert Lee city alder-

Allen Clendennen was the other councilman whose term expired this year, but he did not seek reelection.



#### THE DEPUTY WHIP'S JOB

A fair amount has been written lately about my designation as "Deputy Republican Whip" in the House of Representatives.

It is an honor to be named to such a leadership position. But

It is an honor to be named to such a leadership position. But there's a lot of hard work that goes with the territory. Ultimately, however, the Twenty-first Congressional District will benefit when our leadership is translated into legislative victories.

A whip by definition is a party leader chosen by the policy makers to make certain that members are present for important votes and that they vote the way the leadership wants. The party whip must be tactful, yet tough; he is expected to turn out every member on crucial party-line votes.

The word comes from "whipperin," a man assigned to keep the hounds from straying in a fox hunt. The term was first put into the political language by the masterful English prime minister Benjamin Disraeli, who said the job required "consummate knowledge of human nature, the most amiable flexibility and complete self-control." A tall order by any standard these days!

As Deputy Whip I will work with the Executive Branch, the Senate and conservative Democrats in the 97th Congress. I will also be playing a role in the formulation and execution of Republican strategy. Simply put, the whip or his deputies persuades other members to support the programs sent to Congress from President Reagan. The job will not be an easy one in the House, since it is not controlled by the President's party. But there are many of my colleagues on the other side of the aisle who share my views that the growth in federal spending should be reduced — that rhetoric aside, this is the time for a new beginning.

One of the reasons I was chosen Deputy Whip is my previous Washington experience on the Senate staff of fellow Texan John Tower and more recently my work in the Ford White House. That experience taught me the importance of coalition building. It is the principal way to work on a consistent policy. Success will also depend on persistence and hard work — something to which all of us in the Twenty-first District are accustomed. This year all of us

in the Congress have our work cut out for us.

The Republicans are some 28 votes behind this session in the House and we must build coalitions with the Democrats to get our programs passed. It is perhaps fortuitous that I will be working with my good friend, Congressman Charlie Stenholm of Stamford. Congressman Stenholm is leader of the new Conservative Democratic Forum and in many ways we are philosophical soulmates, particularly on economic and defense matters. Charlie and I have developed a good personal friendship and a sound working relationship. We need these kinds of relationships to win a majority on key votes.

One thing is for sure: Debate on the Federal budget will be extensive and will get heated at times. It is difficult to predict our legislative potential this early in the game but the lines have been drawn and I am optimistic we will gather a good working majority in the House. There are enough Democrats who believe in the conservative public opinion that demands some change in our fiscal thinking. That should send a clear signal to the House majority and others enamored of giveaway programs and a government too involved in local matters to keep its own house in order. We have sent a clear signal to the liberals in the House of Representatives that we intend to get down to the business of passing the President's budget.

Now, there is one footnote to what we've been talking about: I want to stress that my new duties will not take away from the kind and quality of representation I give to the Twenty-first Congressional District. In fact, my new assignments will enable me to have a clearer voice on programs that affect our diverse needs in the Twenty-first.

My service on the powerful Appropriations Committee will be much the same way. That committee sees every piece of spending legislation in the House of Representatives and controls the federal purse strings. We all know that fiscal responsibility is critical in these inflationary times.

And finally, my assignments on the military construction and interior subcommittees — combined with my working relationship with the Republican leadership — will give me a great vantage point to look out for the interests of our district and take action when our causes are threatened.





judge pro tem while Judge Sims was away, said, at the Monday meeting of the commissioners' court, the advice of County Attorney Bill Helwig was taken to submit all the documents and other evidence to the attorney general of Texas for a decision on the matter.

Judge Sims said late Tuesday he told Bennett that trespassing on the closed property was similar to burglary and persons who are caught can be filed on. Sims said Bennett told him, "We'll take our chances," and he construed that to mean that the leader of the opposition to the road closing didn't intend to abide by the commissioners' court decision.

"I'm still open to negotiation." the judge said, "and would like to work with anybody who is willing to work with us on this matter.'

Judge Sims said, "I feel sure the commissioners would be willing to hear any reasonable consideration that would be beneficial to both sides and stay within the bounds of the law, but so far, the only word I have received makes me feel as if I had been threatened.'

#### **CRMWD HEAD TALKS**

The head of the Colorado Municipal Water District, O.H. Ivie, was contacted by this newspaper at his home Tuesday night in Big Spring. During a 45 minute conversation Ivie assured this writer that the CRMWD had nothing but good will toward the citizens of Coke County.

However, he pointedly said that his organization has obligations which "may not satisfy everyone who wants to drop a fish hook into Lake Spence."

Helwig said he felt he advised the commissioners correctly when he told them they had the authority to close the road. He said he did not recommend that the road be closed, but only advised the commissioners of his opinion.

Helwig said he was pleased with the commissioners' Monday decision to submit all the documents concerning the matter to the attorney general and let his office decide the final outcome.

"The commissioners have made a decision and I feel that any further pursuit of the matter until we hear from the attorney general's office would only serve to fracture further and hurt the county," Helwig said, "and that is something I do not want to

The county attorney added that he will do whatever is necessary in the matter, but he would do it only on a professional basis, "not as a personal thing as it has been developing the last few weeks."



COLLEGE STATION -The bathtub — unchanged in 50 years — is too short, too narrow and too low and toilet seats should be redesigned to be more comfortable, claims a human factors engineer.

A new textbook by R. Dale Huchingson takes a questioning look at devices and machines that are supposedly peopleoriented but don't quite mea-

'The book advocates that we think critically of the world,' said Huchingson, professor in Texas A&M's Industrial Engineering Department. "Americans grew taller by four tenths of an inch per decade to 1970, our last reliable figure. Engineers and others in design must take these factors into consideration.

The book contains sections on aerospace, surface transportation, communications and data processing systems, as well as industrial systems and the environment.

# Jerry Lackey's **Country Folk**

FORT WORTH--As a member of the press delegation covering Vice President George Bush's first visit back to Texas after taking office, this writer was caught up in the shock, drama and agony that all Americans experienced when the president

While we lunched with the vice president and listened to his remarks before the 104th annual meeting of Texas and Southwestern Cattle Raisers Association, it never occurred until after the fact how near Bush came to be president. Nonetheless, I was most impressed with the security provided for the vice president by the Secret Service and the police.

I have been in the press corps with five presidents of the United States and several vice presidents over the last 25 years of my journalism career. In all those times, I have never witnessed as much security as was provided for Bush on this visit.

When news circulated that President Reagan was shot, the cattle raisers meeting sort of went into limbo for the remainder of last Monday. People gathered back in their hotel rooms to watch TV or huddled around radios in the huge Tarrant County Convention Center.

As word came that the president was going to be okay, the jubilance showed in the faces of over 2,000 cattlemen. Reagan had addressed this assembly four years ago in the same location. And following Bush's speech, TSCRA president John Cargile of San Angelo sent word to the President via Bush that the cattle raisers support everything he "is trying to do to patch the national economy.'

President Reagan has "described the country's current economic situation as verging on calamity," said Bush. "Unless we do something to stem and reverse current trends, this country is going to suffer an economic catastrophe of unprecedented dimensions. That isn't alarmist talk. It's the harsh truth--the truth that critics of the president's program for economic recovery simply don't want to face up to."

Bush told members of the press in a news conference of three-fold program to deal with the country's economic crisis:

"First, to reduce the rate of inflation and unconscionable interest rates, the president pledged to curb the excesses of a federal spending machine gone out of control;

"Second, to put jobless Amercans back to work and stimulate industrial expansion and private investment, President Reagan pledged tax cuts that would effectively restore incentive to an economy burdened by paying the cost of those federal spending excesses:

"Third, he pledged to take another burden -- that of federal government over-regulation -- off the backs of the American people, in their communities, their lives and their livelihoods."

The vice president delivered his remarks on the economy straight and without any frills. However, he failed to make any statements in the press conference I attended and /or in the speech concerning agriculture policy, the grain embargo or the predator situation.

"I know a lot of the ranchmen's problem stems on rain or drought," he smiled as he looked toward the ag press. And traveling to and from Fort Worth, I observed the makings of a great spring. Visiting with ranch folks from throughout the Southwest, it is obvious one of the best spring's in 20 years. This spring has more than made up for the hot, dry last summer."

Wade McCleery, Tom Green County ranchman, states his 'country is in tip top shape, the best in years and we are enjoying a good spring."

Lad Linthicum predicts "the best lamb crop since 1960 and the best spring in almost that time" at Barnhart.

Bob Northcutt, foreman of the April 10, 1981 Renderbrook-Spade Ranch near Colorado City, says "weeds knee high along with plenty of grass wave over the ranges.

In the Texas Hill Country, James Grote of the Granite-Hills Ranch near Llano, says the bluebonnets are "beautiful this year. We received another inch of rain last weekend to perk them up again. But we have received rains all winter."

John Dudley of Commanche recorded another inch of rain last week. "Because of a mild winter, we have some old grass left and with the new grass coming on, our terrain is going into spring ahead of schedule.

Former Texas Governer Dolph Briscoe stated: "South Texas rangeland is looking good after recent rains."

Johnny Northcutt of Cotulla says South Texas "is either fried chicken and gravy or guts and feathers...right now it's fried chicken. We have the best bottom moisture since 1977, good weeds as a result of good rains and a light winter with little feeding. Everything is blooming and maturing.'
