# Coke County Area Hit By Heavy Spring Rains

Farmers and ranchers of the Robert Lee area and all of Coke County were all smiles this week after earth-soaking rains started falling early Tuesday morning and continued throughout the day and night. Pasture land and

small grain crops will gain many thousands of dollars worth of benefit from the moisture.

Heaviest amount reported to the Observer was 5½ inches received by Floyd Harmon who lives in the Wildcat community south of Robert Lee.

The lightest measurement reported was in the City of Robert Lee where J.E. Quisenberry turn-

ed in a total of 2.70 inches.

Other measurements were: Valley View area, 3.50 inches; Silver, 3.50 inches; Sanco, 3.30 inches; McCabe Ranch on the Divide toward Water Valley, 3.50 inches. Bronte had 2.50 inches.

Farmers were beginning to complain about dry weather and lack of moisture. An unusually wet March this year resulted in lush growth in pastures and small grain fields. However, a number of days of dry, hot winds had sapped much of the moisture which fell last month.

In addition to providing assurance for a good grain crop, the moisture will put the ground in good shape for planting row crops in the next few weeks.

The general attitude about the rains was that "they just couldn't have been better."

Cloudy weather continued Wednesday morning and forecasters said there was a possibility of more rain during the day.





I believe that I am entitled to a rebuttal to the article you wrote in last week's paper, concerning "Friendship Road". This road has been referred to as a dead end road that doesn't go anywhere. This road goes to the largest and most important thing that ever happened to Coke County, namely, Spence Lake. Robert Lee wouldn't be anything but a spot on the map without this lake. Almost every person in Robert Lee has profited from this lake. The land owners received much more than the market value for the land they sold to the C.R.M.W.D. and some of them

are still using it like it was their own, but the agreements I read in the county records say they can graze it "at their own risk" till it is covered by water.

Many people don't realize the importance of this road. It is a loop road and the closing has the effect of closing two roads which are the only access roads to the lake on the northeast side of the lake from the north end of the dam to Rough Creek Park. These two small parks will be the only places left for the public to use with about two miles of shore line. The closing of these roads will hurt the land owners near this road much worse than Robertson and Burns will be hurt by leaving it open. Mr. Tom

Rives, Mr. John Rives, Mr. Bill Teas and Mr. Scales, whose property is within one-half mile of the lake will have to drive eight or ten miles to get to the water. I would estimate that much of this land which joins Friendship Road and the lake property will be reduced by at least \$1000.00 per acre by this closing.

Much business has come to Robert Lee because of the lake many people have moved here to retire. Many old houses that were falling down have been bought and rebuilt or moved off and cleaned up. Lots that were worth about \$100.00 before the lake was built, now are selling for \$2500.00 and up.

I realize that you do not attend the commissioners' meetings and the only information you get is from them, or the minutes of the meetings which contain very little. I will bring you and the readers of your paper up to date on what has happened on the "Friendship Road"

You referred to me as bucking the establishment. I believe in law and order and have never opposed anything that was right and legal.

This started when I came to a closed gate in the middle of a county road. I came back home and went to the home of my neighbor, George Newby. I asked him why the county road was closed. He said the commissioner told him it was closed last November before he was elected and there wasn't a damn thing he could do about it and that the judge would not even talk to him about it.

I told him I did not believe it was legally closed and I was going to check the newspaper files to see if a public notice and hearing had been held; if not the judge could talk to me or my lawyer which ever he chose. The commissioners' court held a special meeting and when Mr. Newby came home I asked him what he found out. He said they flubbed, the road was not legally closed.

Two men had asked them to close it but no action had been taken. I called Mr. Douglas Robertson and told him he should get the gate down, that someone could run in to the gate and get hurt or a big boat or camper could get damaged turning around in this lane and he and the county would be liable for damages. He said the county attorney told him he could close it and he didn't bluff easily. I told him I was not bluffing but giving him the facts trying to help him. It took a few days, but I finally got the gate down and a locked chain off the cattle guard where Mr. Burns had put it.

Several men come to me and asked me to be spokesman for them at the next meeting of the county commissioners. I agreed and asked the Judge to put me on the agenda which he did. About 10 or 15 people attended the meeting with me. When I presented our case to the court, they all seemed apologetic and said they did not intend to do anything underhanded; they thought it was an old dead end road that no one cared about.

I told them what was done was not important, but what they could do now was what we were interested in. They asked what they could do. I told them they could move to reject the request of the two men and vote to leave the road open which would settle the matter now. Mr. Newby made a motion to leave the road open Mr. Millican seconded the motion. At this point Mr. Parker got up and went after the county

attorney and they talked low, where I could not hear what was said. Then the county attorney told them they could not vote on this motion without publishing a public notice and calling a public hearing.

I told the court their attorney was giving them the wrong advice, that it was not necessary to give a notice to keep a public road open that had been open for over 50 years, but it would take a public hearing to close it. They assured us all that they did not intend to close the road but just wanted to make it legal.

If the vote had been taken on the motion of Mr. Newby at that time, it was obvious to everyone in the room that it would have passed. The county attorney asked Mr. Newby to withdraw his motion and Mr. Millican to withdraw his second and pro-

ceeded to publish a public notice and called a public hearing.

Then they completely ignored the results of this hearing where 289 people vigorously opposed the closing of the road, and closed the road, doing exactly the opposite to what they had promised the people of the first meeting. Mr. Ivie told us at the public hearing that if we got out of our boats to eat our lunch on this land we would be trespassing on Mr. Robertson's land. I asked him if he did not pay Mr. Robertson for the land when he bought it. He said yes. I then told him Mr. Robertson did not own any land there and we would take our chances on that trespassing. I think his statement was ridiculous. As for the judge feeling threatened, I do not consider what I told him to be a threat. I just stated a plain fact. I told him he should not let Mr. Ivie get the county to close the

road for no one could close this road against the will of the people, and, if the county closed it, we would sue the county; if C.R.M.W.D. closed it, we would sue C.R.M.W.D., and I did not think the county should be led into this by Mr. Ivie.

Our sheriff said he could not police the whole lake, he has the help of the lake patrol.

If this road stays closed and all the people who have been using all the shore line of the lake for the past 10 years are squeezed into these two little parks, I am afraid our sheriff will have problems that he never thought about. The land they are trying to keep us off of is tax free land. No one pays any tax on it and, if the lake fills up, it will be public land and lake bottom, so I contend we have a right to use it now. We have used this road and land for 10 years, since the lake was built without any inter-

ference by anyone so why should they stop us now.




