## Lou Wright Is First Woman Paramedic

West Coke County Ambulance Service passed another milestone recently when Lou Wright completed all the work toward becoming an Emergency Medical Technician/Paramedic. She was certified during state examinations the last of June.

Her many hours of work give her the distinction of being the first paramedic for Coke County and the first female paramedic in the 13-county Concho Valley area.

The addition of a paramedic to the Robert Lee service will allow it to provide advanced life support at this time, and when the new ambulance is purchased and special equipment is provided for it, the service will have a qualified person to operate a mobile intensive care unit.

All these purchases, like the ambulance, are very expensive. Training costs money, equipment costs money, and "sometimes it seems as if everything we get involved in costs money," Miss Wright said. She did point out one asset of the service that is provided at a good price, noting that it "is important to remember that not one of the volunteers is paid for his or her service on the ambulance."

Lou asked the Observer to thank all those who have had a part in helping her get the paramedic certification. She especially mentioned that her carpool drove extra days to free her, her family did all the chores, ambulance service members covered many of her "on call" days and various organizations including the Lions Club and Coke County Commissioners' Court made contributions toward the expensive endeavor.

As she phrased it, "This paramedic belongs to the whole county, not just to me."

### Judge Refuses To Drop Charge

A heated two-hour session of Coke County Court Thursday of last week resulted in a refusal of Judge D.W. Sims to order dropping of a speeding charge against a man from Decatur.

Charles Hudson of Decatur, Tex., and his lawyer, Stan Boose of Eastland, appeared before the county court requesting a writ of mandamus which would, in effect order Precinct 4 Justice of the Peace Earl D. Nutter to drop speeding charges against Hudson.

With Boose representing Hudson and County Attorney Bill Helwig representing Judge Nutter, a two-hour hearing of the matter resulted with some heated courtroom procedures. It was reported that on at least two occasions Judge Sims threatened the defendant's lawyer with contempt of court.

Helwig said he made his final arguments before the court and was told by Hudson's lawyer that "the last time anybody said that about me he wound up in the hospital."

The hearing ended up with Judge Sims denying the writ, which put the case back into the court of Judge Nutter. Hudson pleaded guilty but appealed his case. This means that once again he will have to go up against Judge Sims and County Attorney Helwig, if he pursues the procedure to its end.

Cases of this nature don't ordinarily cause so much court procedure. However, this one brought in County Clerk Mrs. Winnie Waldrop to serve as clerk for the proceedings; Constable Bob Fields to serve as bailiff; and Judge Sims and County Attorney Helwig.

#### DWI JURY TRIAL COMING

The county attorney said Tuesday that cards are being prepared to mail out to prospective jurors to serve at a jury trial on July 30 on a DWI charge.

### Three Students Will Attend FB Seminar

About 400 high school students from 157 counties will gather July 20-24 at Baylor University to take part in a learning program about their American heritage.

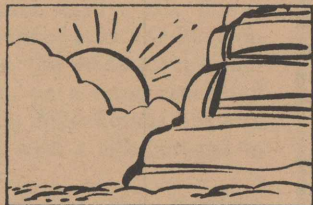

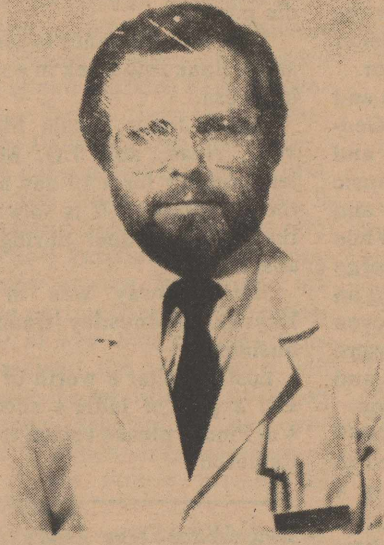

### County Okays Bridge Repair

Coke County commissioners met Monday and accepted a bid of Armco, Inc., of Amarillo to supply the steel pipe to construct a permanent crossing over San Creek south of Silver.

The bid was for six 48-inch, 14 gauge steel pipes, 40 feet long. The price was \$22.31 per linear foot for a total cost of \$5,354.40. The supplier is to deliver the pipe to the construction site, and work will be done by a county crew under the supervision of engineer, Dan Glass.

A low water crossing was built at the site after the old bridge became unsafe, but heavy rains this year have washed it out several times. The commissioners want to build a crossing that will stand up and not require constant repair work.

Bill Green, a member of the board of directors which governs the Nolan County Drug and Alcohol Abuse Program, met with the court and encouraged the commissioners to continue using the program directed by Tom Watson. He said the program would not conflict with the county also making use of a program sponsored by the Concho Valley of Governments, stating that the two programs could work well together.

Javan Vosburg Jr., who is with the Child Protective Services of the Texas Department of Human Resources, spoke to the court about reorganizing the county board which is responsible for working with child abuse cases. He also gave a slide presentation showing how a board should be organized and function. The commissioners took no action on appointing a new board, but plan to take up the matter at their first meeting in August.

Cecil Coalson met with the court to push his request for reopening a road northwest of Bronte which was closed when flood control dams were built on the Kickapoo Creeks. County Attorney Bill Helwig presented opinions on legal aspects of the proposed reopening. The commissioners took no action on the request and told Coalson they would leave it up to him as to how he wished to pursue the matter further.

Bills were approved and the meeting adjourned.

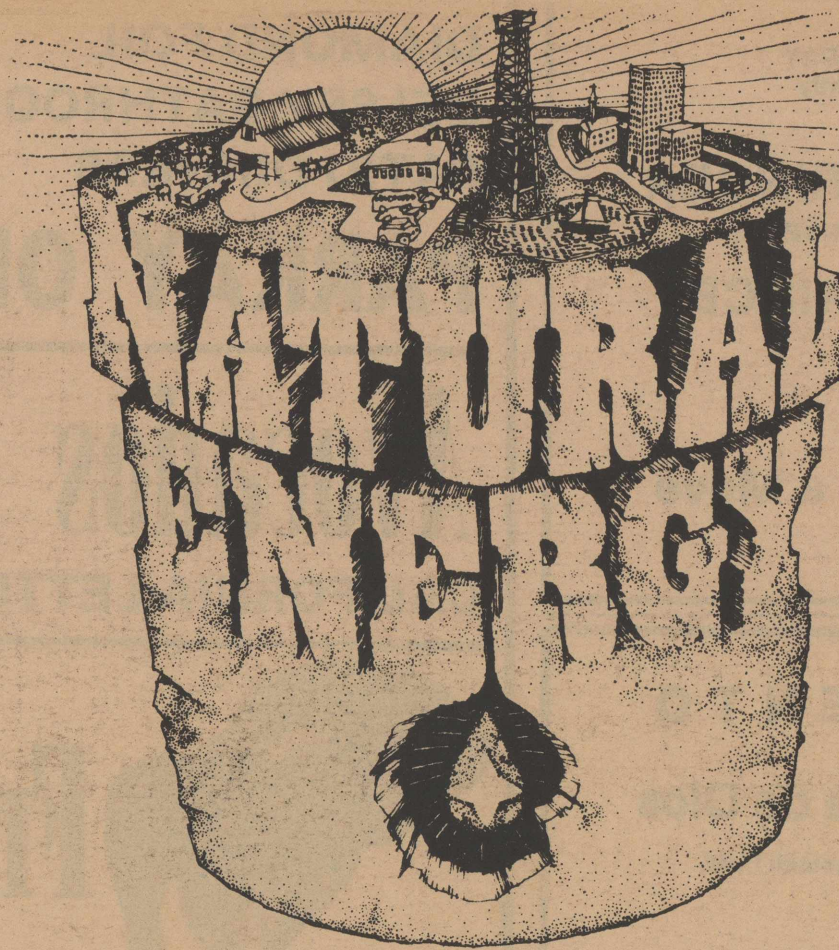
