Even though last week's lead story in this newspaper stated that taxes are not going to be raised to the amount listed on the form which property owners would pay if the tax rate were the same as last year, there is an official meeting coming up for every taxing unit which entice taxpayers to be present and participate.

Judge Sims said the court will make a thorough study of each company's plan before a decision is reached as to who will serve Coke County.

The commissioners spent considerable time working on the budget for next year, Judge Sims said. "we are trying our best to keep the amount of taxes about the same as last year.' he said.

Sims said his office is still receiving lots of inquiries from concerned citizens who received notices last week showing the new valuations which have been placed on all property in the county. He said there is no way the new tax rate can be determined until after the county equalization board meets and reaches a final decision on valuations.

When the total valuation for each taxing entity is determined, and the budget requirements of each have been decided, "then and only then can we know what tax rates will be," Judge Sims said.

He did point out, however, that any taxing unit cannot raise its total tax take by more than three per cent without notifying all the affected taxpayers. A three per cent raise on county taxes would amount to approximately one cent per \$100 valuation, the judge said.

Tax Cut: On The Books

Of all the lobbying, organized demonstrations, promises and protests in the 24 hours preceding the historic tax vote in Congress no voices were heard with greater clarity and impact than yours -- the folks at home.

With your telegrams, telephone calls and personal visits you provided the impetus — the winning edge — to enable us to pass this phase of President Reagan's program for economic recovery.

Because of what happened before the vote — a bold reaffirmation of the November mandate — Republicans and Democrats in the Congress came together and passed a bill to provide a tax cut necessary to offset the massive tax increases so severely penalizing working Americans.

The bipartisan tax reduction program is essential to restore the certainty needed to increase savings, investments and economic growth. And I emphasize, it will put pressure on Congress to continue to hold the line on spending programs.

Restoring incentive to the economy and unleashing the genius of the American people has been the driving force behind the President's program. Key to this effort is an across-the-board cut in marginal income tax rates for everyone.

Cutting taxes is a message to all that we will no longer be penalized for trying to earn a living or for trying to save more of the money we earn.

This tax cut is long overdue. For too long the Federal government has overspent and overtaxed and everyone knows the result: an economic mess worse than any since the Depression.

Remember this tax cut is designed to stimulate the economy. With growth comes a larger tax base and with that more revenues. As revenues increase, while we keep the brakes on Federal spending, we can balance the budget by 1984.

The Conable-Hance bipartisan tax bill provides a full three years of personal tax rate reductions totaling 25 percent across the board. These reductions are permanent reductions, guaranteed to be permanent by the adoption of tax indexing — the annual adjustment of the tax brackets and personal exemptions for inflation. This will end the hidden tax increases that result when cost of living increases push taxpayers into higher brackets. Those hidden tax increases, the so-called "bracket creep," have robbed Americans of every one of the five so-called tax cuts of the last ten years to the tune of \$400 billion!

Spray Pecans For Shuckworm

We have received several calls about spraying to control shuckworm in pecans. Now is the time to spray to control the shuckworm. And, if you had 20% or more shuckworm damage last year, a second application of insecticide in 10 days or two weeks is suggested.

The insecticides that may be used for shuckworm control are guthion or zolone. If you are having a problem with aphids (honeydew) then I would suggest the zolone. It is a pretty good all purpose spray.

Several people have called about nuts shedding. This is an age old problem that can occur almost anytime from the nutlet stage through August. Some form of stress or a combination of stresses can cause pecan trees, particularly those with a heavy load of nuts, to shed. The water stage that the nuts just passed through is one of the more common times for pecans to shed. Some combination of heat, not enough water, insect damage, zinc deficiency, nitrogen deficiency, disease of too much water can trigger the trees to free themselves of the burden of producing fruit. Lately aphids and heat stress have been contributing factors, and if your tree has or had a heavy crop of nuts, ample water before the stress hits is a must. This is particularly true on young, growing trees.

THE PEACHTREE BORER

The Peachtree borer, can be one of the most destructive insect pests of peaches in Texas. Damage occurs as a result of the larvae feeding around a tree's base just under bark. Severe infestations reduce tree vigor and can kill a tree if allowed to continue uncontrolled for several years. Populations that average more than one larva per tree should be treated, Control is achieved with a single late August application of insecticide if Lorsban (R) is used.

Peachtree borer eggs are laid on the bark near the soil line of a peachtree. Hatch occurs in about 10 days. Newly emerged larvae bore into and feed in the bark cambium for 10-14 months. Mature larvae migrate from the tree out into the soil for a distance up to 12 inches and form a bullet-shaped puparium just below the surface. difference! Every few years I have to get on my soapbox and reeducate raiers on the right names of the products they produce. Having grown up in a family of registered Angora goat breeders, it is surprising and little disconcerting to hear well-educated folks aot refer to their animals correctly.

Last weekend at Junction while attending the largest Angora bucks -- "billies -- and Angora does -- "nannies". These terms are incorrect.

According to publications on the Angora goat, put out by the Texas Agricultural Extension Service, the male animal is properly called a BUCK and the female, a DOE. The same is true of the promotional booklets on the Angora, published by the American Angora Goat Breeders Association. Webster's New World Dictionary gives the definition of "buck" as, "a male goat, rabbit, etc.; the female is a doe."

Now, for those who don't know by now, the colorful, straighthaired Spanish goat of our parts are referred to as "billies" and "nannies", and those terms are correct.

One of the most beautiful of domestic animals, the Angora goat has a history older than the written records of man. Mohair from Angora goats was used during the time of Moses, according to the Bible, "and archaeologists have discovered that mohair was one of the first textile fibers used by man.

The first Angora goats imported to the United States were two bucks and seven does, gifts from

The Extension Service has recently published a bulletin entitled, "The Sodium-Restricted Diet."

Many people who are being treated for hypertension (high blood pressure) are prescribed a sodium-restricted diet.

and baking powder are rich in sodium? Foods from plants contain less sodium than foods from animals.

In Coke County, the sodium content of our water is a factor that is often forgotten when planning sodium intake.

Research has demonstrated that a single late August application of the insecticide Lorsban(R) will effectively control the peachtree borer. It is applied at a treatment rate of 5 teaspoons Lorsban(R) 4E per gallon of water or quarts of Lorsban(R) 4E per 100 gallons of water (3 lbs. active ingredient per 100 gallons water). Treatment is made by thoroughly wetting the base of each tree (about 1/2 - 1 gallon) with the spray misture.

the Sultan or Turkey to Dr. James B. Davis of Columbia, South Carolina. In 1900, the Angora goat industry had grown to such an extent that a registry association was needed.

The American Angora Goat Breeders Association was organized then to keep records showing pedigrees of all purebred Angoras and to issue certificates or registration. Today, the United States, Turkey and South Africa raise nearly all the Angora goats in the world. Texas ranchmen have over 90 percent of the Angoras in this country, according to Fred Campbell, executive director of the Mohair Council of America.

The terms, "billy goat" and "nanny goat" are colloquialisms, according to "Webster". They are used in "familiar conversation, friendly letters, or informal speeches," but they are "unsuited to formal speech or writing." And, these terms are generally used, as 1 mentioned, in describing common or Spanish goats.





ORDINANCE

AN ORDINANCE AMEN DING AND CHANGING A FRANCHISE ORDINANCE EN-ACTED BY THE TOWN OF ROBERT LEE, COKE COUNTY, TEXAS, ON OCTOBER 1, 1963 AND BEING PARTLY STYLED, "AN ORDINANCE GRANTING TO LONE STAR GAS COM-PANY, A CORPORATION, ITS SECCESSORS AND ASSIGNS, A FRANCHISE TO FURNISH AND SUPPLY GAS TO THE GENERAL PUBLIC IN THE TOWN OF ROBERT LEE, COKE COUNTY, TEXAS''; AND PRO-**VIDING FOR A MODIFICATION** OF THE DEFINITION OF THE TERMS "SERVICE LINES" AND "YARD LINES" REFER-**ENCED IN SECTON 4 THERE-**OF.

BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF ROBERT LEE, **TEXAS:**

SECTION 1. As of the effective date of this amendatory ordinance, and upon acceptance by Lone Star Gas Company of the provisions hereof, Section 4 of the aforesaid captioned franchise ordinance enacted on October 1, 1963, shall be stricken, cancelled and nullified and there shall be substituted in lieu thereof a new provision reading as follows:

"SECTION 4. In addition to the rates charged for gas supplied, Company may make and enforce reasonable charges, rules and regulations for service rendered in the conduct of its business including a charge for services rendered in the inauguration of natural gas service, and may require, before furnishing service, the execution of a contract therefor. Company shall have August 14, 1981

the right to contract with each customer with reference to the installation of, and payment for, any and all of the gas piping from the connection thereof with the Company's main in the streets or alleys to and throughout the consumer's premises. Company shall own, operate and maintain all service lines, which are defined as the supply lines extending from the Company's main to the customer's meter where gas is measured by Company. The consumer shall own, operate, and maintain all yard lines and house piping. Yard lines are defined as the underground supply lines extending from the point of connection with Company's customer meter to the point of connection with consumer's house piping."

SECTION 2. Enactment of this amendatory ordinance shall in no way ever be construed so as to diminish or impair any consumer's ownership interest in service lines (or portions thereof) installed prior to the effective date of this amendatory ordinance.

SECTION 3. The terms and provisions of this amendatory ordinance shall be deemed to be severable, and if the validity of any section, sentence, clause or phrase of this amendatory ordinance should be declared to be invalid, the same shall not affect the validity of any other section, sentence, clause or phrase of this amendatory ordinance.

SECTION 4. Except as heretofore and hereinabove changed and amended, the terms, provisions, conditions and requirements of the aforesaid franchise ordinance shall remain in full force and effect.

ordinance shall become effective as of May 15, 1981 if the Company files its written acceptance of the provisions of this ordinance within sixty (60) days after its final passage and approval by this City and upon acceptance, the provisions hereof shall be binding upon City and Company, their successors and assigns.






