#### Grants under review

Mayor Victor Leal of Muleshoe will meet on May 22 with the other 12 statewide Community Development Review Committee members to review funding recommendations for \$49.2 million worth of grants to rural Texas communities. Leal was recently appointed to the board by Gov. Rick Perry.

The Committee is charged with providing advice on the administration of Office Rural Community Affairs' (ORCA) Texas Community Development Program and reviewing applications submitted for funding through the program.

"These grants are very important to rural communities," said Robert J. "Sam" Tessen, ORCA's Executive Director.

### Lady Mules finish eighth in state competition

The Lady Mule track team left a highwater-mark on the walls of the University of Texas' Mike A. Myers Stadium in Austin. They finished eighth in the state team competition with 24 points. Sixty-nine girls teams from class 3-A schools were represented in the state meet.

The Lady Mules were in the hunt for the state championship through the 1600meter relay. Muleshoe had 20 points going into the final event of the day and none of the meet leaders at the time had a 1600 relay team.

Celina, Robinson and the Lady Mules each could claim the championship with a first place finish in the 1600 relay and the Lady Mules needed Celina to finish no better than third.

Celina and Robinson both ran sub-four minute times and the Lady Mules finished in fifth place with 4:05.53. It was the best time of the year for the Lady Mules and set a new Muleshoe school record in the 1600-meter relay.

Eva Pylant led off for the Lady Mules and recorded her best split time of the year of 62.45, handing off to Brandi Wood in 1 pack. Wood was in fifth place going into the first curve and almost matched her regional time with a 62.38.

Wood gave the baton to Sara Benham, but a second leg runner from Ingleside stepped in front of Benham causing her to lose precious moments, dropping the Lady Mules to sixth place as the third lap be-



### **Property Tax Protest and Appeal Procedures**

The law gives property owners the right to pro- the evidence you plan to present. The hearing will test actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

the market or special appraised value placed on your property

· the unequal appraisal of your property the inclusion of your property on the

appraisal roll any exemptions that may apply to you

the qualification for an agricultural or timber appraisal

the taxable status of your property

the local governments which should be taxing your property

the ownership of property the change of use of land receiving

special appraisal

any action taken by the chief appraiser, appraisal district or appraisal review board that applies to and adversely affected you.

### **Informal Review**

Review by the Appraisal Review Board

If you can't resolve your problem informally with the county appraisal district (CAD) staff, you may have your case heard by the appraisal review board (ARB).

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the CAD to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. If necessary, you may request a hearing in the evening, Saturday or Sunday. Prior to your hearing, you may ask to review the evidence the CAD will use to uphold their determination. The CAD may ask you for a copy of Texas 78711-3528.

be informal. You or a designated agent may appear in person to present evidence or you may send notarized evidence for the ARB to review at your hearing. The CAD representative will present evidence about your case. You may cross-examine the CAD representative. The ARB will make its decision based on the evidence presented. The CAD has the burden of establishing the property's value by a preponderance of the evidence presented. You can get a copy of a protest form from the appraisal district office at Bailey Central Appraisal District

302 Main St., Muleshoe, Texas 79347 Note: You shouldn't try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they haven't talked about your case before the ARB hears it.

**Review by District Court** 

After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal to district court. If you choose to go to court, you must start the process by filing a petition within 45 days of the date you receive the ARB's order.

Tax Payment

If you appeal and your case is pending, you must pay the lesser of the amount of taxes due on the portion of the taxable value not in dispute or the amount of taxes due on the property under the order from which the appeal is taken.

> If you believe the appraisal district or ARB should have sent you a notice and did not, you may file a protest until the day before taxes become delinquent (usually February 1). The ARB decides whether it will hear your case based on evidence about whether a required notice was mailed to you.



eral." she said. "Buck always brings back such interesting historical items from the auctions we attend that I decided to have a special section dedicated to history."

To fill up the estimated five times of extra space the new store will have as compared to the present location, Carolyn plans to expand on all of her merchandise. For example, she now has about 50 purses at the Second Street location and plans to carry over 350 at the new place.

"I'm expanding on everything — Christmas merchandise, furniture, antiques, life-size bronzes, ewelry, men's gifts, baby's gifts, bridal gifts and westrn items - everything," she said excitedly.

The new store will also have an expanded religious area and a bistro-like area to sit and enjoy cappucino, tea and dessert.

"We're utilizing four rooms that the previous tenant didn't open to the public. Those new areas will be utilized for ornaments, men's gifts, music boxes and books," said Carolyn.

Physical changes to the interior include new red carpet, painting, three new mosaic areas and a large, newly built bathroom. The Main Street display windows have been restored and two areas will have hardwood floors, an original feature of the St. Clair building which was opened in the early 1930s.

All work on the building is being done by local crews, the Johnsons and Carolyn's sister, Elaine Case. The Johnsons and the St. Clairs are sharing financial responsibility for the renovations.

Although only leasing the building right now, the Johnsons do have the option to buy after their 18-month lease is up.

"We want to make our new location a real showplace, and we hope everyone comes to see us," said B. Johnson.

According to Carolyn, the

most important things that make her business successful won't change - her pricing and selection. "We're keeping our prices down because that's important to people and we're planning to have an even bigger and better selection of really unique merchandise," she said.

The board also approved purchasing a new schoolwide software and hardware accounting system for the school food service. District Business Manager Trae McNeill said the current system was "from the dark ages." The cost of the new system is \$21,000. McNeill said the profit of this year's food program would almost pay for the system.

McNeill also recommended that the board purchase new warmers, one for the high school, one for hire David J. Dominguez of Dillman Elementary and one for DeShazo Elementary. McNeill also recommended to the board that they purchase a new steam table for the high school. The total cost of the new equipment is \$30,000.

McNeill told the board after the remodel on Dillman and purchasing the food service equipment, the district

would still have \$5,050,000 in fund balances.

The board tabled a decision on a new high school grade ranking system until

The board voted to endorse board member Cindy Purdy for a position on the board of the Texas Association of School Boards.

The board accepted the resignations of Ronnie Jones, assistant principal of Watson Jr. High School, and Bob Graves, who taught at the high school for forty-five years.

Dominguez is currently employed in the Abilene school system as an assistant principal at Lincoln Middle







### A Genuinely Good Book Points Toward Genuine Love

How many hours of really fine discarded, but as marvelous entertainment does it take to trump untold hours of really worthless stuff? I don't know. But I'd like to recommend a wonderful book, all the more special to me because it was written by a longtime family friend whose father spoke at the graveside of my own father, and this book is delightful. It's by Tom Williams, and it's called The Crown of Eden.

The book centers on the unfolding of a wonderful prophecy involving the marriage of the prince and princess of two kingdoms. At first the prince doesn't know he is a prince, and both he

and the princess are presented with other potential and desirable suitors. Lots of twists and subplots sweeten the plot as the royal pair, unbeknownst even to themselves, search for each other.

Let me share a passage that caught my attention. Hollywood and our society says, regarding the love of a man and woman, meet at a bar, head home, crawl beneath the sheets, and there'll be no devil to pay, ignoring the fact of a better than one in three chance of catching a really repugnant disease and a one hundred per cent chance of having to deal with unpleasant consequences.

Tom writes of Bogarth the blacksmith, that he'd taught his son, Aradon, "to look at women not as fortresses to be stormed and sacked, or as fruit to be plucked and devoured, the core

creatures of immense value, to be honored, wooed, and won courteously and gently. One must build trust, confidence, love, and commitment before tasting the ultimate intimacy."

Aradon was a very normal young man in every way, but he had resolved, not because he disdained love but because he wanted the real thing both for himself and the one to whom he would pledge his love, that "his body would not enter where his mind and heart had not opened the way." To follow mere lust "to pleasure would be a lonely, isolating, selfish thing rather than intimate sharing. He would be using her body merely to satisfy himself. Moreover, she would know that she was nothing more to him than an instrument of pleasure" which "was why so many illicit lovers loathed each other after their lust was spent. They loathed themselves for their own slavery to appetite, and the partner was a mirror in which they saw this truth unmasked.'

Bogarth went on to tell his son that "The writer of the Eden story was not just bein' careless with words when he said that 'Adam knew his wife, and she bore a son.' He didn't just use his wife; he knew her as he knew himself. Their souls and spirits were one, and it was neither an intrusion nor an act of selfishness for him to 'go in unto her.' Their bodies participated in the knowledge their hearts already shared.'

And there is more truth and more genuine warmth and deep love in that than in a thousand steamy Hollywood lust scenes. It's love. And it makes all

counterfeit substitutes look cheap and shabby.

### Volunteer firefighters to receive assistance



Benham was able to make up ground and precious time on the leaders with a 60.4 lap and moved into fifth place as she handed to Jessica Withrow for the final 400meters. Withrow posted a 60.3 split to hold on to fifth place and add four points to the Lady Mules' total.

Withrow had jump started the Lady Mules quest by taking the gold medal in the high jump on Friday afternoon by clearing five feet seven inches. Withrow kept the pressure on the field by clearing each height through 5-5 on her first attempt.

She began the event jumping in second position behind Lean Markert from Yoakum. Markert did not clear the opening height of 5-0 and gave Withrow the first attempt at each subsequent height.

Only four competitors remained at 5-5 and Withrow and Becky Christensen of Celina managed to clear the Withrow Christensen both missed on their first try at 5-6, but Withrow cleared on her sec-

Christensen had cleared 5-6 only twice during the season and succumbed to the pressure of the state meet. Withrow went on to jump 5-7 on her second attempt, but failed to match her season best and Muleshoe school record height of

"I really felt I could have made 5-8 if I could have had one more run through," said Withrow immediately following her win. "But I only had five more seconds to make the jump and I knew I had to go ..... I know I could have made it with one more

attempt."

"I was a little nervous at first, but after the first couple of jumps I felt like I was at any other meet. I just tried to concentrate on what I was doing," concluded Withrow.

"Jessica was awesome," said Muleshoe track coach Benji Jay. "She seemed very calm, especially for a sophomore in her first state meet. After her first few jumps I felt like she was on today and she really put the pressure on the other girls. I really thought she had 5-8, but she just grazed the bar."

Saturday afternoon at 12:55 Withrow placed fifth in the 100-meter hurdles with a time of 15.33. Her season best and school record time of 15.31 was at the Eagle Relays in Canyon.

Withrow had a 90-minute break before returning to the track to take her second medal of the meet. She set a new Muleshoe record of 45.05 in the 300-meter hurdles to take the silver medal with a strong finish to edge out Kim Ballenger of Tatum with a 45.15.

"It really made me mad that I did not finish higher in the 100-hurdles. It just made me try harder in the 300," said Withrow after winning her silver medal.

Excitement began to build for the almost 100 Lady Mule track fans in Myers Stadium as they began to do the math in anticipation of the 1600-meter relay. Withrow had set the Lady Mules up for a possible state championship by scoring 20 points in her first three events.

### Local gymnasts compete for trip to regional meet
