### RL Catholics Plan To Serve Mexican Food

Mrs. Ettie Hubbard, deputy county clerk, has filed for the office of county and district clerk. She is seeking the position now held by Mrs. Waldrop, who has stated that she will not run for reelection.

Mrs. Jerry Thomason has filed for reelection as county treasur-

East side commissioners are up for election this year and the incumbents, Bobby Vaughn of Precinct 2 and Jerry M. Parker of Precinct 4, have filed for reelection.

This is also the year for justices of the peace to be elected. Up to Wednesday, Earl D. (Pete) Nutter of Precinct 4 was the only one of Coke County's four JP's who had filed with the county clerk.

Rumors are circulating that there will be other candidates come out in the next few days for county and precinct offices that are to be voted on this year.

In other business, the commissioners authorized Couty Judge D.W. Sims to check on prices of an incinerator for use in burning courthouse trash. The move was made after the presently-used burning equipment blew out into the street during a recent high wind. Judge Sims said the present equipment is both dangerous as a fire hazard and presents an eyesore in the courthouse area.

### Sheritt Likes Quiet Holiday



#### Mrs. McBroom Writes About to Guadalajara, Mexico Trip

On November 18, at 4 p.m. the Mexicana Airlines plane finally left San Antonio only one hour late. There was nothing wrong; the airplane was simply late. I really wouldn't have minded, except they had told me to be at the air port 11/2 hours before flight time and I felt like 21/2 hours was a little longer wait than was justified. Anyway the flight was beautiful. We apparently crossed the Rio Grande at Laredo, because there was a city at the head of an enormous lake. Soon after, we were over the Siera Madres del Oriente and the city of Monterrey. After that we could only guess where we were because the captain told us no more. At least if he did it was in Spanish and I could only catch isolated words.

It's hard to describe the sense of loneliness you feel when there is no one to whom you can talk or who can talk to you. I had just a glimpse of the frustrations that must be felt by Mexican children when they come to our schools, or older people who have a stroke that leaves the mind clear but destroys the ability to communicate. However the scene below was so overpowering that we managed by signs and just a smidgen of English and Spanish to enjoy the ride together. The Spanish speaking young man beside me was from New York and was traveling this way for the first time. He was so excited that he stood up a good part of the way to watch the mountains. towns and cities below.

Anyway we arrived in Guadalajara about an hour late (there was no way to make the time up. but at least we didn't delay any

It was a great relief to me to see Foy Dell and Chella Smith at the airport to meet me. The delay really shouldn't have worried me so much, because I knew they'd been here long enough to know Mexico - the Manana land

Zapotlanejo, where Fox and Chella live, is about 20 kilometers (15 miles more or less) from Guadalajara, so it was almost dark by the time we reached

home.

Chella teaches English in an American school in Guadalajara. and has to leave home about 6 a.m. to catch a bus, so we didn't stay up very late - a very un-Mexican way to do. Having had a siesta, the nationals are up until all hours.

November 19, my first full day in Mexico left a lot to be desired. It was market (Mercado) day in Tonala, a village famous for its pottery, and Foy and I planned to go there, then meet Chella in Guadalajara when her school turned out. First, Foy had business to attend to in Zapotlanejo. This is a fairly typical Mexican village with rough (very rough) cobblestone streets; houses built right along the sidewalks; balconies; the plaza; church; and all those things usually associated with Mexico. Of course I took pictures here and there. But one thing really intrigued me - the system of delivering milk. A man was riding down the street on a little burro with 5-gallon milk cans tied on each side behind him, 2 fore and 2 aft. If a woman wanted milk, she came out with her container. The milkman opened one of his cans and used a 1-liter dipper to measure out her milk. Now you may be sure I tried to get a picture of that! And there the trouble began... A man on the sidewalk began to make terrible grimaces at us and shake his fingers at us and jabber a bunch of stuff of which we understood not a single word. He must have put a hex on us. for the rest of the day was one disaster after another

In Tonala all was gaily decorated. The street vendors were out in full force with their booths displaying their wares - everthing from food cooked on the premises, to clothing, pottery, fancy embroidery, leather goods, fresh produce, plastic toys, homemade toys, and even a peddler of needles. We made our way through all of this, stopping to examine whatever took our fancy. Finally we reached the corner of the plaza and went into the bank to change some of my money into pesos so I could buy some

souvenirs - if any caught my fancy. Then we were back wandering through the markets again. Of course I was stopping now and again to shoot pictures. Then suddenly, for no reason 1 know, I checked my purse and found my billfold missing. You can't imagine the devastation I felt. When or how my purse was picked I don't know. I do know there were two billfolds, a coin purse, and another small case in the purse - so how did the pickpocket know which one had money unless he followed me from the bank? I had not had it out since then. One thing I was thankful for even at the time. My passport and visitor's permit were not in the billfold and so were safe. It was much later before I realized that my driver's license had been with my money. (I had intended to leave it in San Antonio, but forgot to do so). My credit cards I had left at Robert

We ate at one of the booths, then started into Guadalajara to pick up Chella at her school. Suddenly, on one of those busy narrow streets Foy felt a tire going down fast. By the time he could get the jack the tire was completely flat - and the jack wouldn't raise the car enough to change it. Finally, with the help of a Mexican and some boards from the trash beside the street, we got it propped and jacked up enough to change the tire. It looked like we were going to have trouble making connections at Chella's school, but she was a little bit late, too, so everything turned out fine.

After we got home, I realized that I had failed to change the ASA reading on my camera when putting in new film, so I didn't get a single picutre of Tonala. In a way, I don't really mind.

Somehow it leaves a bad taste to think of that place anyway.

This 20th day of November has to be a better day than yesterday! We left early this morning to go to the mountains. Guadalajara is about 5000 feet high in hilly country and is quite pretty, but we were going to higher ground a different terrain altogether.

I don't know exactly where the place was (there are many Mexican villages not shown on the maps) but somewhere between Zamora and Carapan we could see steam or white smoke rising high into the air. Investigation showed it to be a geyser much higher than Old Faithful in Yellowstone, and with a major difference. Where Old Faithful spews and rests, this one puts out a steady stream of steam and water. It has been harnessed by the Mexican government to produce electricity... As there was no way we could understand what we were told, we could learn very little about it, but it was both beautiful and interesting.

Not many miles from the Geyser, but after turning south at Carapan we saw the road leading to Paracutin, the volcano born not too many years ago in an Indian's corn field, and which covered all his village except the church steeple. We didn't go to see it, because it requires a 2-hour horseback ride; but we did see a large white cloud over a peak in the right direction. If that was not Paracutin, then it certainly was a big geyser or geyser basin!

Our destination for the morning was a National park at Uruapan. It is a beautiful park built along a stream with a succession of springs and waterfalls. We watched a man diving from a high bluff into the basin below one of the falls; we ate sopas (fat little corn tortillas filled with a choice of meat, beans or cheese, fried in deep fat, then filled with salsa) at a trailside stand; we visited with a group of widows, 36 in all, who were touring Mexico in a bus. (Foy told me later that the Mexican people really like to find someone to practice their English on.)

Leaving Uruapan, we climbed steadily into the higher mountains until the unfamiliar trees were replaced by pines. Soon after going through an 8100 foot pass, we came into sight of Lake Pazcuaro. In the middle of this lake is an island city, janitzio, so steep that there are no wheels used. There, also live the Tarascan Indians who fish with those "butterfly" nets shown on nearly all the Mexican travel posters. On top of the island is a statue of one of their heroes that is taller than the statue of liberty.

### Museum Committee Organizes

The recently appointed executive committee for the Coke County Museum met to organize on Tuesday afternoon, Jan. 5, in the court house at 3:30 p.m.

Earlier in the afternoon the old jail building, which houses the museum, was opened to members of the committee to enter and examine before the meeting in the conference room at the court house.

The executive committee for the museum was set up by the Coke County Historical Commission in their November meeting and it consists of seven members, three of whom are officers of the commission and four are not members of the commission.

Officers of the commission who serve on this committee are Ulmer Bird, Mrs. Diane Luckett, and Mrs. Marie Arrott, chairman, secretary, and treasurer respectively. Committee members not members of the commission are Bascom Chesney, Mrs. Marie Ferguson, Mrs. Joan Davis, and Miss Mary Anne Lackey.

A week after this committee held this, their first meeting, will be a combined December-January meeting, also in the conference room and at 3:30 in the afternoon, of the Coke County Historical Commission, prepared to confer with the executive committee for the museum on anything in the nature of a suggestion, idea, or question the executive committee may bring before them, and to confer and take action on the next steps to be taken.

In the meantime, anyone interested may feel free to bring your own individual ideas to the attention of any member of this committee for consideration.

Those who want to have the museum opened up on a going and permanent basis now have the machinery to work, and to give everyone willing to have a part in it.

The Coke County Historical Commission is officially set up as an arm of the county government in such matters. The resolution by which the Historical Commission set up this executive committee provides that sponsorship of the museum by the historical commission is to be only so long as it is necessary for the executive committee to develop into a museum association which can elect its own officers and manage its own business.

mission is tax exempt, and it is expected to take the most of 1982 to form and qualify the Coke County Museum Association to do business as a non-profit organization.

In the resolution that set this up, the Coke County Historical Commission by unanimous vote of these present voted to sponsor this executive committee and the project to help get it organized and functioning.

It is expected that these two meetings in January will offer a workable plan and program for doing this. It's not expected that the commission will manage the museum, but will assist until an association can be formed for that purpose, legally qualified and with enough membership and support to do it.

## Interest On Credit Sales Is Taxable

State Comptroller Bob Bullock said Wednesday that about 1,000 Texas merchants need to be aware of new sales tax requirements on credit sales which go into effect Jan. 1.

The new law affects merchants who make installment sales of taxable items, include the amount of sales tax due in the outstanding balance and keep their books on the "cash" basis of accounting.

According to the new law, a part of the interest paid on the sales tax portion of credit sales will be taxable. This additional amount is to be reported and remitted when the regular sales tax return is filed.

If the interest on the sales tax and the unpaid balance are the same--and the rate is 18 percent of less--the state gets half the interest on the sales tax portion of the total amount being financed.

If the rate is more than 18 percent, the state gets all interest on the sales tax amount above 9 percent. For example, a merchant charging 20 percent interest on credit sales will remit 11 percent interest on the sales tax amount to the state, assuming the rate for the sales tax portion is the same as for the rest of the unpaid balance.

If the interest charged on the sales tax portion of the bill is different from the rate charged on the rest of the unpaid balance, the merchant must remit all of the interest paid on the sales tax portion to the state.

Taxpayers with questions about their new responsibilities should contact the Comptroller's local office nearest them or the Comptroller's Sales Tax division at 1-800-252-555, a toll-free call from anywhere in Texas.




