

# WTU Awarded Rate Increase

A settlement agreement allowing West Texas Utilities Company to increase its rates to retail customers has been approved by the Texas Public Utility Commission of Texas.

Bronte City Secretary Pat Martindale reported that the city council allowed WTU an 8.25 per cent increase. Robert Lee city council had voted to abide by the decision of the PUC.

The new rates, which will average about 8.3 per cent above the old rates, were placed in effect on Friday, Feb. 12. This action is in accordance with a stipulated agreement with all intervenors, including cities represented by the Texas Municipal League, WTU and the PUC staff.

The increase is designed to increase the Company's annual retail revenues by \$11.8 million. A wholesale rate increase of \$5.5 million, also settled by agreement and expected to be approved by the Federal Energy Regulatory Commission in Washington, would bring WTU's total annual revenue increase to \$17.3 million. The Company had applied for a total increase of \$32.2.

The effect on a residential bill for 600 kilowatt-hours of electricity per month would be slightly over 10 per cent. This would include the fuel cost adjustment. For 600 kilowatts at a residence, the bill would be \$37.89 under the new rates and \$34.39 under the old rates.

SAN ANTONIO -- This columnist arrived in the Alamo City Monday to attend and report on the 1982 edition of the stock show and rodeo.

In over 25 years of attending this annual event, I can only remember two years in which the weather was warm. One of those was the first time I attended, when Rex Allen was the star. It was so warm that year, a group of us had a picnic on the river. But most years it was so cold icicles hung around the doors in the sheep and goat barn where I spent most of my time. This is one of those kind of years.

The San Antonio Stock Show is famous for the trail rides. I mean real trail rides that organize early and are on the trails and country roads for a week or more, camping and roughing it. We complain about the cold but most of us have forgotten how really cold it can get when you're in the saddle for eight hours.

This year's trails were filled with over 8,000 horsemen and horsewomen, lead by 11 trail bosses and covering 1,000 miles. All different routes, the rides started all over South and Central Texas and passed through over 100 Texas towns to finish the trail

last Friday. Leading the 28th annual Texas Trail Ride was trail boss Ralph Gertson. The ride was from Hallettsville to San Antonio, with Sonya Weich of Weimer as queen.

In its 23rd year was the South Texas Trail Ride from Robstown Mt. Creek on February 5 with trail boss Howard Stulting. Trail boss Ronnie Morris lead the 21st annual Six Flags of Texas Trail Ride from Victoria to San Antonio.

They came from Cuero, Laredo, Bee Cave, and the Texas Hill Country communities of Stonewall, Bandera, Bastrop and Kerrville.

It's quite a sight to see all these 8,000 cowboys and cowgirls arriving, their chuckwagons and other traveling wagons bringing up the rear of each outfit. The colors of their different riding club uniforms finishing off with hats, boots and chaps along with the beautiful horses, every color too, add so much to this annual event deep in the heart of Texas.

Certainly, as spectators attend the stock show and rodeo here and walk across the large fairgrounds and exhibit halls, coli-

seum and many livestock show barns, they realize the parade of trail riders are just another part of the overall success of the show. For example, the Southwest's largest Western Art Show is part of this annual event.

The stock show's livestock judging results and the blue and other ribbons won by thousands of youths here every year represent many months of feeding, grooming and preparation. The same goes for all the professional cowboys who ride the broncs and bucking bulls, rope the calves and ride barrels. It's a big production and one the folks of Bexar County can truly be proud of.

#### SOME INTERESTS RATES **DOWN, OTHERS RAISED**

**WASHINGTON--The Farmers** Home Administration, the rural credit agency of the U.S. Department of Agriculture, has reduced some of its interest rates and increased others, Administrator Charles W. Shuman said today.

The rate for insured operating loans was reduced to 14.25 percent from 14.50 percent; limited resource operating loans were lowered to 11.25 percent from 11.50, and the limited resource loan rate was reduced to 6.625 percent from 7.

Shuman said the reductions were made because the interest rates are based on the cost to the U.S. Treasury of borrowing money, and short-term interest has been declining.

Rates for two other loan programs, which are based on the costs of comparable loans in the private market, were raised to 16 percent from 15 percent. Those were for annual production loans and operating adjustment loans under the disaster emergency program.

Nearly 25 percent of the households in the U.S. currently own microwave ovens. By 1985, it is expected that over 50 percent of the households will own one.

A look at energy consumption statistics shows that microwave ovens are energy conserving appliances.

Household energy is about 20 percent of the total energy used in the U.S. in Texas, home heating and cooling accounts for 48 percent of household energy used, cooking is about 7 percent.

Laboratory studies, in which a week's meals for a family of four were prepared and where the microwave oven was used in conjunction with the conventional range, resulted in savings of 25 percent. Savings of over 50 percent occurred when the microwave oven was used in place of the conventional oven or broiler.

The Houston Show also provides an opportunity for exhibitors to participate in some of the toughest of showring competition after a year's worth of preparation for their animals. This year's show once again promises to be profitable for them as open show and junior exhibitors will vie for more than a half a million dollars in prize monies and premium auction prices above market value.

Houston, the fastest growing city in the nation, brings western heritage to life when it once again hosts this two week extravaganza. Livestock show dates are Feb. 20-Mar. 7, and rodeo dates are Feb. 24-Mar. 7.

The largest civic event in the history of the nation's fourth largest city inspires local business people and residents to take to horseback and buckboard, or at least wear western hats and boots, all in the Old West spirit of "Going Texas."

ASU Offering Carr Academic Scholarships

Applications from high school seniors are being accepted by Angelo State University for more than 300 Carr Academic Scholarships which may amount from \$2,400 to \$12,000 during a fouryear course of undergraduate study for students with financial need who have outstanding academic ability and leadership qualities.

The applications for 1982-83 scholarships may be requested by writing to the Carr Academic Scholarship Program, Office of the President, Angelo State University, Box 11007-C, ASU Station, San Angelo, Texas 76909, or by telephoning (915) 942-2103.

Students are encouraged to submit their applications as soon as possible although applications from outstanding students may be considered up until July 1, 1982 to the extent funds are still available.

Supported by a multi-million dollar trust established in 1978 by Mr. Robert G. Carr of San Angelo, the scholarships will range in value from \$600-\$3,000 per year for a maximum of four years from undergraduates, two years for graduate students.

In selecting recipients for Carr Academic Scholarships, priority will be given to students of high academic ability with financial need who have demonstrated special qualities warranting honor, respect, and esteem. Carr Academic Scholarships are awarded without regard to race, color, religion, age, sex, or national origin.

Scholarships may be renewed annually. In order to be eligible for renewal, a Carr Academic Scholarship recipient must maintain a minimum of a "B" average (3.0 GPA) on all course work attempted while enrolled as a fulltime student and must maintain an exemplary personal record which demonstrates that he/she is worthy and deserving of renewal of the scholarship. said. Secretary of Agriculture John Block recently announced acreage reduction programs for wheat, corn, grain sorghum, barley, oats, and upland cotton.

"To be eligible for loans and target price protection farmers must sign up and comply with the acreage reduction program requirements," Mathers said.

For reducing their wheat acres by 15 percent, farmers will be eligible for the \$4.05 per-bushel 1982 target price for wheat, a regular loan rate of \$3.55 per bushel, and a grain reserve loan rate of \$4.00 a bushel.

Farmers who reduce their feed grain acreage by 10 percent will receive federal target prices of \$2.70 per bushel for corn; \$2,60 for sorghum and barley; and \$1.50 per bushel for oats. They will also be eligible for loan rates of \$2.55 per bushel for corn; \$2.42 for sorghum, \$2.08 for barley, and \$1.31 per bushel for oats.

According to Mathers, 1982 wheat and feed grains will be eligible for immediate entry in the farmer-owned grain reserve. Feed grain reserve loan rates are \$2.90 a bushel for corn, \$2.75 for sorghum, \$2.37 for barley, and \$1.40 per bushel for oats.

The upland cotton program offers farmers a target price of 71 cents per pound and a loan rate of 57.08 cents per pound for reducing their cotton acres by 15 percent.

"The acreage reductions and higher loan rates will help strengthen farm prices," Mathers said. The land taken from production and devoted to conservation uses must be eligible cropland and protected from wind and water erosion.

"Participation in the 1982 farm programs is voluntary. However, only those farmers who take part in the program will be eligible for benefits," the ASCS official said. The sign-up period ends April 16.
