



News From The County Agent

It's time to begin looking for the pecan nut casebearer in the small nutlets. Normally the first generation of casebearers begin invading the nutlets in Coke County around May 25. We are not certain yet, but the anticipated date will be very close to May 25.

John Begnaud, Tom Green County horticulturist, is banding pecan trees and trapping the casebearer moths. Based on his findings to date, he is estimating the spray date to be between May 24 and May 27. Based on temperatures recorded, the pecan specialists are predicting May 25 to May 27 for this area.

I checked pecans in eight locations in Coke County on May 17. I found no eggs, but did find three hatched casebearer larvae in one area. This is not unusual. Almost every year one or more moths will begin laying eggs well ahead of the masses. For some reason, she hatched ahead of the group.

I am still thinking around May 25 will be the most optimum date to spray to prevent the casebearer. If you should desire to spray twice, I would suggest you spray May 23 and May 30. We will do more checking next week and can give you a more positive answer next week.

A few hot days could speed up the cycle one or two days; cooler than normal weather could delay

the egg hatch.

The chemicals to use in controlling the casebearer include Malathion, Sevin, Toxaplin, Zolone, or pydrin. If you have had a problem with aphids on your trees, do not use the sevin; use one of the other chemicals.

Pecan strees need 3 to 5 applications of zinc in the spring while they are growing rapidly. Include zinc in with the pecan nut casebearer spray. Use zinc sulfate or NZN to supply the zinc.

In summary, we are still a few days away from optimum spraying time to control the casebearer based on our findings to date. We expect the optimum time to be near May 25.

SSI RECIPIENTS MUST REPORT VARIOUS CHANGES

If you receive monthly supplemental security income payments, you are required to report events or facts which may affect your eligibility or payments. Failure to report changes can result in penalty deductions of \$25 to \$100. In addition to a penalty, failure to report events or facts affecting eligibility or payments may constitute a crime punishable under federal or state law or both. You must notify the Social Security Administration if you move to another address or if someone moves into or out of the house in which you live.

You also are required to notify the social security administration if there are any changes in your income, your spouse's income and/or your family's income. There are several other changes you are required to report. If you do not know what your reporting responsibilities are or to report a change, call write or visit your local Social Security Office. 





There are no specific brands because the salmon was canned under many labels. The following TWO LINE CODE identifies the contaminated product.

TOP LINE OF CODE: Something, K13, something (this means that K13 holds the middle spaces of a 5 space code.)

There are four numbers or letters in the bottom line of the code but they do not identify the contaminated batch. A can of salmon with this code should be returned to place of purchase.


