News From The County Agent

By Sterling Lindsey County Extension Agent-Ag

The cool weather continues to delay and/or spread out the pecan nut casebearer cycle. Based on our findings in Coke County and those of Tom Fuchs, Extension Entomologist, in Tom Green County, the optimum time to spray to control the casebearer Should be May 28-30. We have found eggs on the nutlets that should begin hatching May 27, or May 28. We also found one worm already hatched, but this is from an early hatching moth. Most of the egg hatch should come this coming weekend.

If you should desire to spray twice, we would suggest you spray the 28th, then again five days later.

As we stated in last week's paper, to control the casebearer use Malathion, Sevin, Toxaphene, Zolone, or Pydrin, Include zinc in your spray to help combat rosette.

That is among the predictions in a special report entitled, "Landscape Architecture into the 21st Century," written for the American Society of Landscape Architects by Lane Marshall, head of the Texas **A&M** University Department of Landscape Architecture.

'We think there will be dramatic changes in the look of housing," Marshall said. "The conventional single-family home has already increased in cost well beyond the means of the average American family.'

New household formations caused by changing lifestyles. however, will generate the need for 20 million new units during this decade, Marshall said.

Marshall recently received the President's Medal, considered the top award in the profession. It is given to the landscape architect who made the greatest contribution to the profession on a continuing basis during the preceding five mention years.

Registration for Family Land Heritage Opens

"This year we're hoping to surpass the 1,500 mark in the total number of Texas properties registered in our Family Land Heritage Program," Agriculture Commissioner Reagan V. Brown said recently.

"And we certainly hope individuals interested in history or agriculture in Coke County will help us by bringing as many qualified applicants into the program as possible."

"Ulmer Bird, Coke County Historical Commission chairperson and Coke County Judge Dub Sims, will be working with us on the program," Brown said.

Since 1974, the program has honored 1,443 Texas properties.

The Texas Department of Agriculture (TDA) is entering its eighth year in sponsoring the program which honors "those families that have persevered for a century or more in the cultivation and production of food and fiber," Brown said. "Undoubtedly, these families, with their unfaltering determination have been the backbone of Texas agriculture.

The registration period will extend from May 15 to August

Those who qualify are honored in state ceremonies and receive a certificate and a copy of the Family Land Heritage Registry. The publication has a brief history of each farm or ranch and includes old photographs of the families and homes.

Basic requirements include the following: Continuous agricultural production on the farm/ ranch for 100 years, land ownership within the family, complete operation or supervision of the farm/ranch production by family members who are Texas residents and a size of 10 acres or more with agricultural sales of \$50 or more a year, or if less than 10 acres, sales of at least \$250 a year. County judges must approve all applications.

Persons who meet the basic qualifications and wish to enter can obtain an application from the county judge, county Historical Commission chairperson, the nearest TDA district office, or by writing to Commissioner Reagan V. Brown, Texas Department of Agriculture, P.O. Box 12847, Austin, Texas 78711.





Free enterprise in outer space restricted by treaty

COLLEGE STATION —
The future of American space exploration and colonization is in jeopardy from new treaties that could restrict free enterprise in outer space, says a Texas A&M University economist.

Dr. Larry Wolken, associate director of Texas A&M's Center for Education and Research in Free Enterprise, says economic concerns rather than technological considerations pose the greatest stumbling block to settling space.

Wolken points out the economic potential of further space exploration would be stifled particularly by the United Nations "Agreement Governing the Activities on the Moon and Other Celestial Bodies," commonly called the Moon Treaty.

While fewer than 10 nations have signed the treaty, neither the U.S. nor the Soviet Union have approved the document and are not yet bound by its provisions.

The treaty declares all celestial bodies and their resources the "common heritage of mankind." No nation can claim sovereignty over any celestial body and their resources can't become the property of any nation or person. Wolken claims the treaty prohibits nations and individuals from owning property in space.

Using outside air wisely can reduce energy use for residential air conditioning, says an agricultural engineer with the Texas Agricultural Extension Service, Texas A&M University System. During the spring and fall when average outside air temperatures are comfortable, whole house or attice fans can be used to pull outside air into the home and remove heat. Air flow depends on having windows or doors that will open in each room to admit air. Attic ventilation also helps reduce air conditioning bills during the summer. This calls for outlet vents near the peak of the roof along with the same amount of inlet vents at the eave.



After a number of tries, moisture in one form or another has finally arrived at just about every point in West Texas but Stiles in Reagan County.

Boze Hartgrove, who ranches in the Stiles country, believes if Noah had constructed his boat there, it would never have seen water! "During the drought of the 1950s, we couldn't tell the difference," said Hartgrove.

Well, it's not quite that bad. At least most parts of the West Texas terrain are broken up with pump-jacks every few yards or miles, which give good shade to a number of livestock.

Someone in Ballinger the other night told about another unusually heavy broomweed crop in the making in parts where it has rained. My first instinct was to check on my friends in Sterling County. In the past 15 or 20 years when there was an outcrop of broomweeds in County or the Hill County, they would be as tall and thick as the South Texas bush in Sterling.

Back eight or ten years ago, Dow Chemical's public relations department called me with the assignment to photograph the weeds in Sterling County. They had plans to develop some kind of eradication for broomweeds. My pictures indicated the weeds were as tall as mesquite trees.

Thinking I had doctored the nictures. Dow sent some folks down from the head office in Michigan to have a look at the broomweeds on the Clinton Hodges ranch and others. Ine delegation quickly discovered my camera does not lie. I never heard if Dow came up with a chemical either.

Over the years, natives have found there is little that can be done to hold down broomweeds. It seems they are much more prominent in years where moisture falls at just the right time. This appears to be one of those years. So maybe Stiles will come out the winner after all.

Skipper Duncan, who ranches west of San Angelo, commented the other morning that the weeds this season are most prolific in his well kept conservation pastures. That brings up another subject, somewhat relatead.

Many of us have watched over the years the transition of Duncan's ranch from miles of condensed mesquite thick to a ranch which could now accidentally be mistaken for a national park. Duncan has practiced good soil conservation management with the clearing of some brush and planting different varieties of

He has left strips of brush for game and wildlife. Matter of

fact. I can remember when deer and turkev would not be seen further north than the South Concho River at Christoval. Because of Duncan's and others like the Turners at Water Valley and Angelo State University, wildlife is now plentiful all over Tom Green County.

Something else I couldn't help but be delighted about on the Duncan Ranch was the constant observation of electric fencing and fiberglass rod post. He has developed the Savory type high intensity rotational grazing system to beautiful results.

For more than a year, I have worked with Mike Sheehan and Robert Nickel of Twin Mountain Supply Co. here in San Angelo to promote the use of the new electric fencing systems. I remember my days with the sheep and wool growers when the fencing alone would have turned hundres of coyotes.

Skipper has used electric fencing and sound conservation practices to the utmost degree to not only turn ranching into a profitable profession but protecting and caring for the land and saving it for generations to come. To me, to take something and improve it and leave it better than when you took over is what the good Lord challenges us to do in whatever our assignment is in life.

Mesquite and other brush can best be controlled with liquid herbicides in spring and early summer when soil moisture is favorable and the brush is making rapid growth. Mesquite is best controlled after the leaves have fully extended and have turned from light to dark green, notes a range brush and weed control specialist with the Texas Agricultural Extension Service, Texas A&M University System. Once herbicides are applied, ranchers should follow a good grazing management program, deferring grazing for a least three months after treatment.
