
Fire Dept. Called Out Sun.


BROWNIE SCOUTS, DADS ATTEND CAMP





Lamb, Wool Producers To Vote **On Program Extension In August**

Lamb and wool producers will have an opportunity during an August 16-27 referendum to vote on whether they want the American Sheep Producers Council, Inc., to continue its market b promotion and improvement program on their behalf by entering a new agreement with the U.S. Department of Agriculture.

According to Everett Rank, administrator of USDA's Agriculture Stabilization and Conservation Service, the agreement to be voted on is similar to one approved in 1978, except it would authorize larger deductions from producer incentive payments. By approving it, producers would authorize deductions of up to 4 cents per pound on shorn wool and 20 cents per hundredweight is eligible to vote separately in the on unshorn lambs marketed in 1982. Deduction rates from 1978 through 1981 were 21/2 cents and 12¹/₂ cents, respectively, he said.

Rank also said the new agreement would provide for USDA to withhold part of any wool incentive payments that might be made to producers on 1983-85 marketings to finance the council's promotion activities.

He said deductions would be used by the council to finance advertising and sales promotion programs for wool and lamb, and programs to develop and disse-

minate information on product quality, production management and marketing improvement for wool and sheep.

County offices of the Agricultural Stabilization and Conservation Service will distribute copies of the agreement and ballots to sheep producers in early August. Producers may cast their ballots by mailing or delivering them in person to county ASCS offices by the close of the referendum, Rank said.

Anyone may vote who has owned sheep six months old or older for at least 30 consecutive days during 1982. Votes may be cast by individuals or by cooperatives. Members of cooperatives which cast votes would not be referendum. The agreement requires approval by two-thirds of the total volume of producers, or two-third of the total volume of production represented in the referendum.

90 The National Wool Act of 1954 oprovides the authority for deductions and for promotion activities. Sheep producers have approved the program in each of the seven referendums held since 1954. In the most recent referendum of 1978. 75 percent of the producers approved of the program.







Last month's crop-damaging rain and hail in West Texas, mainly north and northeast of Abilene, have compounded the plight of farmers.

Visiting briefly with U.S. Rep. **Charles Stenholm in Abilene last** week, he said in addition to economic problems such as high interest rates, a major natural disaster now has struck farmers.

Up to 2¹/₂ million acres of cotton are believed to have been lost and cotton farmers have lost \$500 million to \$700 million. Since that money would have been spent and respent in rural economies, the total loss is \$3 billion to \$4 billion, the Stamford congressman said.

"The short-term results are devastating," Stenholm said, adding that the long-term results cannot be fully realized.

In Lubbock, between 30 percent and 50 percent of farmers will quit farming depending on whether relief is given to farmers he said.

A "sick aspect" of the crop failures is that farmers who are able to produce a crop will get a fair price if the economy revives because supply has been brought in line with demand by an act of nature, added Stenholm.

"While some fields in Haskell and surrounding counties remained underwater early last week and farmers were still awaiting word on federal disaster relief, planting and replanting was underway," according to Kent Dunlap, farm editor of the Abilene Reporter-News.

Glenn Brzozowski, Haskell **County Agricultural Stablization** and Conservation Service director, said the situation doesn't appear good, but it looks like farmers may end up replanting as much as 75 percent of the fields damaged less than a month ago. He said some farmers are going, back with cotton while others are planting late grain sorghum.

It seems another problem farmers are dealing with is the tremendous soil-washing caused. by the water, which created huge. potholes and the like in many of the fields, Dunlap said.

Rep. Stenholm summed up in a remark to this writer: "I am cautiously optimistic that some form of disaster relief is forthcoming" to the region.

News From The ATTEND ANNIVERSARY **County Agent**

If you have had a problem with white grubs in your lawn in past years, there is a good chance you could have the problem again-the grub cutting the roots of your lawn grass.

The adult June bugs have been laying eggs the past 2-3 weeks. The young larva should be hatching. Now is the time to make your first insecticide application. A second application may be necessary between August 1 and August 15.

White grubs in excessive numbers can heavily damage lawns. Check for white grubs by cutting a square foot section of sod with a shovel and examining the roots and soil to a depth of 4 inches. Examine at least one square foot of sod for 1,000 square feet of lawn area. Chemical treatment is needed if there are more than two grubs per square foot of sod.

Diazinon or Dursban provide adequate control and should be used at recommended rates given on the chemical container label. The granular form is easier to apply and to wash into the soil than liquid or spray formulations. After using granules, drag the grass with a tow sack or water hose to knock them down to the soil. Then apply enough water to soak the granules into the soil. One half to one inch of water will usually do the job.

Apply diazinon sprays at the rate of 25 gallons of water, including the insecticide, per 1,000 square feet to wash the insecticide into the soil. Wetting the lawn before spraying also helps. Always keep children and pets off the treated lawn until the grass is dry.

The key to white grub control in home lawns is proper timing of chemical applications and getting the insecticide through the grass to the root zone where grubs are feeding.

Further information is provided in the publication, "White Grubs in Texas Turfgrass," available at the county Extension Office.

Pecans Go Thru Final Stages

Pecans have gone through the final stages of the "June drop" in preparation for a sizing stage. The pecans will grow to about half their final size from now until the initiation of the water stage. Once the water stage starts, in late July to early August, the nuts will rapidly expand to their final size in a matter of 3 to 4 weeks.


The water stage is a time of tremendous stress for pecan trees. Large volumes of water are required to expand the nuts and fill them with liquid endosperm. During this water stage from late July to mid August, many nuts are shed due to moisture stress on the trees.

Soil moisture levels should be maintained going into and throughout the water stage to prevent moisture stress. This will help minimize nut losses to the "August drop". Growers who have a pecan crop and the means to apply supplemental irrigation would do well to maintain an irrigation schedule from now through mid-August.




Mrs. Odessie McCraw Clawson and daughter, Betty, attended the 1982 national reunion of the McCraw clan in the United States held in Irving, Texas, June 26 and 27, 1982. The McCraws in the United States are thought to all be the descendants of William McCraw of the Isle of Skys, Scotland who immigrated to America in 1729 settling in Virginia. Later generations moved West and South to North Carolina, South Carolina, Tennessee, Kentucky, and later into Georgia,

Alabama, Mississippi and Texas. Mrs. Clawson's grandparents, Mr. and Mrs. J.B. McCraw, were some of Coke County's earliest settlers and came here in 1888 settling in the Wildcat Community. J.B. McCraw was born in 1832 in Cherokee County, Georgia, son of George and Mary Turner McCraw, and Mrs. A.A. McCraw was born in 1833 in Macon County, North Carolina, daughter of Larkin Smith and Louisa Long Smith. They were married January 18, 1850 in Cherokee County, Georgia and lived there until after the Civil War.
