## Grand Jury Has Session

A 51st District Court grand jury returned six indictments in a session Thursday of last week in Robert Lee with Judge Royal Hart presiding.

Luther Lara Jr. of Robert Lee was indicted in four counts, which were murder, attempted capital murder, aggravated assault and attempted murder. The indictments came out of an incident happening Sept. 7 in Robert Lee. A woman, Victoria DeLa Cruz Ortiz, was shot to death and Game Warden Sparks Burdett was shot and seriously wounded.

Two persons were indicted for DWI's subsequent offense. They were Anzelmuz Monzaiz Casarez and Ivan Lefford Wozencraft Jr.

## Fair Housing Ordinance In Effect In R-Lee

At its meeting on October 10, 1980, the City Council of the City of Robert Lee adopted a Fair Housing Ordinance. The purpose of the Fair Housing Ordinance is to prevent discrimination in the sale or rental of housing, in the financing of housing, and in the provision of brokerage services. The ordinance also provides for referral to the Fair Housing/Equal Opportunity Division of the Fort Worth Regional Office of HUD, and directs low income individuals and families to available legal counsel when filing a private suit.

The Council approved a fair housing strategy designed to create powers conducive to expanding the housing choices available for all persons on similar income levels.



### Texas A&M engineer fears chemicals may affect water quality

**COLLEGE STATION** — The quality of some drinking water is a big question mark, says a Texas A&M University environmental engineer.

The average person consumes about half a gallon (two liters) of water every day from the kitchen tap, cooked food, coffee, tea and soft drinks.

But researchers in water quality aren't sure what effect, if any, is caused by minute levels of chemicals now being found with regularity in the nation's underground water tables, says Dr. Bill Batchelor of Texas A&M's Civil Engineering Department.

## October Is National Stamp Collecting Mo.

"Discover Stamp Collecting - The Hobby of a Lifetime," is the theme of the second annual National Stamp Collecting Month, to be observed October 1-31, 1982, Postmaster Coe Lewis, of Robert Lee, Texas, said today.

"The fall observance will include issuance of a special souvenir card, unusual post office lobby displays and a number of new philatelic items especially designed to attract newcomers to the hobby," Postmaster Lewis continued.

"Millions of Americans recognize that stamp collecting generates increased knowledge of geography, biography, history and science. Children who engage in this hobby have a good time acquiring new or used stamps, and the hobby stimulates their intellectual growth. Teachers tell us that boys and girls frequently use their stamp collecting information in preparing and presenting class projects, especially American history, current events and science."

The Postal Service is sponsoring the month-long observance in cooperation with the Council of Philatelic Organizations (COPO) which includes over 200 national, regional and local organizations involved in all aspects of stamp collecting. A number of local collateral activities are also being planned by Robert Lee adult and youth stamp clubs, school and library administrators, community service organizations and government leaders.

Your local post office will have on display many of this year's program support materials that graphically demonstrate how stamps help sometimes dry educational subjects like old world explorers, black heritage and space achievement come alive and become easier to learn in the classrooms.

"An adult who introduces a youngster to the hobby is giving that child a lifetime gift," Postmaster Lewis said, "because stamp collecting does not depend on age, stamina or the weather."

"Many families treasure stamp collections, work on them together, and pass them along as family heirlooms from generation to generation. In an age when all too many of us spend our leisure time solely as spectators, stamp collecting is a hobby in which everyone can participate. That's the message the Postal Service wants to get across in October during National Stamp Collecting Month," Postmaster Lewis concluded.

A new national safety campaign keying to the use of automobile safety belts and child auto safety has just been initiated and will continue until mid-1983 under the name, "Get It Together." The Extension Service is co-sponsoring the educational effort in cooperation with the U.S. Department of Agriculture, the National Extension Homemakers Council, Inc., and the nation's Department of Transportation, according to Dr. Mary Ann Shirer, health education specialist with the Extension Service. Goal of the educational program is to help reduce death and disability statistics from automobile accidents. Many people do not believe they will be involved in an automobile accident, yet national statistics show that almost everyone can expect to be in a car crash every 10 years, she adds. For one of every 20 persons, the crash will be serious.

**BRAZOS BERMUDAGRASS TO BE RELEASED--** Brazos, a new bermudagrass hybrid that tops Coastal in performance, will be released through the Texas Agricultural Experiment Station's Foundation Seed Service at Texas A&M University in early 1983. Brazos has a higher level of digestibility and has produced better weight gains in cattle than Coastal bermuda, says a forage scientist with the Experiment Station. To qualify for sprigs of the new grass, individuals must have their land free of other bermudagrasses and must have passed inspection by Texas Department of Agriculture officials to protect the new Brazos variety from contamination.

## Social Security News Items

Disability benefits are intended to be paid only as long as a person's condition prevents substantial gainful work. Social Security's strict definition of disability is one only the severely disabled can meet. Partial disability is not sufficient for a person to qualify for, or to remain entitled to, Social Security Disability benefits.

In 1980, the Social Security Act was amended to require periodic review of all disability claims. Each claim must be reviewed at least once every three years unless it is determined a shorter or longer review period is justified. The new law recognizes that many advances in medical science and rehabilitation techniques enable an increasing number of people to return to work after serious accidents and illnesses. For example:

- \* Surgery and new mechanical aids and devices improve mobility and enhance job opportunities for many individuals with orthopedic and neurological impairments.
- \* Coronary bypass surgery, pacemakers, and new medications enable some people with cardiovascular impairments to lead more active lives.
- \* Kidney dialysis enables many people to hold productive jobs.
- \* Microsurgery, prosthetic surgery, organ transplants, new drugs, and new methods of

treatment enable additional people to overcome their handicap.

When an individual applies for disability benefits, he agrees to report promptly if he goes to work or if his medical condition improves. The Social Security Administration has an obligation to terminate disability benefits when an individual is not disabled. The primary purpose of a continuing disability investigation is to obtain complete, current information about the disabled individual's medical condition and work activity. This information is used to determine if an individual continues to meet the definition of disability as prescribed by law.

If you have any questions about continuing disability investigations or any other aspects of social security, supplemental security income, or medicare, you can call the social security office in San Angelo. The number is 915-949-4608. They will be glad to assist you.

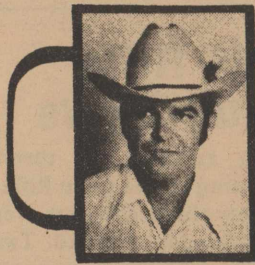

## Jerry Lackey's Country Folk

The good people of West Texas have always measured up to be above average in this writer's mind. It's always rewarding when they reassure our belief, and that is exactly what has happened four times in the past three weeks.

In every direction one travels these days, it is depressing to observe the terrain. In a time when normally we would enjoy cool autumn weather and general rains to put our pastures and winter crops in good shape, we are not. Cattle and sheep prices are down almost 50 percent at the market place. The economy continues to slump.

Despite all this gloom, West Texans have opened their hearts and pocketbooks to raise money for the crippled children at the West Texas Rehabilitation Centers. It's true, there are no less handicapped just because the country is in a recession. The cost to care for 10,000 handicapped annually remains the same, if not higher.

At the first sale of this 23rd annual Cattleman's Round-Up for Crippled Children, cattle sold raised \$163,031 in Abilene. Around \$16,000 was raised in a special horse sale.

The fourth annual Sheep and Goat Sale at Junction raised \$10,000. Junction being my hometown, I take special pride in this sale. I handled Willard Jordan's advertising at Junction Stockyards for eight or nine years. When I started raising funds for the Rehab Center some five years ago now, I went to Willard and told him about WTRC.

Together, we started organizing the Hill Country. We enlisted the help of David and Marc Dobbins, who had a son treated at WTRC. We found E.S. and Jean Herring in Kimble County.

They had known about the center from living in Runnels County.

Over in Mason County, banker Mike Dail had a son go to WTRC for treatment. Now, we have put together an annual roping over in Mason every February. We raise a little money there.

On with my story. In Coleman the other day, the good people raised \$16,000, and \$7,500 of that was by Chinese auction of a small pig. Fay Gill ran a quilt up to \$600 before calling it hers.

Of course, German Chocolate Cakes and Mississippi Mud Cakes sold for \$50 and \$100 a piece. "And the good thing about buying a cake with the money rather than giving it to a politician is that the cake stays with you," laughed one bidder.

All proceeds raised at CRCC sales go to West Texas Rehabilitation Centers in San Angelo, Abilene and Snyder for payment of treatment of patients. WTRC is a private, non-profit treatment and diagnostic facility. There is no charge to patients for services.

Allen Davis, a Kimble County ranchman, said he was looking at another feeding everyday. Johnny Underwood of Mason shook his head. Yet, both dug down a little deeper to support CRCC. That's what makes West Texans a little bit better because they believe in helping and caring for their own.

This is nonsense. The halls of the Capitol will be jammed with lobbyists from every school, fighting over a share of the funding like fishwives over a choice mackerel.

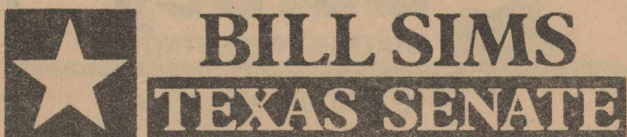
What business, even a small, mom-and-pop operation, doesn't plan ahead?

## News From The County Agent

Gardeners can get-back-to-basics and save money too by developing an old stand-by--the compost pile. And with fall here, plenty of leaves will soon be available for composting.

With transportation costs pushing the price of peat moss and other bulky types of organic matter higher, the backyard compost pile or compost bin is becoming more and more important.

With most Texas soils lacking in organic matter, composting is an excellent way to add humus to the soil while at the same time disposing of unwanted plant material from the yard and garden.

Leaves, straw, lawn clippings, sawdust, garden debris and even shredded newspapers can be converted into usable humus through the decomposing process. These composted materials will make both clay and sandy soils more suitable for growing vegetables and ornamentals.

Ideally, three compost bins works best - one being filled, one in the process of decomposing, and another ready for use. The most workable size for most gardeners is a 4 feet by 6 feet bin, with one side hinged or removable for easy access.

Start the compost pile by spreading a 6-to-8 inch layer of debris. Top this with a 1-to-2 inch layer of soil or finished compost. Sprinkle about two cups of complete fertilizer over each layer of soil and organic matter to encourage bacterial action and hasten decomposition. Manure or blood meal may be used instead of fertilizer. Water thoroughly; then add the next layer as material becomes available.

Repeat the layering process until the pile is 3 to 5 feet high. Keep the center slightly lower than the sides to aid in retaining water. Keep the pile moist for rapid decomposition; however, avoid saturation or bad odors may develop.

To speed up decomposition and insure that wastes on the outer edge of the bin have a chance to break down, turn or mix and restack the pile every 60 to 90 days. Do not add new material once the pile is turned; rather start a new pile in a nearby location.

For better aeration and faster decomposition, spread fresh lawn clippings and shredded green materials into thin layers. When adding dry leaves to the compost pile, wet them thoroughly before adding soil. A shredder will convert twigs and small branches into smaller particles for faster decomposition.

## Wool Promotion Program Okayed

Preliminary results of a recent wool referendum show that 72.6 percent of the nation's sheep producers favor a wool and lamb promotion program. Mr. Arch C. Mather, Coke County ASC Committee Chairman, said approval of the program means that advertising and other market development activities promoting the sale of wool will be continued under a new agreement between the Secretary of Agriculture and the American Sheep Producers Council, (ASPC) Inc.

The new agreement authorizes deductions of up to 4 cents a pound from payments on shorn wool and 20 cents a hundred-weight on unshorn lambs marketed during 1982 through 1985. Previous rates of 2½ and 12½ cents, respectively, had been in effect for 4 years.

According to Mathers, Coke County wool producers participated in the referendum, with 53 voting in favor of the agreement and 20 voting against it. The local voters owned 90,908 sheep.

Nationally, 32,775 producers voted in the referendum. Of this number 23,800 were in favor of the wool promotion program and 8,975 were against it. Sheep owned by the producers voting in the national referendum totaled 6,524,840.

The ASCS official said the ASPC's expenditures for wool and lamb promotion last year were about \$4 million, the same amount budgeted for the current

year. Sheep producers have approved the lamb and wool promotion program by the necessary two-thirds majority in seven referendums held since 1954.
