New Policy On Phone Repair

By taking advantage of repair services now available at Coke County Pharmacy at 710 Washington in Robert Lee, residential and single-line business telephone customers in Robert Lee can avoid charges that now apply if the customers request the company send employees to the customers' premises to repair company-owned telephone.

E.O. Cambern, West Texas Division Operations manager for General Telephone in San angelo, said the Public Utility Commission of Texas, on May 19, approved a \$22.50 charge for single-line business and \$17 for residential customers who have service problems associated with the telephone instrument and who prefer the company to send an employee to the customer's premise to make the repair rather than bring the instrument to Coke County Pharmacy.

In addition, there are separate charges for each telephone outlet repaired if the problem is in the house wiring and the customer prefers to have the telephone company make the repairs rather than purchasing a repair kit to make the repair themselves, or have a third party make the repairs. Wiring charges were started in 1982 but were increased in the recent ruling.

"We have responded to customer's requests to come to their premises for years, and we are more than pleased to respond now." he said. "The only change, brought about by deregulation, is that we must charge a fee to recover those expenses from customers requesting the

Harsh DWI penalties may be ineffective safety educator warns

COLLEGE STATION -Harsh penalties for DWI convictions could do more harm than good if implemented, says a Texas A&M University safety education expert.

'My only fear is that people will overreact and make the penalties so strong that they will be ineffective," said Dr. Maurice Dennis, head of the Texas A&M Safety Education Program and co-author of the curriculum used by most Texas court-mandated educational programs for DWI officers.

'It (driving while intoxicated) is still not looked on as a purposeful act. If we said first offenders would all get five years at Huntsville (state prison), juries wouldn't convict. They're not going to take a chance on ruining this person's life because they're thinking, 'That could be me,'" said Dennis.

Dennis said the emphasis should be on higher rate of convictions with lighter sentences - for example, a mandatory 72 hours in jail for first offenders, plus participation in alcohol education.



"Cents-off coupons for use in food markets are a form of advertising and not necessarily a bargain for consumers," says Mary Clayton, a family resource management specialist with the Texas Agricultural Extension Service, Texas A&M University System. Using coupons may not be the best answer to high food prices for many families, since coupons are primarily issued for storable brand-name items rather than less processed, perishable products. If consumers want to reduce food costs, they should compare the cost of brand-name products with cents-off coupons, to generic or house brands which may still be less expensive. Consumers should also try to prepare more dishes from "scratch." This will generally result in lower costs than processed, prepared food items even with coupon reductions, says the specialist.

Consumer Update

Does it really do any good to complain about incorrect utility

Does it really have any impact if you call the utility or the PUC and complain about poor service?

Does anyone at the PUC really read letters from consumers about high rates or sloppy service?

The answer to all three questions is "yes," but the real question that should be asked here is how can a consumer complain effectively. The following is a short course on how you can complain in a way that will achieve positive results:

(1) Decide what you want to accomplish in complaining. Do you just want to vent your frustration about high rates? Do you want your telephone fixed? Do you want to make sure you're being charged the proper rate? Be specific in stating your complaint.

(2) Decide to whom you want to complain. We have found that the majority of successful complainers try the utility first. Perhaps the utility's computer messed up and charged the wrong rate or a service representative miscalculated a deposit. Any number of things could be the answer to your problem.

(3) If you cannot obtain satisfaction from the utility, ask the utility to whom you should address your complaint (under PUC rules the utility is required to give you our address).

What do we do with the complaints and inquiries we receive? Much of what we do depends on the type of complaint. But we will acknowledge your complaint and we will try to get you some help if your are

having a specific problem such as disconnected service or an inaccurate bill.

In most cases, we contact the utility and ask for a written report on its investigation of your complaint. We want utilities to respond effectively to complaints, and the reports help us determine how well the utility has responded to your complaint.

Last year the Consumer Affairs Office recieved and acted on more than 12,000 complaints and inquiries. As a result of our actions, more than \$250,000 utility customers in credits or re-Hundreds of Texans obtained essential utility services that they had not been receiving. Many who had given up on having a service problem resolved finally got the repairs they were entitled to. We can't always resolve a complaint to your full satisfaction, but we do listen, and we will do our best to help make your complaint count.

So, increase your chances of making your complaint effective. Be specific, contact the utility and then contact the PUC. Our mailing address for complaints or inquiries is:

Tax Shelters

IRS says that in recent years many abusive tax shelters have appeared on the market that claim benefits never intended by law. Generally, these abusive shelters are marketing schemes, often for substantial fees, that involve artificial transactions lacking economic reality. Other characteristics include inflated appraisals, unrealistic allocations, package deals designed from the start to generate losses far in excess of investment. buying in volume at "wholesale" to claim charitable contributions based on retail, and a number of other devices lacking in economic substance.

Investing in an abusive tax shelter, the IRS says, is an expensive proposition. Consider the consequences: the promoter generally charges a substantial fee; the chance of examination by the IRS is great; and the taxpayer will face payment of the tax, substantial interest on the underpayment, plus a variety of penalties.

The IRS advises potential tax shelter investors to consider all the facts and circumstances involved and to seek competent counsel before investing.

BARTERING CARRIES TAX RESPONSIBILITIES

Bartering, or the exchange of goods or services for goods or services of equal value, usually called bartering, is an American tradition that carries federal income tax responsibilities, the Internal Revenue Service said.

Income from any source must be reported, according to the IRS, and, in the case of bartering, the tax is computed on the fair market value of the goods or services exchanged.

For example, an auto mechanic repairs a carpenter's truck in exchange for repair work performed by the carpenter in the auto mechanic's office. Both individuals must report the services received as income at fair market value. However, both may claim the fair market value of the repair work done as a business expense on their income tax returns.

Another example: a plumber owes a physician for medical services and offers to make plumbing repairs in the doctor's office in payment of the bill. The doctor must report the fair market value of the plumbing services as income and the plumber must report the amount of the medical services as income. Then, the doctor may claim the plumbing job as a business expense and the plumber may claim the doctor's bill as a medical expense.

Taxpayers who have not reported income gained from bartering can correct their income tax returns by filing a 1040X, an amended return, for the year or years involved, the IRS said. Forms are available by calling the IRS Forms/Tax Information number listed in the telephone directory under U.D. Government.

FIRE ANT CONTROL--Fire ants are continuing to plague all of the South and half of Texas, and their westward march continues. Well known for their painful stings and mounds that can tear up farm machinery, fire ants remain difficult to control, says an entomoligist with the Texas Agricultural Extension Service, Texas A&M University System. Mound treatment can be successful if done when ants are most activeduring warm weather, late in the afternoon or evening when ants are foraging, and after a rain. Treat mounds with an approved insecticide diluted in water or use a granular insecticide. Apply with a sprinkling can or gallonsized plastic jug with holes in the screw-on top.

Veterans should remind their families that burial in a Veterans Adminstration National Cemetery is open to any veteran discharged under other than dishonorable conditions, advises the director, Waco VA Regional

VA cemeteries in the Texas-Gulf area and their anticipated close-out dates: Fort Bliss and Houston, Texas, after the year 2000; Fort Sam Houston in San Antonio, Texas, 1999; Alexandria, La., 1985; Port Hudson, La., 1987; and Biloxi, Corinth and Natchez, Miss., all after the year

Although the law doesn't provide for gravesite reservations, a veteran may make things easier for survivors by expressing a desire to be buried in a VA cemetery, keeping military service records accessible and verfying eligilibility at any VA region-

To be eligibbe for burial, service must have been for other than training purposes. Reserve or National Guard personnel not meeting those requirements, but who die as a result of active duty are eligible. Burial is available to an eligible veteran's widow, widower, minor children and, under special circumstances, unmarried adult children.

When a veteran or dependent dies, the documents verifying eligilibility should be presented to the funeral director handling the burial, who then contacts the national cemetery to determine eligibility and space availability.

Of the 110 VA National cemeteries, 60 have grave space available, 48 are closed and two are under design. A closed cemetery, such as San Antonio and Kerrville, Texas and Baton Rouge, La., means it isn't available for initial interments. Those who have spouse or dependent buried in a closed cemetery still may be buried in that family grave site. Once eligilibility and space are determined, the VA will open the grave, handle the burial, furnish a headstone or marker and provide perpetual care and maintenance.

For further information, telephone the nearest VA National Cemetery, or the Waco VA Regional Office toll-free number listed in your local telephone directory under "Veterans Administration" or "U.S. Government." A VA counselor will respond.

If you have them, treat the soil once the garden's empty with Vapam, carefully following the label instructions.



Mysterious disease killing newborn foals

COLLEGE STATION — A puzzling new disease is killing newborn foals nationwide and veterinary diagnosticians here are hoping to find clues before the current foaling season

The mysterious disorder attacks the liver and produces symptoms similar to hepatitis, explained Dr. Robert Fiske of the Texas Veterinary Medical Diagnostic Laboratory, a part of the Texas A&M University System.

The foals appear normal at birth, but a few days later exhibit jaundice in the eyes and lips, staggering movements and may seem to be blind. Within nine days after birth, they all die despite treatment, said Fiske, a pathologist.

Cause of the malady called neonatal foal hepatitis syndrome - is unknown, he

"There is a critical need to learn more about this potentially devastating disease," he said. "We are soliciting help from the veterinarian in the field when this disease is suspected.

Information that the TVMDL will be seeking from field veterinarians and owners includes samples of liver, blood serum, a complete history with medications and vaccinations given during pregnancy and exposure to toxic substances.
