Precinct 2-Royce Fancher, judge; Flora Smith, alternate. Precinct 3-Victor Wojtek, judge; Pauline Large, alternate. Precinct 4-Lora Belle Brown, judge; Bill Hartman, alternate. Precinct 5-Willie B. Edmiaston, judge; Pearl Mae Andrews, alternate. Precinct 9-D.O. King, judge; Connie Millican, alternate. Absentee judges were also appointed which are Kenneth Lackey, James Arrott, Golda Smith and Noel Perciful.

* Judge Aubrey Denman was recommended by commissioners to be nominated to serve on the Concho Valley Regional Review Committee for the State Community Development Block Grant Program.

* Opened bids on sale of beds and bedding and awarded the highest bidders.

* Approved bills for payment and adjourned.

Along with each 500 word story you may have a picture also. You may leave your stories at the Judge's office in the Coke County Courthouse in Robert Lee or the City Hall in Bronte.

A Saturday afternoon parade through downtown Bronte begins at 5 p.m., starting from the Bronte Nursing Home. The route goes north on Highway 277 to Main Street, then turns west and continues to the Santa Fe depot. Everyone who has a horse to ride (bicycles and stick horses welcomed) is invited to join the parade. The riders will first meet at the depot at 4:30 p.m. and ride as a group to the Nursing Home where the parade will form and lead off.

Friday night action kicks off at 7 o'clock with a large number of events scheduled for both boys and girls in all age groups. Events for all girls and the younger boys are: barrel racing, flag racing and pole bending. The older boys will compete in steer or bull riding, tie-down, break-away or ribbon roping. There will be no steer roping.

Contestants are divided by age groups of six years and under through 19 years and over. The rule for eligibility for Best All-Around Awards will be in effect again this year. The rule states there must be four or more contestants in your age group. Anyone wishing to move up to the next age group may do so.

Prizes will be awarded to the top four contestants in each event. The Best All-Around Cowboy and Cowgirl Awards are \$25.00 gift certificates donated by Gate #1 and Cowboy Shack in Winters.

Admission prices to the rodeo will be \$2.00 for adults and \$1.00 for all students.

A concession stand will have food available so plan to come early and enjoy supper while watching the rodeo. On the menu are hot dogs, sausage-on-a-stick, sandwiches, cold drinks and other goodies.

Intruder Attacks Couple; Husband Dies

An 82 year old East Point, Georgia man died Friday, July 1, of injuries received when he and his 80 year old wife were attacked by a man at their home.

Emory Hughes died at South Fulton Hospital of injuries received Wednesday, June 29, in the attack, which he had tried to thwart with an unloaded 22 caliber pistol. His wife, Thelma, was in satisfactory condition.

Their son, Phil Hughes, offered a \$10,000 reward for information leading the arrest and conviction of the killer. "I just hope this will jar something loose" he said.

Hughes, owner of Tri-City Saw & Tool Co. in East Point, said he is in the process of moving his business to Gainesville and had urged his parents to move also. They refused to leave the house where they had lived for 42 year, he said.

East Point police are seeking a black man about 25 years old, 6 feet tall and weighing 175 pounds, with severe acne and matted hair, according to Detect-

ive Jack Lambert.

Lambert said Mrs. Hughes answered the door of the home at about 7 a.m. Wednesday, and a man asked for information about a vacant house next door on Winburn Drive. Mrs. Hughes told the man that the house was taken, and he asked to use the telephone.

Mrs. Hughes let the man enter the house, and he grabbed her and demanded money, according to her son, "When the commotion started, Daddy was still in bed," Hughes said. "He heard the commotion and got up and retrieved his 22 target pistol, and he confronted the man."

Hughes said the gun was unloaded, and the intruder beat his father, tied him up and stomped him. He said his mother also was bound and beaten.

Before the incident involving the Hugheses, several neighbors had been approached by a man who asked if they had any yard work. "He was seen by numerous people," Lambert said.

Neighbors in the quiet residential area were shocked by the slaying. Most of the residents are retired people, and most have lived there for 30 to 40 years, according to Grady Barker, a neighbor.

It was Barker whom Hughes

called after freeing himself. "Everybody is like kinfolks around here," Barker said.

Initially, Mrs. Hughes appeared to be injured more seriously hospital workers told the family that she had lost a lot of blood.

But her husband lapsed into a coma Wednesday night; doctors performed surgery for a blood clot in his head, but he never regained consciousness.

Funeral services for Mr. Hughes were held on Tuesday, July 5, at 2 p.m. in the East Point Baptist Church followed by burial in an East Point cemetery.

Emory Chesley Hughes was born June 12, 1901, to C.L. Hughes and Eva Pearl Vestal in Robert Lee. He attended school in Robert Lee.

He was married to Miss Thelma Phillips of Abilene, December 5, 1925. They lived in Abilene for several years before going to Georgia. He was a salesman for Fechheimer Uniform Co. out of Cincinnati, Ohio and traveled the southern states, about twenty years.

He and his son were owners of Tri-City Saw & Tool Co. in East Point, Ga. until his retirement a few years ago.

He leaves a wife, Thelma; a son, Phil; and one grandson, David; two granddaughters, Mrs. Clint Copeland and Amy Hughes of East Point, Ga.; one brother A.V. Hughes and one sister, Zola Hatley, both of Robert Lee. His father, mother, a sister Ordie Gibbins, and two brothers, David and Bonner Hughes, preceded him in death.

Emory was a Baptist and a Mason.

Word has been received by Mrs. Hatley and Mr. Hughes that a suspect has been arrested in the beating death of their brother. He was taken into custody

following a service station robbery and as a suspect in another beating and robbery of two elderly women. He reportedly had Mr. Hughes' pistol in his possession when arrested.

Services Held For Earl Smith

Funeral services were held on Sunday, July 10, 1983 for Earl Smith in the First United Methodist Church at 2:30 p.m. Burial followed in Divide Cemetery directed by Shaffer Funeral Home. The Rev. James Sanders of Colorado City officiated the rites, assisted by Rev. Fred Cox, pastor of the First United Methodist Church.

Mr. Smith, 91, was a member of a pioneer ranching family. He was born and raised in Coke County, the son of Jay Smith and Zula Spivey, born on January 29, 1892. He was engaged in ranching all his life in the county.

He had resided the past year in Kristi Lee Manor Nursing Home in Colorado City. Mr. Smith died at Root Memorial Hospital in Colorado City at 10:45 a.m. on Friday, July 8.

He is survived by two sisters, Zula Webb of Plano, and Lucy Smith of San Angelo, and a number of nieces and nephews.

Public Notice

Southwestern Bell, in accordance with the rules of the Public Utility Commission of Texas, hereby gives notice of the company's intent to implement a new schedule of telephone rates in Texas, effective August 1, 1983, unless otherwise determined by the Commission.

A complete copy of the new rate schedule is on file with the Texas Public Utility Commission (PUC) at Austin, Texas, and with each affected municipality served by Southwestern Bell, and is available for inspection in each of the company's public business offices in Texas. The Commission staff has contended in the past that all rates are subject to change as a result of Southwestern Bell's rate application.

As a result of the settlement of a lawsuit brought by the U.S. Department of Justice against AT&T, Southwestern Bell, on January 1, 1984, (or as otherwise ordered by the United States District Court) will no longer be a part of the Bell System, but will be owned by public shareholders. Under the terms of the settlement, Southwestern Bell has identified 15 areas in the state within which it may provide service, and the federal court with jurisdiction of the settlement has tentatively approved these areas, called LATAs (Local Access and Transport Area). On or about January 1, 1984, Southwestern Bell can not provide service between these LATAs, and in addition, must transfer to AT&T customer premises equipment that it leases to customers.

Southwestern Bell has filed a proposed revised rate schedule with the PUC reflecting these changes. These rates would become effective August 1, 1983, if they are not suspended by the PUC; however, it is expected that they will be suspended and that the rates ultimately set by the PUC will become effective on or about January 1, 1984. If the rates were to become effective as filed, they would produce a 48.2% increase in Southwestern Bell's unadjusted test year revenues (or a 76.36% increase in Southwestern Bell's test year revenues adjusted to reflect the effect of Southwestern Bell's divestiture from AT&T). Any change in the rates for any interLATA services offered by AT&T or a subsidiary after January 1, 1984, could affect customers of Southwestern Bell Telephone Company.

Notice to Customers of Other Telephone Companies

With Texas' heavy spring and summer rains, homeowners need to be on guard against a "bumper crop" of mosquitos and the health hazards they bring. Encephalitis is spread by the bite of an infected mosquito, which receives the infection by first biting an infected animal, says Dr. Mary Ann Shirer, a health education specialist with the Texas Agricultural Extension Service, Texas A&M University System. Texas offers an ideal environment for encephalitis because of its large bird population which can become infected with the virus and carry it great distances, she adds. So far this year, the Texas Department of Health has reported no human alitis. But last year, 18 cases of St. Louis encephalitis in humans were reported. In addition, infection from scratching mosquito bites and allergic reactions causing redness, swelling and itching are other possible health hazards, notes the specialist.

In the United States, 2.4 percent of children ages 3-15, and 7.5 percent of adolescents are estimated to have high blood pressure. Hypertension is called a "silent disease," says Dr. Mary Ann Shirer, a health education specialist, because signs and symptoms will become obvious only when the condition persists over a period of time. The symptoms of hypertension in older children and adolescents usually include frequent headaches, dizziness and visual changes. Infants or young children may not even be recognized as having symptoms until complications such as unexplained seizures result, says Shirer, who is with the Texas Agricultural Extension Service, Texas A&M University System. The National Heart, Lung and Blood Institute now recommends that children three years of age and older should have their blood pressure measured annually, Shirer notes.
