COMMISSIONER'S COURT HOLDS MEETING DEC. 12

The Coke County Commissioners Court met in a regular session Monday, December 12. The meeting was called to order by County Judge Aubrey Denman and was opened with a prayer led by Ettie Hubbard. The minutes of the last meeting were approved as read on a motion made by Commissioner Tidwell and seconded by Commissioner Luckett.

Item one on the agenda- The Coke County Appraisal Board came before the court to discuss the possibility of the Appraisal Board collecting taxes for all taxing agencies in the county. No action was taken on this discussion.

Item II- The County Treasurer met with the court asking for extra office personnel two weeks

New DWI Laws To Go Into Effect Jan. 1

Effective January 1, 1984 new stiffer DWI laws will go into effect. These laws passed in 1983 are the result of highly publicized debates in the legislature.

Deferred adjudication, which allows a defendant to plead guilty and accept a fine and probation without being convicted, will be eliminated under this new statute. Even if probation is given, a conviction record will be established for the offender and this record can be used in future prosecution of any additional drunk driving charges.

The new law provides increased penalties for DWI convictions. Conviction on first offensive DWI carries a fine of \$100.00 to \$2,000.00 with a jail term ranging from 72 hours to two years. A second offense conviction is punishable by jail time ranging from 15 days up to two years with a fine of \$300.00 to \$2,000.00. Conviction for third and subsequent DWI offenses carry a fine of \$500.00 to \$2,000.00 and confinement in jail for a minimum of 30 days to two years or in the state penitentiary for 60 days to five years.

Minimum terms of confinement are increased by 60 days and fine limits are raised by \$500.00 if the DWI offense results in serious bodily injury to another person. If a drunk driver is found to be responsible for a traffic fatality, the law prescribes a mandatory term for the violator.

The new law establishes that a driver is definitely too drunk to drive if test reveal a blood alcohol concentration of .10 per cent or more.

The revised statute allows for a 90 day suspension of driver's license for refusing to submit to an alcohol chemical test. The refusal will also be admissible evidence in court. Upon the fourth DWI conviction, a drunk driver's vehicle may be confiscated and sold.

These revisions in the DWI laws will aid in the prosecution of drunk drivers and hopefully this will help discourage drunk driving.

Co. Attorney Gives Info On Check Cashing

Out of county constable and sheriffs' departments have begun to refuse to serve arrest warrants on criminal defendants in hot check cases where there was no date of birth, driver's license number and current address on check.

Therefore, I recommend and advise all merchants and citizens taking payment by check from out of county persons to record on the check their date of birth, driver's license number and current address. Without this information it is of no use to attempt prosecution for the check as our arrest warrant will not be served.

Without the above mentioned information I can offer no remedy to any hot checks filed since it is becoming impossible to arrest a defendant in another county. With information there is a possibility of having the defendant arrested and the case handled.

I recommend complete and accurate verification of the following information when taking checks: (1) Name; (2) Current address; (3) Telephone Number; (4) Texas Driver's License; and (5) Date of birth.

With your cooperation in obtaining this information will help for your local county officials to better serve you.

YEAR-END TAX PLANNING

Farmers and ranchers have only a few weeks left to make decisions that could affect their 1983 income tax situation. Year-end planning can help save tax dollars.

Such planning mainly involves decisions to adjust income or expenditures so as to come up with a more favorable tax situation. The primary purpose of year-end tax planning is to level out taxable income from year to year to avoid jumping through several tax brackets from one year to the next.

With lower tax rates expected during 1984, producers may be in a dilemma about their income tax situation this year. Many may feel inclined to shift some taxable income into next year to take advantage of the lower tax rates, particularly if this year's taxable income will be above average.

The main thing producers need to avoid is a net operating loss (NOL) because for many that could mean a loss of the tax benefits from personal deductions and exemptions. These add up to at least \$5,400 for a couple with no dependent children and \$7,400 for a family of four.

Social Security retirement benefits also will be affected by low net earnings in a preretirement year. And contributions to a Keogh or IRA retirement plan may be affected if taxable income falls too low.

The first step in year-end tax planning is to calculate your 1983 taxable income and to project 1984 taxable income. The IRS is presently mailing 1983 income tax tables and schedules along with forms and filing instructions. For a rough estimate of 1984 tax rates, figure taxes at 5 percent less for the same taxable income as in 1983. Remember

that the maximum capital gains tax on the sale of land, machinery or other investments is 20 percent.

If it is determined advantageous for a cash basis taxpayer to shift taxable income from 1984 to this year, several steps can be taken. Certain cash purchases can be postponed until next year or payments can be delayed until after the first of the year. Certain soil and water conservation and land clearing expenses can be capitalized and depreciated rather than taking them all this year. Some tax and interest payments might also be deferred until after year-end. Shifting capital assets bought before 1981 from a rapid method of depreciation to straight line depreciation can postpone deductions.

1983 income may also be increased by receiving payment for grain and livestock sales before year-end, through assignment of PIK entitlements to someone else, and by receiving advance diversion and deficiency payments through participation in the 1984 farm program. Certain assets might also be sold this year that would eventually be sold anyway.

However, if the decision is to shift taxable income to 1984 to take advantage of the lower tax rate, a producer may avoid receiving income from any 1983 sales (especially crops) through a deferred payment agreement with the buyer. He may also delay counting PIK entitlements, crop insurance proceeds, and income from forced sales of livestock from federally designated drought areas.

Stepping up deductions can also postpone 1983 income. This could include paying for and taking delivery of equipment and supplies before year-end as well as prepayment of such items as

leases. Year-end tax benefits associated with farm machinery purchases (such as ACRS deduction, investment credit or the \$5,000 expensing option) may enhance the payoff of such purchases. And contributions to a Keogh and an IRA retirement plan are deductible as long as they are made before the tax return is filed.

If a producer does all he can to reduce his 1983 taxable income and still finds his earnings much higher than in past years, income averaging is suggested. If this year's income will be 20 percent above the average taxable income for 1979 through 1982 plus \$3,000, then income averaging may save tax dollars.

Producers should check with their tax consultants for further information on year-end tax planning.



He is the postmaster in Woodsboro, Texas and recently visited postoffices in the Brownwood-San Angelo area. He wrote such a flattering article about Robert Lee, we called and ask his permission to reprint it for you all to read. It's always nice to see how others view our town.

Robert Lee--- Not "Robert E. Lee", just Robert Lee.

But that's plenty!

If you want to visit one of the nicest small towns you've ever been in, take a detour off Highway 87 (or come up from the South, I don't care!) and head for Robert Lee, TX 76945.

I had occasion to visit "Bob" Friday, the day after Thanksgiving. I was very impressed.

As is my custom on such sojourns, I wandered around the town (in my merry Oldsmobile) before going to the post office, sort of "casing the joint". What I saw in Robert Lee was neatness, cleanliness, spaciousness, and unmistakable signs of progress. This is a town on the move!

And... Robert Lee has just the right type of Postmaster, Coe Lewis--- an ebullient, effervescent, bubbly, gracious and TALKATIVE head of her post office. And, what she talks about makes sense!

There is no doubt that she loves her town... and my subsequent "grilling" of some of the townspeople convinced me that the love is reciprocal.

Coe is an active NAPUS member, and won one of the big prizes at Doubletree this past June. And, there in lies a nice story.

Coe's prize was a TI home computer. She lugged it home ("it was large, but not TOO large to carry", said Coe). Her daughter, Cathy was not planning to go to college. But, she started tinkering with the computer... then began "programming" it.

After fooling around with it a couple of weeks, Cathy decided to definitely attend Angelo State University after high school graduation!

Postmaster Lewis couldn't be happier. As a matter of fact, lots of things make Coe happy... and not many things can discourage her. A lesser lady would have been hysterical back in June, when (on the way to Doubletree) her car broke down on a frantic Houston freeway, and she and Cathy had to wait SIX hours before anyone stopped to help (chivalry, where art thou?) But, she laughed it off... just as she laughed off the fact that I had identified her as "Joe Lewis" in the photo of those attending the national convention in Biloxi in 1982!

Before leaving the delightful town of Robert Lee, I stopped for a bite to eat at the "Spudd Shak". You cannot miss this marvelous little cafe, because it's real close to two other businesses, the "Flower Sack" (a florist); and "Cracker Barrel" (a grocery store).

At the Spudd Shak, there is room for only about 22 persons at a time-- at individual tables. The place is positively sparkling, it's so clean. And, the food is "indescribably delicious." I had liver and onions, a baked potato (where else can you get a baked potato at 3 p.m.?), and as good a salad bar as you'll find at the Hyatt Regency in San Antonio. I topped it off with a scrumptious piece of cherry pie and three cups of steaming, STRONG coffee. What a meal!!

I kinda hated to leave Robert Lee, but Bronte and Winters were on my route, so I had to move on. Leaving town, I noticed a beautiful nine-hole golf course on my right... a golf course in a town of 1300!

The town also has its own newspaper--- and a fine one.

Can you believe these two attributes?

Of course you can. Almost anything good and pure is believable in one of the four or five nicest places I've ever been in Texas--- Robert Lee!

CHRISTMAS TREE SAFETY

The Christmas tree is one beloved symbol of the Christmas season. Don't let it become a fire hazard. Remember that dry resinous evergreens are highly flammable and can be consumed by fire almost explosively.

To increase safety:

- *Use a freshly cut tree.
- *Keep the tree in a container filled with water.
- *Never use open flames such as lighted candles on or near a tree.
- *Don't place your tree near a

source of heat - fireplace, a radiator, or electric heater.

*Never leave Christmas lights on when no one is in the house.

*Check electric cords for frayed or worn spots which can easily lead to a fire.

*Do not overload electric circuits.

*Hang only unbreakable bulbs on lower branches where small children might reach them.

*If you are using a man-made tree, use only miniature lights, larger bulbs generate too much heat.

If this is the year to replace your Christmas tree lights, keep this fact in mind as you shop. The order of brightness in colored lights is white, orange, red, green and blue. In other words, if you plan to use all colors in lighting your tree, you'll need about twice as many blue and green lights as you do white, orange and red in order to have a good balance of color and brightness. This will also help to retain the true color of the tree.


