The guidelines that will be used to determine if, and how much the publication will cost is as follows:

#### **Death Notices...**

Death notices may include the deceased's name, city of residence, age, date and place of birth, date and place of death, and the names of parents. Survivor information will not be included.

If the notice is to be published prior to any services, the time, date and location of services, and location of burial may be included.

If publication will be after said services, the time will not be included.

#### Obituaries...

Obituaries printed in the Muleshoe Journal are printed at the rate of \$4.50 per column inch, and may contain a variety of information, including but not limited to: Date and details of funeral and place of burial; date and place of birth and parents names; date of marriage; biographical information; names of parents, spouses or children who have preceded the person in death; names of survivors; and where memorials may be directed.

A black and white photo will be included; however, there is an additional charge of \$75 to include a color photograph.

#### Proposition Number 2 (HJR 79)

HJR 79 proposes a constitutional amendment to repeal the constitutional provision requiring the creation of a State Medical Education Board and a State Medical Education Fund, neither of which is in operation. No new loans have been made from the fund by the board in more than 25 years, and the board currently has no appointees and receives no program funding.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment eliminating an obsolete requirement for a State Medical Education Board and a State Medical Education Fund, neither of which is operational."

#### **Proposition Number 3** (HJR 133)

HJR 133 would authorize local political subdivisions to extend the length of time that aircraft the exemption up to 730 days after the date that a person acquired or imported aircraft parts in the state.

appear on the ballot as follows: The constitutional amendment to authorize a political subdivision of this state to extend the number of days that aircraft parts that are exempt to their location in this state for a temporary period may be located in this state for purposes of qualifying for the tax exemption."

#### **Proposition Number 4** (HJR 24)

HJR 24 proposes a constitutional amendment that would allow the legislature to provide for an exemption from ad valorem taxation of part of the market value of the residence homestead of a partially disabled veteran or the surviving spouse of a partially disabled veteran if the residence homestead was donated to the disabled veteran at no cost to the veteran by a charitable organization.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of part of the market value of the residence homestead of a partially disabled veteran or the surviving spouse of a partially disabled veteran if the residence homestead was donated to the disabled veteran by a charitable organization."

#### **Proposition Number 5** (SJR 18)

SJR 18 would amend the definition of "reverse mortgage" to authorize the making of reverse mortgage loans for the purchase of homestead property in addition to the current

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the making of a reverse mortgage loan for the purchase of homestead property and to amend lender disclosures and other requirements in connection with a reverse mortgage loan."

#### **Proposition Number 6** (SJR 1)

SJR 1 would create the State Water Implementation Fund as a special fund inside the state treasury and outside the General Revenue Fund. Money in the fund would be administered by the Texas Water Development Board (TWDB) and would be used to implement the state water plan, as adopted by general law, by TWDB.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the creation of the State Water Implementation Fund for Texas and the State Water Implementation Revenue Fund for Texas to assist in the financing of priority projects in the state water plan to ensure the availability of adequate water resources."

#### **Proposition Number 7** (HJR 87)

HJR 87 proposes a constitutional amendment to allow home-rule municipalities to adopt charter provisions authorizing the filling of vacancies in the governing body by appointment, but only when the remainder of the vacant term is less than 12 months. Under current law, municipal voters may adopt terms of office for municipal officers longer than two years, but upon approving longer terms of office, any resulting vacancies in office must be filled by special election. The proposed amendment would provide an option

HJR 147 would repeal the Texas Constitution's maximum tax rate for a Hidalgo County hospital district; the maximum rate is currently set at 10 cents per \$100 valuation. This rate is lower than the maximum tax rate allowable for hospital districts in all other counties in the State (75 cents per \$100 valuation). The repeal of the constitutional cap would authorize hospital district tax rates in Hidalgo County equal to the hospital district tax rate laws applicable to all other Texas counties.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment repealing Section 7, Article IX, Texas Constitution, which relates to the creation of a hospital district in Hidalgo County."

#### **Proposition Number 9** (SJR 42)

SJR 42 would expand the potential sanctions that the State Commission on Judicial Conduct can issue following a formal proceeding. This constitutional amendment would allow the Commission to issue an order of public admonition, warning, reprimand, or a requirement to obtain additional training or education in addition to the Commission's current authority to issue a public censure or recommend removal or retirement of a judge.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment relating to expanding the types of sanctions that may be assessed against a judge or justice following a formal proceeding instituted by the State Commission on Judicial Conduct."







The Muleshoe Independent School District is adding a natural tactic in its weed management program.

Puncture vine — also known as goathead — has invaded some school grounds and has flourished in the surrounding area.

If you have ever stepped on a goathead in bare feet you will certainly remember it!

The seeds, in addition to being very painful when in ones heal, are easily transported on moving objects such as tires, pets and shoes.

Puncture vine is widely distributed and is thought to have been accidentally imported into the US on livestock from the Mediterranean feed.







# **USDA Study Shows Benefits Of Weaning Calves Early**



Beef producers, when hit with drought, have limited forage for cows to eat. The result is usually reduced calf growth and reduced weights at weaning. ARS scientists confirmed that early weaning is a beneficial production alternative for beef producers when forage is limited.

It pays to wean calves early when severe weather conditions like drought hinder beef cattle production, US Department of Agriculture, (USDA) studies confirm.

During drought, limited forage for livestock grazing can restrict calf growth, resulting in lighter calf weaning weights.

Drought may also cause cows to lose body weight, and may weaken their immune functions, reducing their overall health and reproductive performance.

Animal scientist Richard Waterman, at the Agricultural Research Service (ARS) Fort Keogh Livestock and Range Research Laboratory (LARRL) in Miles City, Mont., examines management options to minimize the effects of severe drought on rangeland livestock production.

ARS is USDA's principal intramural scientific research agency, and this research supports the USDA priority of promoting international food security.

Working with local ranchers, Montana State University scientists and American Simmental Association collaborators in Bozeman, Mont., Waterman evaluated the early weaning of beef calves and its impact on cow, heifer, and steer performance.

Calves at two locations in Montana — Judith Gap and LARRL — were weaned early at 80 days of age and at the more traditional age of 215

Cows that weaned a calf early weighed more and were in better body condition at the start of winter.

As a result, the amount of harvested feedstuffs required for cows to maintain satisfactory body weights and condition throughout winter was reduced.

Waterman confirmed that early weaning is a viable management option, presents fewer problems and allows producers to better control their production environment.

He also demonstrated that early weaning increases the likelihood that heifers will become pregnant on time in the following breeding season

Additional studies showed that early-weaned steers reached maturity sooner than traditionally weaned steers when body weight gain, feedlot performance and carcass traits were measured.

Waterman noted that management of early-weaned steers can directly impact how they grade at harvest.

In some cases, early-weaned steers had poorer USDA yield grades because carcasses were too fat.

However, Waterman demonstrated that producers can maximize carcass value of early-weaned steers if animals are identified before they enter the feedlot and then harvested at an earlier age.

# **Temporary Coating May Help Protect Homes From Wildfires**

Quickly spraying a home with a temporary fire-retardant coating may prevent it from being destroyed by a forest or brushland wildfire.

An experimental gel that US Department of Agriculture (USDA) plant physiologist Gregory M. Glenn and his colleagues in Albany, Calif., have developed might offer better, more affordable protection than other fire-retardant gels.

The experimental gel is made of sodium bentonite clay, corn starch and water. Preliminary tests suggest that a quarter-inch layer of the gel may protect wood-based home siding for up to 30 minutes.

Depending upon the circumstances,

that timeframe might be long enough to save a house.

In a best-case scenario, all that a homeowner might need to do after the fire is to wash the coating off the house, according to Glenn. He works for the Agricultural Research Service (ARS), USDA's chief intramural scientific research agency.

In preliminary research, documented in a 2012 article in Fire Safety Journal, Glenn and his co-investigators cut planks of residential wood-based siding into squares measuring about 7 by 7 inches by 3/8-inch thick, then coated all but the "control" squares with either the experimental gel, a commercial gel, or other formulations.

In several of the tests that followed, the experimental clay-andstarch gel outperformed the other coatings.

"Drying tests," for example, showed that the gel kept its moisture longer, which is an important quality in a fire retardant.

In "burn tests," siding coated with the research gel took longer to reach 392 degrees Fahrenheit, the temperature at which woodbased siding may begin to burn and char.

Other tests, in which the squares were positioned upright, demonstrated that the gel was less prone to sliding, technically known as "slumping," toward the bottom of the squares.

The starch helped the coating to stay in place and, in so doing, to shield the siding.




In all, the California studies provide a foundation for more extensive tests of the promising, all-natural coating.

Although neither sodium bentonite clay nor starch are new to firefighting, the idea of combining these materials to form a fire-retardant coating is apparently a "first," as is the California team's detailed analysis of the coating's effectiveness.

Glenn collaborated with co-workers Bor-Sen Chiou, Artur Klamczynski and Zhongli Pan at ARS' Western Regional Research Center in Albany, and with former ARS researcher Gokhan Bingol. ARS is seeking a patent for the research.

An article in the September 2013 issue of Agricultural Research magazine highlights these studies.

### **Producers Affected By Disasters Urged To Keep Good Records**

The USDA Farm Service Agency urges livestock producers affected by natural disasters to keep thorough records of their livestock and feed losses, including additional expenses for such things as feed purchases because of lost supplies. FSA recommends that owners and producers record all pertinent information of natural disaster consequences, including: Documentation of the number and kind of livestock that have died, supplemented if possible by photographs or video records of ownership and losses; dates of death supported by birth recordings or purchase receipts; costs of transporting livestock to safer grounds or to move animals to new pastures; and feed purchases if supplies or grazing pastures are destroyed.

Then one night I couldn't sleep and I came up with Muleshoe Day and thought with our 100 years celebration we would start up with that.



**Continued on Page 9** Compared to July, the combination of lower production and fewer beginning stocks lowered corn supplies in the 2013/2014 marketing year by 197 million bushels.

"On the use side of the supply and demand balance sheet, feed use was reduced 50 million bushels and exports cut 25 million bushels," Welch said.

"The net effect of these revisions was a decrease in ending stocks of 122 million bushels. The corn stocks-to-


use ratio is now estimated at 14.5 percent compared to 15.4 percent last month and 6.4 percent last year," he added. Welch noted the recent U.S. corn crop condition index has held steady at 368 with 64 percent of the crop rated as good or excellent.

"The crop condition index score — one point for very poor, two points for poor, three points for fair, four points for good, and five points for excellent — is just above the average for this time of year of 357," he said.
