Continued from A1 Texas law stipulates that if a road is divided only by a left-turning lane, drivers on both sides of the roadway must stop for school buses when their red lights are flashing and stop-arm is activated.

However, if the lanes are separated by an intervening space or physical barrier, only motorists going in the same direction as the bus are required to stop.

Harvard-educated and with more knowledge, wisdom, and experience in the tip of his little finger than I had in my whole body, his eyes sort of glazed over as he began telling stories as if he were seeing pictures from another world, though it wasn't another world he was seeing at all — just another time and another place so real to him that he made them real to us.




