Texas Teenagers Are Responsible To Laws

Texas Teenagers, eager to grow up and enjoy the freedom of their parents, will learn Friday August 23, that responsibility goes hand in hand with all forms of freedom as well as the attainment of position, when the new Texas Teenage Driver's License Law becomes effective.

Under the new law youngsters 14 years of age and older, can be fined \$100 for speeding, driving while intoxicated, or for driving without a license. Parents will be liable up to \$300 for property damage caused by minor children. Drivers license for youngsters under 16 will be harder to get. The Department of Public Safety will issue the licenses. A special license will be needed for driving motor bikes and scooters.

Local officers will start checking driver's licenses of teenagers and adults Friday as the new law swings into action. Sheriff Ross Turner and Deputy Sheriff Adrian Preston feel that the new law is one passed in the interest of public safety, and will devote much of their time to its enforcement.

School Opens August 29th

Stratford Schools will open Thursday, August 29, with a general assembly program to be held in the school auditorium at 9:00 a. m. for all students except those of the first grade who will gather in their classrooms.

First grade students entering school for the first time will be required to present their birth certificates, a certificate of polio vaccination, and a certificate of smallpox vaccination or the evidence of a scar. County records of mass polio vaccination have been made available to the school and will be accepted as evidence of vaccination of those who took part in the mass polio vaccination program.

School buses will operate on last year's scheduled routes with adjustments made to pick up new pupils. The school cafeteria will also be in operation for the opening day of school.

School will be in session all day Thursday and Friday. Monday, September 2, the school will be closed for the Labor Day holiday with classes being resumed on Tuesday, September 3.

Faculty meetings and teacher orientation will begin Monday, August 26, with a reading conference for elementary teachers. Miss Virginia Heflin of Albuquerque, New Mexico, a reading consultant, will direct the reading conference. Tuesday morning a meeting will be held with new members of the faculty. Wednesday all the teachers will meet in a general conference.

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 5, 1957.

HOUSE JOINT RESOLUTION NO. 37 proposing an amendment to Subsection (a) of Section 62, Article XVI of the Constitution of the State of Texas.

Section 1. That Subsection (a) of Section 62, Article XVI of the Constitution of the State of Texas be amended so as to read hereafter as follows:

"Section 62. (a) The Legislature shall have the authority to levy taxes to provide a State Retirement, Disability and Death Compensation Fund for the officers and employees of the State, and may make such reasonable inclusions, exclusions, or classifications of officers and employees of this State as it deems advisable.

"Section 2. The foregoing Constitutional Amendment shall be submitted to the vote of the qualified electors of this State at a special election to be held throughout the State on the first Tuesday after the first Monday in November, 1957, at which election all ballots shall have printed thereon the following:

"FOR THE CONSTITUTIONAL AMENDMENT AMENDING SECTION 62 OF THE STATE CONSTITUTION, RELATING TO THE ESTABLISHMENT OF A RETIREMENT, DISABILITY AND DEATH COMPENSATION FUND FOR OFFICERS AND EMPLOYEES OF THE STATE."

"AGAINST THE CONSTITUTIONAL AMENDMENT AMENDING SECTION 62 OF THE STATE CONSTITUTION, RELATING TO THE ESTABLISHMENT OF A RETIREMENT, DISABILITY AND DEATH COMPENSATION FUND FOR OFFICERS AND EMPLOYEES OF THE STATE."

Section 3. The Governor of the State of Texas is hereby directed to issue the necessary orders for the special election and this Amendment shall be published and the election held as required by the Constitution and laws of this State.
