



EL PASO, March 9 -- The right f a railroad company to drill for oil on its right-of-way was denied in federal court in the Texas and Pacific Co., suit against Eli J. Jones, Ector county, and others,

Judge Charles A. Boynton ruled that the railroad owns only an easement and not record title to the right-of-way. Adjoining property owners may not drill on this rightof-way, but wells adjacent to it may drain oil from under the right-ofway, the court held.

Attorneys said the ruling would have an important bearing on the railroad's rights throughout the state.



Years ago when I first came to New York I did not know it and had no intention of learning it because it was always Caruso who sang it. But at the request of the management I learned it so as to

be an understudy in it for the great artist and during his life I used te sing it two or three times each sea-son. Since his death, however, 1 have sung it oftener than any other part-in fact, so far as my entire career is concerned, I have sung it oftener than any rôle except that of Radames in "Aida."

It may be interesting to recall that the first "short" made by the Vitaphone, in 1926, was of me singing "Ridi, pagliaccio." I have reason to remember it. Warner Brothers wanted me to take the contract on a percentage basis. I thought a bird in hand was worth two in the bush and took a lump sum. That picture has netted. I am told, over half million dollars and has been shown in every country in the world where there is a silver screen. That is a kind of thing which makes an artist very, very sad.

Leoncavallo's Popular Opera Will Be Broadcast This Saturday

Spying on her he discovers that she is planning to elope that night with Silvio, a wealthy and handome farmer. He betrays the lovers to Canio who, mad with jealousy, rushes out, but too late to identify his wife's lover. A good "trouper," he must go on with the evening's show which is old-fashioned Italian slap-stick comedy. It is then he sings the famous "Ridi, pagliaccio" — "Laugh, clown, laugh" — which brings the first of the two acts to Ewing, Ranger, Texas. a close.

The second act is a play within a play. The comedy has the same theme as the actual tragedy. Nedda is playing a faithless wife and Canio a betrayed husband. The drama becomes so realistic that Canio forgets his rôle and demands of Nedda the name of her lover. While the audience is delighted with the tense passion of what to hem is merely a comedy, Canio, forgetting everything in his jealous fury, drives his knife into Nedda's heart. Silvio rushes from the au-dience to her rescue and Canfo kills him also. The curtain falls as the distraught Canio murmurs brokenly, "La commedia e finita"-"The play is ended."

**Tibbett to Sing Tonio** 

While I confess that "Pagliacci" is not my favorite opera, as an opera, the rôle of Canio is one of best and most grateful of all those written for a tenor. While it is comparatively short it is diffi-cult. Its demands upon the voice are most exacting and the acting of the part requires the greatest histrionic resources of the artist. Many find "theatrical hokum" in its appeal to the public but that appeal is very real.







#### MUNICIPAL DEBT RELIEF

Reversing a sub-committee which had reported the bill adversely by a decisive vote, the judiciary committee of the United States senate approved the municipal bankrupt relief bill eight to five the other day. The bill was the same as passed by the house at the last session. Radical provisions are made in the bill permitting cities and other political subdivisions in default on their bonds to effect settlements with their creditors under the protection of the federal courts. The principles are similar to those applied in the measure for the relief of individual debtors. Such political subdivisions, with the consent of holders of 30 per cent of the total debt, may petition the federal court for an extension or scaling down of the debt which, if permitted by the court, would be made binding upon the whole body of creditors after three-fourths of the whole had assented. The bill makes it possible to effect a settlement with a scattered body of creditors and also removes the impediment of the dissenting mingrity. Under the present laws the city must deal with all the creditors, which is well-nigh a physical impossibility, or else risk dissatisfac-tion, litigation or face-value settlement with a small element that cannot be reached or holds out. 



#### ADAMS' RESIGNATION ACCEPTED

The resignation of Jed C. Adams as national committeeman from Texas, after lying on the desk of National Chairman Postmaster-general Farley, has been accepted by Farley. Mr. Adams, appointed to the board of tax appeals sent his resignation from the national committee to Farley a year ago. Confronted with a possibility in Texas that did not suit the national party administration taste, Mr. Far-ley declined to accept. Now C. C. McDonald, the "possibility," has entered the race for governor of Texas and is out of the room so far as the committeeman's post is concerned. Chairman Maury Hughes, of the state democratic executive committee which will choose Adam's successor, will call a special meeting of his committee immediately to act in the premises, he said. It will also act in another premise-that of the selection of a successor to Mr. Hughes, himself. Hughes, a rival of McDonald for the democratic nomination for governor of Texas, announced his intention to resign a few days ago. J. K. Brim, of Sulphur Springs, and Ed Hussion, Houston, are said to be candidates for chairmanship shoes. Both are staunch Ferguson men, and Ferguson is said to dominate the committee. The presence of more than one coveted vacancy may be the means of satisfying all hands and saving something for McDonald. Things politically have been known to work out to more embarrassing situations.

Texas has another national committee post resignation lying on the Farley desk. Mrs. Clara Driscoll Sevier, national committeewoman, filed her resignation some time ago. Her husband, Hal Sevier, has been made U. S. ambassador to Chile.

#### SPEAKING OF STATE GASOLINE TAXES

Another important decision has been passed out by the supreme court of the United States. Contractors engaged on federal river and harbor improvements are subject to state gasoline taxes. The court of last resort sustained a tax of five cents a gallon imposed by Louisiana on gasoline brought into that state by the Trinity Farm construction company of Dallas, for use in the construction of levees along the Mississippi river. It appears that the rights of the sovereign state were not abrogated when Robert E. Lee surrendered his sword to the victorious Grant at Appomattox court house.





## Persian Believes He Can Find Remnants Of Noah's Ark on Summit of Ararat

FORT WORTH, March 9 - David George, a 32-year-old Persian grocer Texas Has Room here is convinced that if he could return to his father's estate in Mesopotamia he could find remnants of Noah's Ark on the summit of Mount Ararat.

A shy, retiring man. George, who was born in Mesop-tamia, lives alone in an upstairs room across the street from his store. As he talked, a Bible lay on his pillow. In it were numerous underscored lines and verses, especially in the book of Genesis, where he has found what he believes to be proof that he is sole heir to the Ark.

The young Persian was reared in Mesopotamia. He studied at the Presbyterian seminary at Austin, Texas He came here in 1926, preached for a while, and then began his busines career by selling apples at the Y. M. C. A. building

Quietly and with characteristic confidence, he pointed out his reasons for believing that he could find emnants of the Ark on his father's estate, if any remnants survive the 0000 years since, according to biblical conception, Neah landed his Ark.

#### Means "Eight" The town of Hashton, near the

base of Mount Ararat means "eight" when translated, George pointed out probably founded by the eight human occupants of the Ark and the end of the flood when they descended with mountain.

On the east side of Ararat is Bephin, which mean to "give thanks" Noah and his family gave a burni offering to God for deliverance from the flood, George pointed out.

George also recalls olive trees at the base of the mountain near his home, which he believes is Ararat. It was from similar trees that Noah's doves plucked leaves to bring back to the Ark telling him the waters were receding.

The young minister-grocer has hopes of returning some day to the land of his birth to make exploration or perhaps to head a searching party. His two greatest difficulties at present, he said, are because the tribes of Mesopotamia are barbarous and vicious and because he does not et have sufficient funds to finance uch an undertaking


