

"It's possibly the first time someone's been identified by their eyeglasses," Sheriff Wills

He explained that the frame of the victim's eyeglasses bore a model number that was traced to a store in the Dallasmetroplex, from which it was learned that only two such frames had been sold. One to a black male, and the other to a Caucasian male on whom it was discovered a missing person report had been filed.

After locating a thumbprint from the missing person, it was verified that it belonged to that of the apparent suicide victim.





### Changes announced for cattle being sold

Effective Aug.1, the Texas Animal Health Commission will no longer require brucellosis testing of adult cattle for change of ownership.

TAHC will also cease to pay the \$2 per head supplement to markets for the testing.

Approximately half of the markets have indicated however, that they intend to continue testing all or some of the adult cattle sold through their markets.

For markets wishing to test, they will still be able to receive all the supplies currently being provided at no charge, including the brucellosis card test kits. TAHC inspectors will also be able to run the supplemental testing as usual if a card positive animal is disclosed. TAHC officials strongly encourage voluntary testing of Texas cattle to remain vigilant in keeping Texas Brucellosis free.




So the courts committed both of them to the mental institution where they stayed the rest of their lives.

I was just a small child at that time, but I noticed that out kinfolks, "Uncle John, Uncle Jim" and other came to my father for advice and counsel. And that continued for years after we moved to Texas. In fact some of them moved in and lived with us.

Unless there's been some changes during recent years, which I doubt, mental illness is handled by the Probate Court. But during my life time there has been quite a lot of advancement in the care for and treatment of people that are afflicted with mental care for and treatment of people that are afflicted with mental or emotional problems.

Consequently there's not as much need for hospitalization now as there was years ago, and that is another thing we should be thankful for.

I served for more than 20 years as secretary of the board of trustees of the mental hospital in Plainview. Thus I witnessed the development, not only for mental illness, but for drug abuse, alcoholism and other emotional

The secondary test run by TAHC inspectors at markets will usually clear those consignments for sale unrestricted, and only require the card positive animal to be held up. "Even though TAHC is undergoing drastic budget reductions, the agency will continue to provide a market inspector wherever cattle are sold to support all of the cattle programs underway," Dr. Dee Ellis, state veterinarian, said. A separate issue regarding t h e identification of cattle is also under discussion. Historically all Texas cattle leaving a market have had a USDA eartag in place because they were brucellosis tested there.
