

### Blood Drive Is Scheduled COUNTY **At Hospital April 12** 88

The chance to restore health to a neighbor or even save a life is being offered to Ciscoans during the Graham Memorial Hospital blood drive April 12.

Those who wish to donate blood may do so by calling for an appointment on that day. The hospital's number if 442-3951.

Bill Musser, who is the hospital's lab and X-ray director, said the blood donations make it possible for the hospital not to charge its patients for blood they receive while confined there.

Blood donated by Ciscoan's is used to replace blood from the blood bank so Graham's patients do not

pay for blood they receive. At present, Cisco owes the blood bank about 60 units. Part of this shortage stems from not having been able to hold a drive last fall because of scheduling problems,

Musser said. Musser indicated he would very much like to see Cisco's donations rise to a number that would allow credit to be issued to Ciscoans who must use out-of-town hospitals in Abilene or Fort Worth. This

would save these citizens a lot of money, he said. However, for now the hospital must concentrate on making up the deficit and providing enough blood for the benefit of its own pa-

tients should not exceed 45 minutes, he said. Donors need not fear transmission of diseases such as AIDS because these are not passed on to donors. A donor's blood is screened, however, to rule

The canvass and recount have been completed and Dee Hogan is officially the Democratic Party's nominee for Sheriff of Eastland County.

The recount changed the vote totals slightly, but the outcome was the same. Dee Hogan had 2,072 votes to 2,036 votes for Don Underwood, with 73 voters not voting for either and 2 votes disqualified. County Democratic Party Chairwoman Mary Bailey, as agreed to by both candidates, chose four

Cecil Deadman was chairman of the recount committee, which also included Frances Cox, Sandy Goode and Sandy Lyerla. The total Democratic Party vote, according to the recount committee, was 4,183 in Eastland County. The two disgualified votes were in Rising Star's Election too

A one vote correction was made in several of the boxes while the biggest corrections were made in the Cisco and Olden boxes. The Cisco and Olden changes each affected the outcome

by only five votes. Wednesday's recount gave Hogan a 36 vote win over Underwood rather than the 27 vote edge first reported. Winning candidate Dee Hogan gained 9 votes in the recount.

It seems our fruit has been killed again by a late freeze. Peach, plum, apricot, and nectarine trees were in bloom Sunday night when the temperature was below 28° F. for over eight hours. I have examined several trees and have found no signs of live fruit

Last year the fruit was killed on March 29 and 30. The late freezes seems to kill our fruit more often than not. March 16, is the average last frost or freeze date of the year, but this may not be an average year

Today is National Agriculture Day and it officially ushers in the 1988 spring season. Agriculture Week is March 20-26, with the theme of "Honoring America's Providers"

of food and fiber products. In Texas during 1987, cash receipts to producers from farm marketing alone



Eastland firefighters included Assistant Chief Phillip Arther, Terry Edwards, H.T. Fillingham, Steve Jameson, Ardie Merritt, Mark Pipkin, Steve Simmel, Terry Simmons, Rick Wende and Gordon Woolam.







# Mike Moore Tells Cisco Rotary Club



Mike Moore, manager for the City of Cisco, talked to the Rotary Club at their regular meeting held last Thursday at Tradition's Restaurant. He told the club, Eastland County could have the 911 emergency number in about 14 months, if it is approved by each city in the county.

Moore said he has only been to one 911 workshop, so he is not completely familiar with the program. He said the 911 Emergency number is a nationwide program. With the 911 number everyone in Eastland County will have immediate access to emergency numbers for the police and fire departments and ambulance service.

Moore said at the present time, the five towns in Eastland County have an emergency dispatch for only the police. He said everyone has to dial a separate seven digit number for the ambulance and fire department. He said that Rising Star and Gorman have to dial long distance at the present time to call the police. He added that most people have to look up the emergency numbers in the phone book, before they dial, but the 911 number would be easy for everyone to remember

Moore said the exact cost of the system won't be known until it is finished. He said each person will pay fifty cents extra on their phone bill to pay for the installation, the line, and equipment for the 911 number. Moore said there are approximate-

ly 7,141 homes in Eastland with telephones. He said it will take about 14 months to accumulate about \$50,000 to install the emergency number.
